INDEPENDENT AUDITORS' REPORT

To the Trustees
of the Quality Home Services 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Basis for Opinion

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Quality Home Services 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan that was established August 1, 1997 by B and D Quality Water, Inc. (referred to herein as the Company) to provide benefits to eligible employees, as defined in the Plan document. Full-time employees are eligible to participate in the Plan after completing six months of employment, which is defined as the employee completing a minimum of 500 hours of service within a 6-month consecutive time period and attaining age 18. Employees are eligible to participate in the Plan on the first day of the month following the date of the employee meeting all eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration: The Company is the Administrator of the Plan. The Company appointed Reliance Trust Company to be the Trustee of the Plan. ADP, LLC, a third-party administrator appointed by the Company, processes and maintains the records of participant data. Reliance Trust Company also acts as the custodian of Plan assets.

Participant contributions: Each year participants may contribute up to 90% of their eligible annual salary as defined by the Plan to the Plan, subject to certain Internal Revenue Code limitations. Participants can voluntarily contribute to pre-tax (regular) or after-tax (Roth) salary deferrals up to the allowable amount per IRS regulations. Contributions are withheld from each participant's compensation and invested in accordance with the participant's instructions. The Plan has an automatic contribution feature. In the event a participant fails to complete a deferral election form provided by the employer, the participant's eligible compensation will automatically be reduced by two percent for a contribution to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans, classified as rollover contributions.

Employer contributions: Annually, the Plan can make a discretionary employer contribution. For the years ended December 31, 2024 and 2023, the Company contributed a matching contribution of 50% of the first 4% of participants' salary reduction contributions totaling \$90,043 and \$110,680, respectively.

The Company can also elect to make a discretionary profit-sharing contribution to the Plan. The Company did not contribute additional profit sharing contributions for the years ended December 31, 2024 and 2023.

Participant accounts: Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution and, (b) Plan earnings, and are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan.

Vesting: Participants are vested immediately in their salary deferral contributions and rollover contributions, plus actual earnings thereon. Vesting in employer matching contributions and profit-sharing contributions, plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

NOTE 1 – DESCRIPTION OF THE PLAN (continued)

Forfeitures: Forfeitures remain subject to being restored for five years after a participant terminates employment. Forfeitures occur when a participant's employment is terminated before the vesting period of the participant's interest in Plan assets is complete. Forfeitures are disposed of during the Plan year following the Plan year in which forfeitures occur. Forfeitures of Company contributions may be used to pay administrative expenses or may be used to reduce Company contributions. At December 31, 2024 and 2023, forfeited non-vested contributions totaled \$19,164 and \$14,568, respectively. During the years ended December 31, 2024 and 2023, no forfeitures were used to pay administrative expenses of the Plan. During the years ended December 31, 2024 and 2023, \$19,164 and \$14,568, respectively, of forfeitures were used to reduce Company contributions.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. Note receivable transactions are treated as a transfer to (from) the investment fund from (to) the participant notes receivable fund. Participants may have a maximum of two plan loans outstanding at any time. Note receivable terms range from one to five years, or up to thirty years for the purchase of a primary residence. The notes receivable are collateralized by the balance in the participant's account and bear interest at a rate equivalent to the prime rate as published in the Wall Street Journal on the 14th day of each month (or on the first business day preceding the 14th in the event the 14th is not a business day), plus one percent, with the principal and interest paid ratably through weekly payroll deductions. The interest rate will be fixed for the duration of the loan.

Payment of benefits: The Plan provides for the payment to the participant (or, if applicable, the beneficiary) at normal retirement (age 65), disability, death, financial hardship or termination of employment. In-service distributions are also permitted if the participant has attained age 59 ½ or normal retirement age. Participants who qualify for retirement benefits will receive their benefits in the form of a lump-sum amount equal to the value of the participant's vested interest in their account, or payments over a certain period in monthly, quarterly, semiannual, or annual cash payments, or partial withdrawals. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The benefit to which a participant is entitled is the benefit that can be provided directly from the participant's vested account balance. Hardship withdrawals are available to participants under certain qualifying events of immediate financial need, if it meets IRS requirements. Participants who separate from service and have a vested account balance of \$5,000 or less are subject to an administrative distribution at the discretion of the Plan administrator.

Retirement: Normal retirement age is the first day of the month coinciding with or following a participant's 65th birthday.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting: The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of estimates: The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for the investments in collective trusts measured at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment valuation and income recognition (continued): The net appreciation or decline in fair value investments includes the realized gain or loss on the sale of securities and unrealized appreciation or depreciation arising from the differences between fair value at the beginning and end of the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. In accordance with FASB ASU No. 2016-13, *Financial Instruments – Credit Loss*, financial assets measured at amortized cost basis are to be presented at the net amount expected to be collected. The notes receivable from participants were measured for all expected credit losses based on historical experience, current conditions, and reasonable and supportable forecasts about collectability. No allowance for credit losses was recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as distributions on the basis of the terms of the Plan agreement.

Corrective Distributions Payable: Corrective Distributions payable to participants are measured as their excess contribution plus any earnings thereon. Corrective distributions payable at December 31, 2024 and 2023 were \$3,512 and \$19,428, respectively.

Payment of benefits: Benefits are recorded when paid.

Administrative expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of distributions and participant loans are charged directly to the participant's account and are included in administrative expenses. Contract administration fees paid by forfeitures are included in administrative expenses (see Note 1). Certain investment-related expenses are charged directly by the funds and are thereby factored into each fund as a reduction in investment return.

Subsequent events: In compliance with accounting standards, management has evaluated events that have occurred after year-end to determine if these events are required to be disclosed in the financial statements. Management has determined no such events require disclosure in accordance with accounting standards. These subsequent events have been evaluated through September 16, 2025, which is the date the financial statements were available to be issued.

NOTE 3 – INFORMATION CERTIFIED BY CUSTODIAN

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, Reliance Trust Company, the custodian of the Plan, has certified as being complete and accurate the investments on the Statements of Net Assets Available for Benefits, the investment activity reflected in the Statements of Changes in Net Assets Available for Benefits, and the investment information included in the supplemental schedule, Schedule H, Line 4i – Schedule of Assets (Held at End of Year) of the financial statements as of and for the years ended December 31, 2024 and 2023. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any additional auditing procedures with respect to the information certified as complete and accurate by the Plan's custodian.

NOTE 4 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4 – FAIR VALUE MEASUREMENTS (continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023 and there have been no transfers between levels during the years ended December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employers of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such employer or employee association, or relatives of such persons.

The Plan issues loans to participants, which are secured by the vested balances in the participants' accounts. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

The Third-Party Administrator of the Plan and the Plan Financial Advisor provide various management and record-keeping services to the Plan and receive compensation and other fees for these services and, therefore, qualify as parties-in-interest. For the years ended December 31, 2024 and 2023, total fees and commissions paid to these parties-in-interest totaled \$43,929 and \$40,955, respectively.

The owners of the Plan sponsor and relatives employed by the Plan sponsor are participants in the Plan, and therefore, qualify as parties-in-interest.

The Plan's sponsor provided certain administrative services at no cost to the Plan. These transactions are considered to be exempt party-in-interest transactions.

There were no transactions with any parties-in-interest that would be considered prohibited transactions by DOL regulations.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent vested in their employer contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE 7 – TAX STATUS

The Plan has adopted a prototype 401(k) profit sharing plan established by ADP, LLC. The prototype plan obtained an opinion letter in June 2020, in which the Internal Revenue Service stated that the form of the prototype plan, as then designed, was acceptable under Section 401 of the IRC. The Plan’s Administrative Committee and the Plan’s tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan provides a variety of investment options in any combination of mutual funds that are offered by the Plan. Investment securities are exposed to various risks, such as interest rates, market fluctuations and credit risks. Due to the level of investment risk associated with certain investment securities, it is at least reasonably possible that changes in risk in the near term would materially affect participant account balances and the amounts reported in the accompanying financial statements.
