**NOTE 1 DESCRIPTION OF THE PLAN**

The following description of the ABBTECH Professional Resources, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan established October 1, 2017. The Plan was amended and restated throughout the years to comply with tax legislation and most recently amended effective August 1, 2022. The Plan provides retirement benefits to qualified employees of ABBTECH Professional Resources, Inc. (the Company). The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility**

Employees of the Company are eligible to participate in the deferral and match components of the Plan upon turning 21 years of age and having three months of service. Employees will become participants in the Plan on the first day of the calendar month following the date they meet the participation requirements.

**Contributions**

Each year, participants may contribute a certain percentage up to 90% of their annual eligible compensation, as defined in the Plan, subject to Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may make Roth contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Company contributes a safe harbor matching contribution equal to 100% on the first 4% of participant's compensation which is deferred as an elective deferral on a payroll-by-payroll basis. The Plan does not allow for any other employer contributions.

**Participant Accounts**

Each participant's account is participant-directed, and credited with the participant's contributions, the Company's safe harbor matching, as well as allocations of (a) Plan earnings (losses), and (b) administrative expenses. Allocations are based on account balances, compensation, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their salary deferral contributions and employer safe harbor matching contributions credited to their account.

Participants may borrow from their fund accounts a minimum of \$500 and a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are collateralized by the balance in the participant's account and bear interest at rates equal to the prime rate plus two percent. Loans are to be repaid within a period of five years, unless used for the purchase of a principal residence, in which repayment length is determined by the Plan administrator. Loans are repaid through payroll deductions based upon an established amortization schedule.

**Benefit Payments**

On termination of service due to retirement, disability, death, or other reasons, a participant will receive benefit payments in the form of a lump sum, partial payment, or installment payments, equal to the vested value of the participant's account. Upon reaching age 59½, a participant may elect to withdraw all or a portion of their vested account while still employed with the Company. Participants may withdraw voluntary contributions from their accounts by reason of financial hardship, under specific guidelines set forth in the Plan. Upon termination of employment, if the participant's vested interest in the value of their termination benefits does not exceed and has not, at the time of any prior distributions, exceeded \$5,000, the participant will receive an immediate lump-sum cash payment of their vested balance. If a participant's vested interest at such time exceeds \$1,000 but not \$5,000, the participant's account will be distributed in a direct rollover to another qualified plan, unless the participant requests otherwise. At all times, participants may withdraw in total or a portion of their rollover contributions.

**Forfeitures**

There are no forfeitures for the Plan due to the immediate vesting of employee and employer safe harbor contributions.

**NOTE 2 SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivables from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**Subsequent Events**

The Plan has evaluated subsequent events through September 12, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

Reliance Trust Company (Reliance), the trustee of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 5 RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds and units of a common collective trust and mutual funds managed by Reliance, the trustee of the Plan. These investments qualify as party-in-interest investments/transactions. Fees incurred by the Plan for the investment management services are included administrative expenses. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 7 PLAN TAX STATUS**

The Plan is in the form of a pre-approved plan which received an opinion letter from the IRS indicating that the pre-approved plan and trust are designed in accordance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**NOTE 9 SUBSEQUENT EVENTS**

The Plan changed trustees effective January 2, 2025, the date the Plan assets were first received and accepted by ADP Retirement Trust Services, LLC, the successor trustee.
