## INDEPENDENT AUDITORS' REPORT

To the Participants and Sponsor of  
Ditsch USA LLC 401(k) Retirement Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ditsch USA LLC 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditors' Responsibilities for the Audits of the Financial Statements* section:

1. DESCRIPTION OF THE PLAN

The following description of the Ditsch USA LLC 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan Adoption Agreement and Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Ditsch USA LLC (the “Sponsor” or the “Company”) who have completed 3 months of service and are 21 years of age or older. Employees will have the opportunity to become a participant on their “entry date”, which is the first day of each month once the employee satisfies the above requirements. The Plan became effective on January 1, 2021, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”) and the Internal Revenue Code (the “IRC”).

Contributions

Each year, participants may contribute, on a pre-tax basis or after-tax basis, up to 90% of his or her compensation, as defined by the Plan, subject to IRC limitations, in the form of a salary deferral. Participants not electing otherwise are automatically enrolled to make salary deferral contributions to the Plan in the amount of 3% of their compensation. These contributions will increase by 1% annually until 6% is reached, unless otherwise elected by the participant. Participants may also make rollover contributions to the Plan, which represent distributions from other qualified plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Plan requires a fixed employer matching contribution at the rate of 100% of participant contributions up to 3% of the participant’s compensation. These contributions are to be made on a payroll period basis.

The Plan also allows for a discretionary nonelective profit sharing contribution to be made by the Sponsor. There was no such contribution made for 2024 or 2023.

Contributions are subject to certain statutory limitations.

Investment options

The Plan’s investment assets are held by Reliance Trust Company (the “Trustee”). Under an arrangement with the Trustee and upon enrollment in the Plan, participants direct all contributions in any whole percentage increment to any of the available funds. Participants may change their allocation among the various investment options at any time.

Participant accounts

Each participant’s account is credited with (a) the participant’s contributions, (b) the Sponsor’s contributions on behalf of the participant, and (c) allocations of earnings and losses of the participant’s investments and is charged with any expenses incurred as a result of transactions initiated by the participant as well as a charge for an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Each participant is immediately fully vested in the portion of his or her account attributable to his or her contributions (including rollovers) and earnings thereon. Vesting in the portion of his or her account attributable to the Sponsor’s nonelective profit sharing contributions and earnings thereon is based on periods of service (as defined in the Plan) with the Sponsor and occurs at a rate of 20% per period of service, with full vesting occurring after five periods of service.

Vesting associated with the Sponsor matching contribution and earnings thereon occurs at a rate of 33% per period of service (as defined in the Plan), with full vesting occurring after three periods of service.

### Payment of benefits

Upon termination of employment, attainment of retirement age (as defined in the Plan), or for reasons of death or disability, participants may withdraw the vested portion of their account in the form of a lump sum or partial installments. Participants still employed with the Sponsor may withdraw all or a portion of their account balance upon attainment of age 59½ or for reasons of a financial hardship, as allowed under the IRC. A terminated participant with a vested account balance of less than \$1,000 and who does not elect otherwise, will have their vested account balance automatically distributed from the Plan. A terminated participant with vested balance between \$1,000 and \$5,000, and who does not elect otherwise, will have their account balance automatically rolled out of the Plan into an individual retirement account in their name. Terminated participants with a vested balance in excess of \$5,000 may remain in the Plan, but they may not make additional contributions.

### Forfeitures

If a participant is not fully vested on their termination date, the non-vested amount of their account is forfeited. Forfeitures of nonvested account balances may be used, at the sole discretion of the Sponsor, to pay administrative expenses of the Plan or to reduce Sponsor contributions. During the years ended December 31, 2024 and 2023, forfeited amounts were \$26,488 and \$5,054, respectively and \$27,194 and \$4,355, respectively, were used to pay administrative expenses or to reduce Sponsor contributions. Accumulated forfeitures totaled \$13 and \$699 at December 31, 2024 and 2023, respectively.

### Notes receivable from participants

Participants may borrow, from their accounts, amounts ranging from \$500 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balances. The maximum term of repayment for a loan is five years, unless it is for the purchase of a principal residence, in which case the maximum term of repayment is thirty years. The loans are secured by the balance in the participant's account and bear interest at prime plus 2%. Principal and interest are paid ratably through payroll deductions. A participant may only have one loan outstanding at a time. The interest rates ranged from 7.5% to 10.5% on participant loans outstanding as of December 31, 2024 and 2023.

### Administrative expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments. Administrative expenses associated with participant loans and certain distributions are included in administrative expenses and charged to the accounts of the participants initiating the transactions. Also, participants who have separated from service with the Sponsor and choose to maintain a balance in the Plan are charged an annual fee.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

### Use of estimates in financial statement preparation

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded at the ex-dividend date. Net appreciation in fair value of investments includes realized and unrealized gains and losses on those investments.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable are recorded as distributions based upon the Plan's provisions.

Payment of benefits

Benefits are recorded when paid.

Net assets available for benefits

Net assets available for benefits at both December 31, 2024 and 2023 included \$-0- allocated to the accounts of persons who, prior to that date, had withdrawn from participating in earnings and operations of the Plan.

3. INFORMATION PREPARED AND CERTIFIED BY THE TRUSTEE (UNAUDITED)

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's (the "DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified as complete and accurate by the Trustee, Reliance Trust Company, except for comparing such information to the related information included in the Plan's financial statements and supplemental schedule.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.

### Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

### Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodology used during the years ended December 31, 2024 or 2023.

- Mutual funds: Valued at the quoted net asset values of shares as reported by the Fund. Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price and are deemed to be actively traded.
- Common collective trust: Valued at the net asset value (NAV) of the units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily and there are no participant redemption restrictions for this investment. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require a 12-month notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no unfunded commitments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. RELATED PARTY TRANSACTIONS

The Sponsor pays certain costs on behalf of the Plan for insurance, administration and professional services. Recordkeeping and administrative services are also provided by the Sponsor at no cost to the Plan.

Reliance Trust Company is the trustee of the Plan and ADP, Inc. is the recordkeeper. Transactions with these providers qualify as party-in-interest transactions, as defined under ERISA guidelines. Fees paid by the Plan to these providers are included in administrative expenses or net appreciation in fair value of investments. These party-in-interest transactions are exempt from the prohibited transaction rule of ERISA.

## 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

## 7. INCOME TAX STATUS

The Plan utilizes a prototype plan document sponsored by ADP, LLC, who was informed by the Internal Revenue Service (“IRS”) by an opinion letter dated October 6, 2020, that the Plan, is designed and being operated in accordance with applicable sections of the IRC. The Plan has been amended since receiving this opinion letter and has not received a determination letter specific to the Plan from the IRS, however the Sponsor and the Plan’s tax counsel believe that the Plan is designed and being operated in accordance with the applicable sections of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt. Thus, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require the Plan’s management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the tax authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of both December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress and the Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021 (the year the Plan was formed).

## 9. PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants would become 100% vested in their accounts.

## 10. SUBSEQUENT EVENTS

The Sponsor has evaluated subsequent events through August 25, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Sponsor increased the threshold for forced distributions of terminated participants from \$5,000 to \$7,000 as permitted under the SECURE Act 2.0.
