### **NOTE 1 - PLAN DESCRIPTION**

The following description of SummitMedia, LLC (Sponsor) 401(k) Plan (Plan) is provided for general information only. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a contributory, defined contribution 401(k) plan available to substantially all qualifying employees of the Sponsor. The Plan originated on July 1, 2013. To be eligible to participate in the Plan and for purposes of the employer matching contribution, a full-time or part-time, non-leased employee must have completed six months of service. An employee becomes eligible to enter the Plan on the first day of the month after six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator is responsible for oversight of the Plan. The benefits committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### **Contributions**

Participants may contribute up to the maximum amount allowed by law, as defined in the Plan, with the contributions and earnings thereon being nontaxable until withdrawn from the Plan. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Such transfers from other qualified plans are reported as rollover contributions. After six months of service, the Sponsor will make a safe harbor matching contribution equal to one hundred percent of the first three percent of eligible compensation plus fifty percent of the next two percent of eligible compensation contributed to the Plan as deferral contributions. After one year of service, participants are eligible for the profit-sharing contribution, which is made at the Sponsor's discretion. The Sponsor did not make a discretionary, profit-sharing contribution to the Plan during 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's and the Sponsor's contributions and an allocation of net Plan earnings. Participants may direct the investment of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is based on the participant's vested balance.

#### **Vesting**

Participants are immediately vested in their elective deferrals, the employer safe harbor matching contribution, and any income or loss thereon. Participants become 100 percent vested in Sponsor profit sharing contributions and any income or loss thereon after five years of continuous credited service.

### **NOTE 1 - PLAN DESCRIPTION - Continued**

#### **Notes Receivable from Participants**

Participants may borrow a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a rate of 3.25% - 9.50%. A loan will provide a fixed rate of interest equal to the prime rate reported by the United States Federal Reserve plus one percent. Principal and interest are paid through payroll deductions as indicated in the loan policy.

#### **Payment of Benefits**

Upon termination of service, due to death, disability, retirement or separation of service, a participant may receive a lump-sum distribution under various options equal to the value of the participant's vested interest in his/her account. The Plan also permits withdrawals due to circumstances of financial hardship or when a participant attains age 59 1/2, in accordance with provisions specified in the Plan document. If a terminated participant's vested interest in his or her account is less than \$5,000 and he or she does not elect to receive a distribution from the Plan, benefits will be paid in a single, lump-sum distribution as soon as administratively feasible.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Investment-related expenses are included in net appreciation or depreciation of fair value of investments. The Sponsor pays the administrative costs of the Plan associated with any professional services provided to the Plan and the cost of communications to the participants. Administrative expenses recorded in the Plan represent fees related to the administration of notes receivable and benefit payments that are charged directly to the participant's account and trustee fees and other recordkeeping fees paid directly from the Plan to the Plan's trustee and other third parties.

#### **Forfeitures**

Forfeitures are used to pay administrative expenses or reduce future employer profit sharing contributions. Forfeited nonvested accounts totaled \$10,278 and \$9,768 at December 31, 2024 and 2023, respectively. During the year ended December 31, 2024, forfeitures of \$1,413 were used to reduce employer profit sharing contributions.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America. In preparation of the financial statements, management evaluated subsequent events through September 2, 2025, the date the financial statements were available to be issued.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the reporting date and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

**Concentration of Market Risk**

As of December 31, 2024 and 2023, approximately 37% and 38%, respectively, of the Plan's net assets were invested in three registered investments. The underlying value of the investments are dependent on the performance of the individual investment holding and the market's evaluation of such performance. It is at least reasonably possible that changes in the fair value of the registered investment accounts and their investment holdings in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**Income Recognition**

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Realized gains and losses from security transactions are reported on the average cost method.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit loss has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

**Fair Value**

The established framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value is the price the Plan would expect to receive to sell an asset or pay to transfer a liability in an orderly transaction with a market participant at the measurement date. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs which are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

**Payment of Benefits**

Benefits are recorded when paid.

### **NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the trustee, Reliance Trust Company, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at fair value and notes receivable from participants, included in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income, which includes net appreciation in fair value of investments and dividends, and interest income on notes receivable from participants, included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, included in the supplemental information.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

### **NOTE 4 - PLAN TERMINATION**

Although it has not expressed intent to do so, the Sponsor has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions.

### **NOTE 5 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 - FAIR VALUES**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

- *Registered investments:* Valued at the closing price reported on the active market on which the individual securities are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 7 - INCOME TAX STATUS**

The Plan is an ADP, LLC prototype defined contribution plan. The Internal Revenue Service has ruled, in a letter dated October 6, 2020, that the prototype plan developed by ADP, LLC, after which the Plan is modeled, qualifies under the applicable sections of the Internal Revenue Code (IRC). The plan administrator and the Plan's tax counsel believe that the Plan is designed, and currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Tax positions are recognized when it is more likely than not that the position will be sustained upon examination by the tax authorities.

The Sponsor has concluded, as of December 31, 2024 and 2023, the Plan had no uncertain tax positions or material amounts of unrecognized tax benefits that qualify for either recognition or disclosure in the financial statements for open tax years based on an assessment of many factors including experience and interpretations of tax laws.

**NOTE 8 - RELATED PARTY TRANSACTIONS**

Plan investments are managed by Reliance Trust Company, the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions.

**NOTE 9 - RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**
