### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of the Fort Worth Carrier Corp. Sec. 401(k) Salary Reduction Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ## 1. Description of Plan

The following description of Fort Worth Carrier Corp. Sec. 401(k) Salary Reduction Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

### General

The Plan is a defined contribution plan available to all eligible employees of the Fort Worth Carrier Corp. (the “Company”). The Plan was formed on February 1, 1982, is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and is defined by Section 401(k) of the Internal Revenue Code (“IRC”).

### Eligibility

An employee is eligible to become a participant in the Plan on the first day of the month coinciding with or the next following date he or she completes three (3) months of service and is eighteen (18) years of age. Additionally, the Plan provides automatic enrollment with 3% contribution rate unless eligible participants opt out. All investments are participant-directed.

### Employee Salary Reduction Election

A participant may elect to defer up to seventy-five percent (75%) of his or her compensation each year instead of receiving that amount in cash. However, total deferred compensation may not exceed the limits set by Internal Revenue Code Sections 401(k), 404, and 415. In addition, participants who are age fifty (50) or over before the close of the plan year are eligible to make catch-up contributions subject to the limitation imposed by the IRC.

### Contributions

#### *Elective Contributions*

The Company must contribute the amount of the total employee salary reduction elections of all participants made during the plan year. The Company must pay elective contributions to the Plan’s trustee as soon as they can be segregated from its general assets, but no later than the fifteenth (15<sup>th</sup>) business day after the month of receipt of the voluntary contribution.

#### *Safe Harbor Matching Contributions*

The Company makes a Safe Harbor matching contribution which the Employer will match one hundred percent (100%) of the participants salary deferrals up to the first six percent (6%) of the participants eligible compensation.

**Contributions (continued)**

*Employer Non-elective Contributions*

The Company may make a employer non-elective contribution in an amount to be determined by the Company. The non-elective contributions are not immediately fully vested and are subjected to a six-year vesting schedule described below under *Vesting* section.

*Rollover Contributions*

The Plan may accept a rollover contribution on behalf of all participants as well as any employee, regardless of whether such employee has met the service requirement of the Plan.

*Participant Accounts*

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting*

Participants are immediately fully vested in their elective contributions plus actual earnings thereon and company safe harbor matching contributions. Vesting in the employer non-elective contribution portion of the participant account plus earnings thereon is based on years of continuous services. The vesting for the Company account is as follows:

*Forfeited Accounts*

Forfeitures represent the portion of non-vested employer non-elective contributions remaining in the Plan for terminated employees and may be used to reduce the employer matching contribution and to cover the costs of administration of the Plan. Forfeited account balances at December 31, 2024 and 2023 were \$22,576 and \$0, respectively. During 2024, no forfeitures were applied toward employer contributions or used to reduce the Plans expenses.

**Distribution of Benefits**

*Upon Retirement*

Distributions may be made to a participant who has not separated from service when he or she attains age fifty-nine and one-half (59 ½). Payment may be in the form of a lump-sum distribution in cash. The minimum amount he or she can receive as an in-service distribution is \$500.

*Upon Termination of Employment*

A participant may elect to have his or her account balance distributed as soon as administratively feasible following termination of employment. If the value of the vested account balance does not exceed \$1,000, then a distribution will be made in cash. However, if the value of the vested account balance is more than \$1,000 but less than \$7,000, he or she may elect to receive distribution in cash or to roll over to an IRA or a qualified plan of his or her new employer. If his or her vested account balance exceeds \$7,000, he or she may elect to receive a distribution of his or her vested account balance in a single lump-sum payment, installments over a period of not more than his or her assumed life expectancy or partial withdrawals.

*Hardship Distributions*

A participant may withdraw money for financial hardship if he or she satisfies certain conditions. Hardship distributions can only be made from salary deferral and rollover accounts which are 100% vested and a participant must be employed with the Employer at the time of the hardship distribution.

*Upon Disability*

A participant's account is distributable upon a participant's disability. If the value of his or her vested account balance does not exceed \$1,000, then a distribution of his or her vested account balance will be made to the participant, regardless of whether he or she consents to receive it. If his or her vested account balance does not exceed \$7,000, then his or her vested account balance may only be distributed to the participant in a single lump-sum payment. If his or her vested account balance exceeds \$7,000, he or she may elect to receive a distribution of his or her vested account balance in a single lump-sum payment, installments, or partial withdrawals. In addition, if his or her vested account balance exceeds \$1,000, the participant must consent to any distribution before it may be made.

*Upon Death*

Upon the death of a participant, a distribution of the vested account balance will be made to his or her designated beneficiary in a single lump-sum payment.

**Administrative Fees**

Distribution and loan fees are charged directly to the requesting participant's account. The Company absorbs the majority of all other administrative fees of the Plan. If expenses paid by the Plan are allocated to participants, expenses are either proportionately based on the value of the account balances or as an equal dollar amount based on the number of the participants in the Plan.

**Investment Options**

Upon enrollment in the Plan, a participant may direct all of his or her accounts to a variety of investments. Participant's accounts are segregated for purpose of determining the earnings or losses on their investment options.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting

**Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit Payments**

Benefit payments are recorded when paid.

**3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

In accordance with Subtopic 820-10, certain investments that were measured at net asset value (NAV) per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in the tables below are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits. As the Plan’s collective investment trusts are measured at fair value using NAV per share (or its equivalent) practical expedient, they have been excluded from the fair value hierarchy.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**7. Related-Party Transactions and Party in Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan paid \$8,290 of recordkeeping fees to ADP, Inc. during the year ended December 31, 2024. The Company provides certain administrative services at no cost to the Plan.

**8. Tax Status**

The IRS has determined and informed the Company by a letter dated December 3, 1991, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Company and Plan administrator believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.
