**NOTE A - DESCRIPTION OF THE PLAN**

***General***

Hirtle, Callaghan & Co. LLC 401(k) Profit Sharing Plan (the Plan), formed January 1, 1994, is a defined contribution plan established by Hirtle, Callaghan, & Co. LLC (the Company) under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Company. All employees of the Company aged 21 and older are eligible to participate in employee contributions upon hire and enrolled quarterly in employer contributions following hire, with the exception of non-resident aliens and collectively bargained employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The following brief description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

***Contributions***

Each year, participants may contribute up to 90% of pre-tax annual compensation, as defined in the Plan document, not to exceed the Internal Revenue Service (IRS) limitation, which was \$23,000 for 2024. Participants who have reached the age of 50 by the end of the Plan year may make additional pre-tax "catch-up" contributions up to \$7,500 for 2024. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company's matching contribution formula provides a safe harbor matching contribution on behalf of each participant who has made salary deferrals in the Plan year. This contribution is equal to 100% of the first 4% of a participant's compensation deferred. The matching contribution shall be determined on an annual basis and shall be adjusted to the extent necessary after the end of each Plan year with a true-up contribution. All contributions are subject to and within limitations of the IRS. Participants direct the investments of all contributions into various investment options offered by the Plan.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, rollovers and the participant's portion of the Plan sponsor's contributions and plan earnings (losses). A participant may direct the investment of his or her employee and employer contributions in any of the Plan's investment options. The participant may change the investment elections on a daily basis. Earnings, expenses, and gains and losses on investments are allocated based on participants' account balances, as defined in the Plan document.

***Vesting***

Participants are immediately vested in all contributions plus actual earnings thereon.

***Payment of Benefits***

Withdrawals from participants' accounts may be made for the following reasons: hardship, attainment of age 59½, normal retirement at age 65, death or totally disabled or termination of employment.

Hardship withdrawals are permitted if certain criteria are met, as defined by the Plan document, and are subject to taxes in the year received.

Upon reaching the age of 59½, a participant is eligible to receive distributions without termination of employment without penalty.

Upon termination of service due to death, disability, or retirement, participants with vested account balances greater than \$7,000 generally receive payments in the form of a lump sum or installment payments. Participants with vested account balances of \$7,000 or less may receive a single lump-sum payment.

The minimum distribution rule requires retired or terminated former employees to begin withdrawing minimum amounts from their retirement account starting the year they reach 72 years of age. The initial required distribution can be delayed until April 1 in the year following the year they turn age 72. Required distributions for subsequent years need to be taken by December 31 of each year.

***Participant Loans***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance and bears fixed interest at rates that are commensurate with local prevailing rates. A participant may only have two notes receivable outstanding at any time. Principal and interest are paid ratably through payroll deductions. Outstanding notes receivable at December 31, 2024 carry interest rates ranging from 4.25% - 9.50%.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting.

***Estimates***

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company are excluded from these financial statements. The investment management fees and operating expenses charged to the Plan were deducted from investment income earned on a daily basis and were included in net appreciation in fair value of investments.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### **NOTE C - CERTIFIED INFORMATION**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company (Reliance), the trustee of the Plan, certified the following information included in the accompanying financial statements and supplemental schedule as complete and accurate as of and for the year ended December 31, 2024.

- Investments, at fair value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants included in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform any auditing procedures with respect to information certified by Reliance, except for comparing such information to the related information included in the above named financial statements and supplemental schedule.

#### **NOTE D - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Accounting Standards Codification (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value.

**Mutual Funds**

Valued at net asset value (NAV) of shares held by the Plan at year end based upon quoted market prices.

**Collective Trust Fund**

Collective trust funds are valued at NAV of shares held by the Plan at year end, which is used as a practical expedient to estimate fair value. The NAV is based on the value of the underlying assets. The fund seeks to maintain a stable NAV of \$1 per share, however, it cannot guarantee that it will be able to do so. Collective trust funds may include investments that trade in markets that are not considered to be active, but whose values are based on quoted market prices, dealer quotations or valuations provided by alternative pricing sources supported by observable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables present information about the Plan's investments measured at fair value on a recurring basis as of December 31, 2024 and 2023, and indicate the fair value hierarchy of the valuation techniques utilized by the Plan to determine such value:

#### NOTE E - TAX STATUS

On April 10, 2014, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under IRC Section 401(a). Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is currently designed and being operated, in all material respects, in compliance with the applicable requirements of the Internal Revenue Code ("IRC").

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE F - PARTY-IN-INTEREST

The Plan's investments include mutual funds managed by the Company. Party-in-interest transactions include participant notes receivable. Such transactions, while considered party-in-interest transactions under ERISA, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

#### NOTE G - RISKS AND UNCERTAINTIES
