## Independent Auditors' Report

To the Board of Trustees and Management of the  
HNB National Bank 401(k) Retirement Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of HNB National Bank 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of HNB National Bank 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of HNB National Bank 401(k) Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about HNB National Bank 401(k) Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of HNB National Bank 401(k) Retirement Savings Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about HNB National Bank 401(k) Retirement Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

**1. Description of Plan**

The following description of the HNB National Bank 401(k) Retirement Savings Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**A. General**

The HNB National Bank 401(k) Retirement Savings Plan (Plan 001) is a defined contribution profit sharing trust. Eligible full-time employees are age 21 or older. Eligible part-time employees must have completed one Year of Service (as defined by the Plan agreement) for the Plan year. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective October 1, 2023, after HNB National Bank (the “Company”) successfully acquired The Mercantile Bank of Louisiana, Missouri, the Plan was amended to recognize the service with The Mercantile Bank of Louisiana, Missouri, for eligibility, vesting, and contribution requirements.

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions became effective in 2024 and thereafter. Accordingly, there has been no material impact on the Plan’s 2024 financial statements.

**B. Excluded Employees**

There are certain employees of HNB National Bank who will not be eligible to participate in the Plan. Those employees are:

1. Employees whose employment is governed by a collective bargaining agreement.
2. Nonresident aliens who do not receive any compensation from U.S. sources.
3. Leased employees.
4. Part-time, temporary, or seasonal employees whose regularly scheduled service is less than 1,000 hours of service.

**C. Contributions to the Plan**

Contributions to the Plan consist of the following:

1. Participants:
  - a. Elective contributions – These may be made as pre-tax salary deferrals or as after-tax Roth deferrals and at all times have a 100% vested balance. Roth deferrals are a form of salary deferral but, instead of being contributed on a pre-tax basis, income tax is paid currently on such deferrals.  
  
Participant deferrals were \$534,461 and \$449,074 for the years ended December 31, 2024 and 2023, respectively.
  - b. Rollover contributions – Qualified distributions from certain other kinds of retirement plans or accounts may be rolled over into this Plan and at all times have a 100% vested interest.
  - c. Catch-up contributions – These are available to participants 50 years of age or older and are not counted toward any other limits imposed on other Plan contributions and at all times have a 100% vested interest.

**C. Contributions to the Plan (Concluded)**

2. Employer:

- a. Discretionary matching contributions – During the Plan year or at the end of each Plan year, the Company may contribute a discretionary amount equal to a percentage of salary deferrals but limited to the first 6% of a participant's plan compensation.

The Company match contribution was \$181,108 and \$150,776 for the years ended December 31, 2024 and 2023, respectively.

- b. Discretionary pro-rata employer contributions – During the Plan year or at the end of each Plan year, the Company may make an additional contribution on a discretionary basis on behalf of all eligible employees whether or not they made an elective contribution for the Plan year.
- c. Special employer contribution – QNEC – In addition to any other contributions authorized under the Plan, the Company may contribute a special discretionary contribution called a qualified non-elective contribution (QNEC) and at all times participants have a 100% vested balance.

**D. Participant Accounts**

Each participant's account is credited with the participant's contribution, allocations of the Company's contribution, and plan earnings, and charged with an allocation of investment gains or losses, withdrawals, and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**E. Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Participants vest 100% after three years of credited service in accordance with the Plan document, or immediately if employment is terminated due to death, disability, or retirement upon attainment of the age of 65.

**F. Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant can elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account as provided in the Plan document. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**G. Forfeitures**

During the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,066 and \$2,866, respectively. These accounts are available to be used to reduce future employer contributions to the Plan. Employer contributions were reduced by \$4,068 and \$2,866 for the years ended December 31, 2024 and 2023. Any amount a participant loses the right to is called a forfeiture.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits payments to participants are recorded when paid.

**Expenses**

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

**3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

***Level 1 Fair Value Measurements***

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

***Level 2 Fair Value Measurements***

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

***Level 2 Fair Value Measurements (Concluded)***

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

***Level 3 Fair Value Measurement***

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Fund: Values at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the NAV. Participant transactions (purchase and sales) may occur daily.

**4. Certified Investments**

The Plan's investments are held and managed by Reliance Trust Company. Financial information relating to those investments held by the managing agent are included in the accompanying financial statements, in the information presented in this note, and in the supplemental schedule based on information provided by the managing agent. The managing agent has certified that the information provided to the plan administrator relating to the Plan's participation in invested assets and investment transactions is complete and accurate. This information has not been audited by independent auditors.

Dividend income reported by the managing agent totaled \$458,207 and \$366,476 for the years ending December 31, 2024 and 2023, respectively.

During 2024 and 2023, the Plan's investments (including investments bought, sold, and held during the year), as reported by the managing agent, appreciated in current value by \$974,357 and \$1,105,958, respectively.

**5. Related Party Transactions and Party in Interest Transactions**

Certain Plan investments are managed by Reliance Trust Company. Reliance Trust Company is the trustee of the Plan and, therefore, these transactions qualify as party in interest transactions.

**6. Reconciliation of Financial Statements to Form 5500.**

There were no reconciling items.

**7. Income Tax Status**

The Internal Revenue Service has determined and informed the Plan sponsor by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Investment Options**

Participants have a choice of investments to elect to contribute to. The allocation can be changed by participants at any time over the website of its third-party administrator, ADP, LLC. Numerous investment options through a group annuity contract issued by ADP, LLC are available. An enrollment kit explaining these choices is available to all participants.

**9. Transfers from Qualified Plans (Rollovers)**

At the discretion of the Administrator, participants may be permitted to deposit into the Plan distributions participants have received from other plans. Rollovers to the Plan from other qualified plans were \$2,945 and \$834,317 for the years ended December 31, 2024 and 2023, respectively. Rollovers will be placed in a separate account called a "participant's rollover account". Participants are 100% vested in their "rollover account".

**10. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**11. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**12. Subsequent Events**

For the year ended December 31, 2024, the Company evaluated subsequent events for potential recognition and disclosure through September 17, 2025, the date of financial statement issuance.

Effective January 1, 2025, the Plan was amended and restated for the resignation of Reliance Trust Company as the Plan's trustee and appointment of ADP Retirement Trust Services, LLC as the Plan's trustee.
