## **NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Banesco USA 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan’s provisions.

General: The Plan is established by the Plan sponsor and employer, Banesco USA (the “Bank,” “Company,” or “Plan sponsor”). The Plan is a defined contribution plan, which covers substantially all employees who have completed 3 months of service and attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Reliance Trust Company is the trustee and Automatic Data Processing (“ADP”) is the recordkeeper.

Contributions: Elective deferrals by participants are based on a percentage of their compensation as defined in the Plan agreement, which is subject to certain limitations. Participants may designate a portion or all of their deferral contribution as a Roth 401(k) contribution. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employees also may rollover account balances from other plans into their account. The Plan has an automatic enrollment feature where newly eligible employees that do not affirmatively elect to contribute or not to contribute to the Plan will be automatically enrolled in the Plan at a deferral rate of 3%.

The Bank will contribute to each participant’s account a matching contribution which is a percentage of the participant’s elective contribution for the year. The Bank makes matching contributions equal to 100% of the first 3% of the participant’s compensation and 50% of the next 2% of the participant’s compensation contributed to the Plan subject to certain limitations as specified in the Plan agreement.

Participant Accounts: Each participant’s account is credited with the participant’s contributions, rollovers, if any, and an allocation of (a) the Bank’s contributions and (b) Plan’s earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the aggregate of the participant’s deferrals, rollovers, and vested employer contributions.

Investment Options: Participants may direct the trustee to invest their elective 401(k) contributions, rollovers, if any, as well as employer matching contributions to the Plan in any of the available investment options. Participants may change their investment elections at any time. Participants can individually determine their investment options based on desired level of risk and return for all contributions (employer and participant) to the Plan.

Vesting: Participants are vested immediately in their contributions and in their employer contributions plus actual earnings thereon.

Payment of Benefits: Upon termination of service, due to employment termination, death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant’s vested interest in his or her account in either a lump-sum amount, or through installment payments over a period not to exceed the life expectancy of the participant or beneficiary of the participant. A participant also is eligible for in-service withdrawals. Types of in-service withdrawals available under the Plan are withdrawals after attaining 59 ½ years of age and hardship withdrawals.

**NOTE 1 – DESCRIPTION OF THE PLAN (Continued)**

Forfeitures: Forfeitures are used to reduce Plan Sponsor discretionary matching contributions or to pay plan expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$199, respectively. During the year ended December 31, 2024, \$0 of forfeitures were utilized to reduce the Bank's matching contributions.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of (a) \$50,000 or (b) 50% of their vested account balance. However, the \$50,000 amount in the preceding sentence is reduced by the highest outstanding loan balance under the Plan provisions during the previous twelve-month period. The loans are secured by the balance in the participant's account and bear an interest rate commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratable through payroll deductions.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Bank. Expenses that are paid by the Bank are excluded from these financial statements. During the year ended December 31, 2024, administrative expense amounting to \$54,397 were paid by the Plan and shown as a deduction from net assets. Fees related to the administration of notes receivable from participants are charged to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events: The Plan has evaluated subsequent events through September 16, 2025, which is the date the financial statement were available to be issued. There were no subsequent events requiring adjustments or disclosures to the financial statements.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLIIES**

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Bank's management determines valuation policies. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned and is reflected as interest income on notes receivable from participants on the accompanying Statement of Changes in net Assets Available or Benefits.

Related fees are recorded as administrative expense and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLIIES (Continued)**

Payment of Benefits: Benefits are recorded when paid.

Risks and uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, marker and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonable possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.

Use of Estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements and accompanying notes. Actual results could differ from those estimates.

Contributions: Participant and Bank contributions are recorded in the period during which the Bank makes payroll deductions from the participants' earnings.

Investment Management Fees and Operating Expenses: Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned daily and are reflected as a component of net appreciation in fair value of investments.

**NOTE 3 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Bank has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.

**NOTE 4 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

**NOTE 5 – PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulation as any fiduciary of the Plan, any party rendering service to the Plan, the employer and certain others. Fees paid by the Plan for these services are included in the net appreciation in fair value of investments. Notes receivable from participants are also considered exempt party-in-interest transactions. Certain Plan investments are shares of registered investment companies and a liquidity fund managed or sponsored by Reliance Trust Company. Reliance Trust Company is the trustee of the Plan and ADP is the recordkeeper; therefore, transactions with the Trustee qualify as parties-in-interest transactions. Certain officers and employees of the Bank, who may be participants in the Plan, perform administrative and other duties for the Plan at no cost to the Plan.

## NOTE 6 – TAX STATUS

The Plan has adopted a standardized plan, which has obtained an Internal Revenue Service (“IRS”) letter dated October 6, 2020, in which the IRS stated that the form of the Plan was acceptable under Section 401 of the Internal Revenue Code (“IRC”). Although the Plan has been amended from that prototype since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been made.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax position taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

## NOTE 7 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standards Codification Topic 820 (ASC Topic 820) establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* The fair values of registered investment companies are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

*Liquidity fund:* The fair values of participation units in the liquidity fund are based on the net asset values per unit as reported by the fund managers. The liquidity fund provides for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
