## INDEPENDENT AUDITORS' REPORT

To the Plan Administrative Committee of

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of the Murdock Webbing Company, Inc. Employee Savings & Security Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Murdock Webbing Company, Inc. **1. Description of Plan**

The following description of the Murdock Webbing Company, Inc. (the “Company”) Employee Savings & Security Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan was established on September 1, 1990. The Plan is a defined contribution plan of the Company that covers substantially all eligible employees who have reached the age of 18 and completed 30 days of service. The Plan entry date is the first day of the month coincident with or following the remaining eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Board of Directors is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors.

Effective May 1, 2023, the Plan was restated and amended in its entirety as a result of a change in custodian and trustee.

On March 27, 2020, in response to the economic impact caused by the coronavirus (“COVID-19”) pandemic, the Coronavirus Aid, Relief, and Economic Security (“CARES”) Act was signed into law. As part of the CARES Act, certain universal changes were implemented related to retirement plans, including waiving required minimum distributions for the 2020 calendar year and waiving the 10% early distribution penalty tax for participants affected by the pandemic. The CARES Act also contained provisions which allowed for plan administrators to make amendments and elections to the plan to provide greater access to retirement funds for participants impacted by the pandemic. Some of the allowable elections contained within the CARES Act included allowing expanded in-service distributions, increasing plan limits on loans to \$100,000 or 100% of the participant’s vested balance, and offering suspensions of loan repayments, without default, until December 31, 2020. The Plan Administrator had the ability to choose which elections the Plan would make; there was no requirement for plans to adopt any of these provisions. The Plan Administrator made the election to adopt the above provisions during the Plan year ending December 31, 2020. While these provision were, operationally, enacted immediately upon the Plan Administrator’s election, the Plan will not have to be formally amended to incorporate these changes until December 31, 2025. The Plan Administrator has indicated that it is their intention to amend the Plan by that date.

**Contributions**

Participants may elect to defer between 1% and 100% of their eligible compensation, as defined in the Plan, from January 1, 2023 to April 30, 2023 and between 1% and 90% of their eligible compensation from May 1, 2023 forward, through a salary reduction agreement. For the years ended December 31, 2024 and 2023, the total deferrals may not exceed \$23,000 and

\$22,500, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, up to the Internal Revenue Service (“IRS”) limit of \$7,500 for the years ended December 31, 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect otherwise. Automatically enrolled participants have their deferral rate set at 2% of eligible compensation, with annual escalations of 1% up to a maximum of 5%, and their contributions are invested in a designated fund until changed by the participant. The Company may also make a discretionary matching contribution. The Company made no matching contributions for the years ended December 31, 2024 and 2023. In addition, the Company may make additional profit-sharing contributions at the discretion of the Board of Directors. The Company made no profit-sharing contributions for the years ended December 31, 2024 and 2023.

**Participant accounts**

Each participant’s account is credited with the participant’s contributions and rollover contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary and rollover contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts plus actual earnings thereon is based on years of credited service. Participants are 100% vested after six years of service. Participants are also fully vested upon reaching normal retirement age, death, or total disability.

**Investment options**

Participants may direct their contributions, in one percent multiples, into any of the funds offered by the Plan, which were held at Principal Trust Company from January 1, 2023 to April 30, 2023 (the guaranteed investment contract continued to be held at Principal Trust Company until February 22, 2024 due to a twelve month payout structure) and ADP Retirement Services from May 1, 2023 to December 31, 2024. These funds include a variety of investment options with various objectives and degrees of financial risk.

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, except for loans to purchase a primary residence, which may be offered over a term of up to ten years. Participants could have one loan outstanding at any given time from January 1, 2023 to April 30, 2023 and can have up to two loans outstanding at any given time from May 1, 2023 forward. The loans are secured by the balance in the participants' accounts and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan Administrator. Principal and interest is paid ratably through payroll deductions.

**Payment of benefits**

Upon retirement, disability, death, or termination of employment, the participant shall become entitled to the total value of his or her vested account. Distributions will be paid in a lump sum or in installments over a number of years, based upon the election of the participant or as defined in the Plan or the IRC. If a participant terminates employment for any reason and his or her vested account balance does not exceed \$1,000, the Plan Administrator may distribute such amount in a lump-sum payment to the participant without consent of the participant. If the participant's balance is between \$1,000 and \$5,000, the Plan Administrator may roll the amount into an individual retirement account on behalf of the participant without the consent of the participant.

Participants may make in-service withdrawals from their accounts. Participants who have attained age 59 ½ or have a serious financial hardship may make a discretionary withdrawal from their eligible account balance, as defined in the Plan agreement.

**Forfeited accounts**

For the Plan years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$885 and \$1, respectively. Forfeitures that have not been used to pay administrative expenses or used to reduce employer contributions shall be allocated to Plan participants as of the last day of the Plan year following the Plan year in which the forfeitures occur, as defined in the Plan agreement.

Forfeitures of \$0 were allocated to Plan participants in 2024 and 2023.

**2. Summary of significant accounting policies**

**Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of estimates**

The preparation of financial statements in accordance with accounting principles generally

**Use of estimates (continued)**

accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amount of changes in net assets available for benefits during the reporting period, and disclosure of contingent assets and liabilities. Estimates are principally used in the determination of the fair value of investments. Actual results could differ from those estimates.

**Investment valuation and income recognition**

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value, and the common collective trust, which is reported at net asset value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, trustee, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants, and any matching contributions from the Company, are recorded in the year in which the employee contributions are withheld from their compensation.

**Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, that participant loan balance is reduced and a benefit payment is recorded.

**Payments of benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participants' accounts and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

**Subsequent events**

The Plan did not have subsequent events through August 21, 2025, which is the date the financial statements were available to be issued, for events requiring recording or disclosure in the financial statements for the year ended December 31, 2024.

**3. Information prepared and certified by custodian and trustees**

Information presented in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Principal Trust Company, custodian, and Principal Life Insurance Company, the trustees of the Plan from January 1, 2023 through April 30, 2023, and Reliance Trust Company, the trustee of the Plan from May 1, 2023 through December 31, 2024. The contract value of the guaranteed investment contract was certified by the custodian, Principal Trust Company, as of and for the year ended December 31, 2023. The guaranteed investment contract was fully paid out and has a zero-value balance as of December 31, 2024.

These certifications also include schedules of investments and inter-fund transfers.

**4. Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") *Accounting Standards Codification* ("ASC") 820, *Fair Value Measurements and Disclosures* are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for Plan investments. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Common collective trust:** Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. See Note 5 for more information.

**Guaranteed investment contract:** Investment in a group annuity contract, valued at contract value. The Principal Fixed Income Guaranteed Option is a single group annuity with a fixed rate of interest. This option is an insurance contract. A rate of interest contractually guaranteed by Principal Trust Company is credited to participant account balances. See Note 6 for more information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of

**5. Investment contract with common collective trust**

The Plan invested in the Principal LifeTime Hybrid Funds from January 1, 2023 through April 30, 2023 through a common collective trust (“CCT”) in the Plan. The Plan invests in the Putnam Stable Value Fund from May 1, 2023 through December 31, 2024 through a CCT in the Plan. The underlying investments held by the CCT are mutual funds valued at their net asset value per share as of the close of business on the valuation date and are considered to be level 1 investments. In calculating unit value per share for each class, investment income, realized and unrealized gains and losses, and expenses other than class-specific expenses, are allocated daily to each class of shares based upon the proportion of net assets of each class at the beginning of each day.

**6. Guaranteed investment contract**

The Plan entered into a fully benefit-responsive group annuity contract, Principal Fixed Income Guaranteed Option, issued by Principal Trust Company. The investment is a single group annuity contract with a fixed rate of interest. Principal Trust Company maintains contributions in a general account and due to the nature of these contracts, they do not have specific underlying assets assigned. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal Trust Company is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for the guaranteed investment contract and thus the investment is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

One of the primary risks involved with investment contracts is credit risk of the contract issuer; there are no reserves against contract value for credit risk of the contract issuer or otherwise if termination of the contracts were to occur. The average yield earned by the Plan is calculated by dividing the annualized earnings credited to participants of all fully benefit-responsive investment contracts by the fair value of all fully benefit-responsive investment contracts. Under the terms of the contract, the composite crediting rate is reset on a semi-annual basis and will never be less than the guaranteed minimum interest rate.

Certain events limit the ability of the Plan to transact at contract value. Such events include but are not limited to the following: 1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), 2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provisions, 3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or 4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited

transaction exemption under ERISA. The Plan Administrator does not believe that any events that limited the Plan's ability to transact at contract value with participants occurred while the investment was held.

The guaranteed investment contract does not permit Principal Trust Company to terminate the agreement prior to the scheduled maturity date.

The guaranteed investment contract was fully paid out during 2024 and has a zero-value balance as of December 31, 2024.

**7. Related party and party-in-interest transactions**

Certain Plan investments are managed by Reliance Trust Company from May 1, 2023 to December 31, 2024 and by Principal Trust Company and Principal Life Insurance Company from January 1, 2023 through April 30, 2023, and their respective sub-custodians, and, therefore, these transactions qualify as party-in-interest transactions. Investment and administrative expenses paid by the Plan to Reliance Trust Company, Principal Trust Company, and Principal Life Insurance Company totaled \$37,746 and \$23,813 for the years ended December 31, 2024 and 2023, respectively. The Plan also issues loans to participants which are secured by the balances in their accounts.

The Plan is administered by trustees appointed by the Board of Directors of Murdock Webbing Company, Inc. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**8. Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in all amounts allocated to their accounts.

**9. Tax status**

Through April 30, 2023, the Company had adopted a non-standardized pre-approved profit-sharing plan document, and was relying on the non-standardized pre-approved profit-sharing plan sponsor's opinion letter from the IRS dated June 30, 2020. Effective May 1, 2023, the Plan was restated in its entirety under a non-standardized pre-approved profit-sharing plan document, and is relying on the non-standardized pre-approved profit-sharing plan sponsor's opinion letter from the IRS dated October 6, 2020. The letters state that the non-standardized pre-approved profit-sharing plan and related trust are designed in accordance with the applicable sections of the IRC. Although the non-standardized pre-approved profit-sharing plan has been amended since receiving the opinion letters, the Plan's Administrator

and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**10. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
