Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Glencore Ltd. 401(k) Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

The supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

1. Description of Plan

The following description of Glencore Ltd. 401(k) Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Glencore Ltd. and ST Shipping and Transport Pte. Ltd. (collectively, the “Company” or “Employer”). The assets of the Plan are maintained by Lincoln Financial Group Trust Company, Inc. in various separate investment funds.

The Plan is sponsored by Glencore Ltd. and administered by the Company trustees of the Plan, consisting of four Glencore Ltd. representatives. The Company trustees serve without charging compensation for such service to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The purpose of the Plan is to provide a method to supplement retirement income to eligible employees of the Company. All employees of the Company over the age of 18 are eligible to participate in the Plan.

Contributions

Each year, eligible employees (the “Participants”) may contribute up to 50% of their eligible compensation on a pre-tax, after-tax or Roth basis, as defined in the Plan document, subject to certain Internal Revenue Code (“IRC”) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions; these additional contributions are eligible for employer matching contribution if the participant was hired after July 31, 2012. As of May 1, 2013, the Plan was amended such that, in the absence of an election made by a participant to the contrary, a participant shall be deemed to be automatically enrolled to contribute on a pretax basis 3% of his or her eligible compensation into his or her account. As of August 1, 2012, the Plan has been amended so that employees hired after July 31, 2012, are eligible for employer matching contributions under the Plan. Matching contributions will be made in the amount equal to 50% of the participant’s contributions that do not exceed 10% of the participant’s eligible compensation each payroll period. The Company may also make a non-elective discretionary contribution to eligible participants as defined in the Plan document. No non-elective discretionary contributions were made for the 2024 Plan year.

Participants may also contribute amounts representing distributions (rollovers or transfers) from other qualified defined benefit or defined contribution plans; however, these contributions are ineligible for employer matching contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) Employer contributions, if any, and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments

All investments are participant directed. The Plan currently offers mutual funds and a fixed annuity contract as investment options for participants.

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at the current prime rate, plus 1% at the time funds are borrowed and updated quarterly by the Plan administrator. Principal and interest are paid ratably through payroll deductions. A participant may have one loan outstanding at a time. If a participant's vested account value is less than the Plan minimum of \$1,000, no loan is available. Repayment of a loan must be made at least quarterly, on an after-tax basis, in level payments of principal and interest, and must be repaid within five years, unless the loan is taken for the purchase of a primary residence, in which case the loan must be repaid within 30 years.

Payment of Benefits

On termination of service, a participant may generally elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. Withdrawals may be made by the Participant in the event of hardship, as defined in the Plan document, after age 59 1/2, and at any time from rollover contribution accounts.

Vesting

Participants are immediately vested in their elective deferral contributions, plus actual earnings thereon. Participants are vested in the employer matching contributions after completing three years of service. Additionally, participants are vested in non-elective discretionary contributions after a period of three years, although there were no non-elective discretionary contributions made for the 2024 plan year.

Forfeitures

When a participant terminates employment with the Company prior to being fully vested, the non-vested portion of the participant's account represents a forfeiture. The plan document permits the use of forfeitures to either reduce future Employer contributions or Plan administrative expenses for the Plan year. However, if a participant is reemployed and fulfills certain requirements, as defined in the Plan document, the account will be reinstated. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4 and \$5,727. During 2024, \$66,684 of forfeitures were used to reduce Employer matching contributions.

Plan Expense Account

The Plan and Lincoln Retirement Services Company, LLC (“LRSC”), an affiliate of Lincoln Financial Group Trust Company, Inc., have entered into a revenue sharing arrangement whereby a portion of the revenue earned by LRSC from certain funds is passed through to the Plan for payment of permitted Plan expenses. In order for the Plan to receive revenue as a result of this arrangement, and to use the revenue to pay Plan expenses, a Plan Expense Account was setup under the Plan. The Plan Expense Account is a nonparticipant directed account within the Plan, and is used to record the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. The Plan Expense Account balance was \$0 and \$101 at December 31, 2024 and 2023. During 2024, \$6,842 from the Plan’s Expense Account was used to reduce administrative expenses incurred by the Plan and no amounts were allocated back to participants from the Plan’s Expense Account.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan’s investments, that were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

All of the Plan’s investments are stated at fair value except for the fixed annuity contract, which is stated at contract value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The fixed annuity contract is stated at contract value, which equals the sum of contributions plus interest credited, less withdrawals.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded when a distributable event occurs.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in the NAV of the respective funds and, consequently, those expenses are not separately reflected but are a component of net appreciation in value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 17, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and the net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, Inc., a qualified institution.

4. Fixed Annuity Contract

The Plan offers the Lincoln Stable Value Account (the “Contract”) as an investment option under the Plan. The Contract is a fully benefit-responsive fixed annuity contract issued by The Lincoln National Life Insurance Company. Principal and interest are guaranteed and is backed by the general assets of the issuing company. The Contract is designed to provide plan participants with liquidity, yield and stability. Benefit payments from the Contract are allowed whenever a qualifying life event occurs (upon retirement, termination and other life events), but voluntary withdrawals for the purpose of transfer to other investments are limited by the 90-day wash. The crediting rate is determined and declared periodically by a Lincoln executive committee. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The credit risk of the issuer, Lincoln National Life Insurance Company, is evaluated by nationally recognized statistical rating agencies. The financial ratings from these agencies are as follows: Moody’s Investor Service (A2 as of August 2025), A.M. Best (A as of February 2025), Standard and Poor’s (A+ as of July 2024), and Fitch (A+ as of July 2025).

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, participants would become 100% vested in their Company contributions.

6. Tax Status

The Internal Revenue Service (“IRS”) issued an Opinion letter to the prototype plan document preparer, Findley Davies Inc., dated June 30, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Party-in-Interest Transactions

Certain investments are managed by an affiliate of Lincoln Financial Group Trust Company, Inc., the trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

7. Party-in-Interest Transactions (*continued*)

Certain administrative functions are performed by employees of the Company. No such employees receive compensation from the Plan.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
