## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Sponsor of  
**Team Gillman 401(k) Plan**

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Team Gillman 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter — Supplemental Schedule Required by ERISA***

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Team Gillman 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan covering all employees of Gillman North, LLC (the “Plan Sponsor”); Gillman Imports North, Inc.; Gillman of Fort Bend, Inc.; Cgillman 3, LLC; CGillman Texas, LLC; Gillman North II LLC; Gillman North III, LLC; CGillman Texas II, LLC, CGillman CHO, LLC, and Gillman North VWK, LLC (collectively, the “Companies”). Employees are eligible to participate in the Plan immediately after completing 90 days of service and the attainment of age 18. The Plan is participant directed and participants may change their investment options at any time. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024 and September 15, 2024, the Plan was amended to include Cgillman CHO, LLC and Gillman North VWK, LLC as participating employers, respectively. Employees were credited for previous service time and allowed to participate immediately in the Plan upon reaching eligibility.

In December 2022, SECURE Act 2.0 (SECURE 2.0) was enacted. SECURE 2.0 has many provisions, both mandatory and elective with various effective dates. One of the mandatory provisions requires that, beginning in 2026, age 50 or older catch-up contributions made by employees making more than \$145,000 per year (subject to indexing) must be made to Roth accounts. Therefore, effective January 1, 2024, a Roth contribution option was added to the Plan. The Plan will amend the Plan document for the Roth contribution option and other changes related to SECURE 2.0 by December 31, 2026.

**Contributions**

Participants may elect to make pre-tax, Roth, and/or after-tax salary deferral contributions to the Plan up to 100% of their eligible compensation, subject to certain limitations. The Companies will automatically make a pre-tax salary deferral contribution of 3% of eligible compensation for newly eligible employees unless the employee elects not to participate or elects a different deferral percentage. Participants age 50 or over in the plan year may also make catch-up contributions into the Plan. Participant contributions are subject to applicable limitations of the Internal Revenue Code (IRC). Rollover contributions are allowed subject to conditions set forth in the Plan. Participants may change their contribution rates or elect to stop contributing at any time.

The Companies contribute a nondiscretionary matching contribution of 25% of each participant’s elective contribution that is up to 5% of the participant’s eligible compensation for the plan year. The Companies may also make an additional discretionary contribution, which shall be allocated to each eligible employee in proportion to his or her eligible compensation as a percentage of the eligible compensation of all eligible employees. No such discretionary contributions were made during 2024.

**NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)**

**Participant Accounts**

Each participant's account is credited with the participant's contributions and the Companies' contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are at all times fully vested in their participant and rollover contribution accounts and the appreciation or depreciation thereon. Vesting in the Companies' contributions portion of their accounts plus earnings thereon is based on years of service. Participants vest 10% per year after one year of service, 20% per year after three years of service, and are 100% vested after six years of service. A participant shall be immediately vested upon death, retirement, or termination of employment due to permanent disability.

**Notes Receivable from Participants**

Plan participants may borrow a minimum of \$1,000 and up to a maximum of the lesser of \$50,000 or 50% of their vested account balance in the Plan in accordance with the provisions of the Plan. The \$50,000 maximum loan amount is reduced by the highest loan balance of all loans that were active for the participant for the 12 months prior to the loan. Interest rates on loans are stated at the prime rate plus 1% at the date of the loan. Loans are repaid in level installments through payroll deductions for periods ranging up to five years. A participant may only have two loans outstanding at any time. Loans are secured by the participant's vested account balance to the extent of the principal amount of the loan plus accrued interest.

**Forfeited Accounts**

Forfeitures shall be used to pay administrative expenses or to reduce the Companies' contributions to the Plan. The forfeitures balance as of December 31, 2024 and 2023 was \$7,079 and \$36,154, respectively. During 2024, the Companies used \$131,977 to reduce the Companies' contributions to the Plan and \$14,462 to pay Plan expenses.

**Payment of Benefits**

Participants may elect to withdraw any part of their vested account balance upon retirement, termination of employment, death or disability, or attainment of age 59½. Normal retirement age is 65. Hardship withdrawals of vested balances due to immediate and heavy financial need are also permitted, subject to the terms of the Plan document. Distributions from the Plan are made in lump-sum payments or in alternative structures as allowed by the Plan.

**NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)**

**Plan Termination**

Although it has not expressed any intent to do so, the Companies have the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants would receive benefits based on their account balances accumulated to the date of termination of the Plan, becoming 100% vested in all amounts credited to their account.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Investments**

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Interest income is recorded when earned and dividend income is recorded on the ex-dividend date. Purchases and sales of investments are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

**Contributions**

Contributions from Plan participants and the matching contributions from the Companies are recorded in the plan year in which the participant contributions are withheld from compensation. The Companies' discretionary contribution is recorded in the plan year in which participant compensation is paid.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Fees related to recordkeeping and advisory services are allocated to participants' accounts and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

**Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Level 2* - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

*Level 3* - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The collective investment trust funds and stable value fund are valued at the underlying NAV per unit as determined by the issuer of the funds as practical expedients to estimate fair value. The Plan has no unfunded commitments or contractual obligation to further invest in the funds and there are no restrictions on redemption of these funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 - INFORMATION CERTIFIED**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Trust Company, LLC (Empower), the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment income and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS**

The Plan provides for investments in a stable value fund and a collective investment trust fund managed by Empower. Empower is the trustee as defined by the Plan. Therefore, these investments qualify as party-in-interest transactions. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are covered by an exemption from the prohibited transaction provisions.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 7 - INCOME TAX STATUS**

The Plan adopted a prototype plan document which obtained an opinion letter dated November 14, 2022 in which the Internal Revenue Service (IRS) stated that the pre-approved prototype plan document satisfies the applicable provisions of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, contributions to the Plan and earnings from its assets are not currently taxable to the Plan or its participants.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
