## INDEPENDENT AUDITOR'S REPORT

The Plan Administrator, Trustees, and Participants  
Total Care Services Inc 401(k) Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of the Total Care Services Inc 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C), which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from qualified institutions as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

## **NOTE 1 - PLAN DESCRIPTION**

The following description of the Total Care Services Inc. 401 (k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

### **1-A. General**

The Plan was established January 1, 2020, and provides eligible employees of Total Care Services Inc (collectively, the Company or the Employer) the opportunity to make regular and systematic contributions through withholdings. After attaining the age of 21, employees of the Company are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **1-B. Contributions**

Each eligible employee who elects to participate in the Plan may contribute any whole percentage of their compensation per payroll period. In addition, the Plan allows "catch-up" elective deferral contributions under Internal Revenue Code (IRC) Section 414(v) for those participants who have attained the age of 50 by the close of the plan year. Participants may elect a portion or all the deferral contributions to be made as Roth (after-tax) contributions. For the plan year ended December 31, 2024, the Company made no annual discretionary contribution to the Plan. Participants may also contribute amounts representing rollovers from other qualified plans.

### **1-C. Participant Accounts**

Each participant's account is credited with the participant's contribution, the Employer's matching and discretionary contributions, and an allocation of the Plan's earnings, and is charged with their withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

### **1-D. Participant Vesting**

Under the Plan, participants or their beneficiaries are entitled to 100% of their account balance upon death, disability, or retirement. Upon termination for any reason other than death, disability, or retirement, a participant's accrued benefit is subject to a six-year graded vesting formula for all employer contributions. A participant's voluntary contribution and earnings thereon is always 100% vested.

### **1-E. Forfeitures**

The non-vested portion of terminated participant accounts plus earnings thereon are forfeited and can be used by the Plan to pay administrative expenses and to reduce the amount of future employer contributions to the Plan.

### **1-F. Payment of Benefits**

Upon death, disability, retirement, termination of service, or attainment of the age 59½, the participants or their beneficiaries are entitled to receive a lump-sum distribution. Hardship withdrawals may be made by participants under certain conditions and are subject to certain restrictions. Participants are also allowed to make withdrawals from rollover accounts subject to limitations, as defined by the Plan Agreement.

### **1-G. Administrative Expenses**

Certain administrative expenses incurred by the Plan are paid by the Plan sponsor. Investment management fees are paid by the Plan in accordance with Plan provisions. Certain fees for participant-requested services are paid by the Plan and charged to the respective participants' accounts.

### **1-H. Investment Options**

Each participant may direct contributions into various investment options available under the Plan.

## **NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **2-A. Basis of Accounting**

The accounting principles and procedures followed by the Plan conform to accounting principles generally accepted in the United States of America (U.S. GAAP). The financial statements of the Plan are prepared under the accrual basis of accounting.

### **2-B. Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from estimates and differences could be material.

### **2-C. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### **2-D. Investment Valuation and Income Recognition**

The investments of the Plan are stated at fair value. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **2-E. Payment of Benefits**

Benefit payments to participants are recorded when paid.

### **2-F. Notes Receivable from Participants**

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses. Defaulted loans, if any, are reclassified as distributions based upon the terms of the Plan Agreement and recorded as benefits paid to participants in the statements of changes in net assets available for benefits.

## **NOTE 3 – INVESTMENTS**

In accordance with ASC 820, *Fair Value Measurements and Disclosures*, the Plan utilizes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets.

*Level 2* - Inputs to the valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in inactive markets, and other inputs that are observable or can be corroborated by observable market data.

Level 3 - Inputs to the valuation methodology are both significant to the fair value measurement and unobservable.

The following valuation methodologies were used to measure the fair value of the Plan's investments:

*Mutual Funds* – These funds are valued at the daily closing price. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled Separate Accounts (PSAs)* - Units held in PSAs are valued based on the underlying investments (i.e., common stock, mutual funds, short-term securities). While the majority of the underlying asset values are based on quoted prices, the NAV of the PSAs are not publicly quoted. The NAV is reported by the fund managers as of the financial statement date based on recent transaction prices, and is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The PSAs held by the Plan provide for daily redemptions by the Plan at the reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at the NAV on the measurement date. There are no unfunded commitments.

*Collective Investment Trust (CIT)* - Units held in a CIT are valued at NAV as reported by the trustee. The NAV is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The CIT held by the Plan provides for daily redemptions by the Plan at the reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. The investment strategy for the CIT, which is categorized as a balanced/asset allocation fund, is to seek total return consisting of long-term growth of capital and current income, consistent with the investment strategy of an investor who expects to retire in a specified target year. There are no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes the valuation methods are appropriate and consistent with the market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **NOTE 4 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C), pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's trustee, Fidelity Management Trust Company, has certified that the following data included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants, as shown in the accompanying statement of net assets available for benefits as of December 31, 2024.
- Investment income and interest income on notes receivable from participants, as shown in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H (Form 5500), Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and ERISA-required supplemental schedule.

## **NOTE 5 - TAX STATUS**

The Internal Revenue Service (IRS) informed Total Care Services Inc 401(k) Plan by an opinion letter dated April 10, 2014, that the pre-approved basic savings plan is acceptable under section 401 of the IRC. The plan has been amended since receiving the opinion letter. However, the Company and Plan Administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan continues to be tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **NOTE 6 - RELATED PARTY TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. No related party transactions of note besides proceeds being distributed to participants have been noted in the current year.

## **NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## **NOTE 8 – SUBSEQUENT EVENTS**

Management has evaluated subsequent events through August 28th, 2025 the date the financial statements were available to be issued.
