Note 1. Description of Plan

The following description of the Banks Chevrolet–Cadillac 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established to provide eligible employees of Banks Chevrolet–Cadillac, LLC (the “Company”) with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (“IRC”). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (“ERISA”).

Eligibility

All Company employees, other than union employees, nonresident aliens, and leased employees are eligible to participate in the Plan if they have attained the age of 21 and have completed one year of service with a minimum of 1,000 hours. Upon satisfying this requirement, employees will become eligible to participate in the Plan as of the first day of the following quarter.

Participant Contributions

Eligible participants may make voluntary contributions through salary reductions from 1% to 100% of their eligible annual compensation, as defined, limited to the maximum amount allowable under the provisions of the IRC (\$23,000 in 2024). Further, participants who are 50 years of age or older as of December 31, 2024, may contribute an additional “catch-up” contribution (\$7,500 in 2024). The Plan also allows rollover contributions from other qualified plans, as defined in the plan document. The Plan currently offers various mutual funds and common collective trust funds as investment options for participants.

Effective July 1, 2022, the Plan was amended and restated. In connection with the Plan restatement, Roth elective deferrals were added to the Plan.

Employer Contributions

The Company provides a discretionary matching contribution on behalf of each participant enrolled in the Plan. For the year ended December 31, 2024, the matching contribution was 100% of every dollar contributed, up to the first 4% of compensation, as defined in the Plan document. The amount of the discretionary match contribution was \$626,283 for the plan year ended December 31, 2024. Additional profit-sharing contributions in excess of the matching contributions may be made at the discretion of the Company’s board of directors. For the plan year ended December 31, 2024, the Company made no profit sharing contributions.

Participants must be employed as of the last day of the Plan year to be eligible to receive a matching and/or discretionary contribution.

Participants’ Accounts

Each participants’ account is credited with the participants’ contribution and allocation of employer contributions, if any, and Plan earnings or losses and charged with an allocation of investment/administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants’ vested account.

Cash Reserves and Other Income

Certain mutual fund expenses that are charged by the mutual fund companies to the individual participants (e.g., 12b-1, sub transfer agent) are recaptured by the Plan and held in a cash reserve account. These funds are then used to pay for expenses of the Plan that benefit the plan participants, approved by the Internal Revenue Service (“IRS”), Department of Labor (“DOL”), and ERISA, such as administration and auditing fees. During the year ended December 31, 2024, these funds amounted to \$12,367 and are included as other income in the accompanying statement of changes in net assets available for benefits. The balance in the cash reserve account was \$684 and \$545 at December 31, 2024 and 2023, respectively.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s contributions plus actual earnings thereon is based on the number of years of continuous service. Vesting begins after two years of service, as defined, with full vesting after six years of credited service. In the event of death, disability, or attainment of age 65, participants’ accounts become fully vested.

Payment of Benefits

Upon termination of employment, attainment of age 65, death, or disability, the participant or the participant’s beneficiary is entitled to receive the vested portion of the participant’s account in a single lump-sum. Further, withdrawals from the Plan before leaving the Company are available for special “hardship” reasons or after attaining the age of 59½. Distributions to participants are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses had been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. Participants may borrow against their own accounts in an amount of not less than \$1,000 up to the lesser of \$50,000 or 50% of their account balance. A participant may not have more than one loan outstanding at one time. All general-purpose loans must be repaid in full by the fifth anniversary of the loan. Loans for the purchase of a primary residence must be repaid by the tenth anniversary of the note.

Participants repay principal and interest through payroll deductions. During the repayment period of the loan, the trustee reallocates the repayment amounts among the investment funds in the same proportion as current investment allocations. The interest rate on loans from participants is determined by the plan administrator. All loans have a fixed interest rate set at inception at prime plus 1%.

Forfeitures

The Plan provides that forfeitures, the unvested portion of employer contributions for terminated participants, may be used to reduce future Company contributions. Forfeitures from participants totaled \$3,017 for the year ended December 31, 2024. The Company used forfeitures of \$12,022 to reduce profit sharing contributions for the year ended December 31, 2024 and gains and transfers (out) totaled \$204 and (\$3,365), respectively. At December 31, 2024 and 2023 the net forfeiture balance was \$9,724 and \$2,942, respectively, and is included in interest bearing cash in the accompanying statements of net assets available for benefits.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's sponsor determines the Plan's valuation policies utilizing information provided by the trustee. See Note 8 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year and held at year end.

Refundable Contributions Due to Participants

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to employer contributions. The Plan distributed the 2024 and 2023 contributions to the applicable participants prior to March 15 of the following year.

Administrative Expenses

The Company may, at its discretion, pay the expenses incidental to administering the Plan and are excluded from these financial statements. In the event that the Company does not pay Plan expenses, the expenses shall be paid by the Plan. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through August 28, 2025, which is the date the financial statements were available to be issued.

Note 3. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company ("Reliance"), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule, is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023

- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Tax Status

On November 30, 2020, the IRS stated that the volume submitter plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the IRC. The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of both December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Related-Party and Party-in-Interest Transactions

Certain Plan investments are shares of common collective trusts sub-advised by Sentinel Pension Advisors, Inc. ("SPA"), a division of Sentinel Benefits Group, Inc. ("SBGI"). Additionally, certain Plan investments are share of common collective trusts sub-advised by Reliance, the Plan's trustee. SPA and Reliance received \$41,776 and \$2,478, respectively, in direct compensation during the year ended December 31, 2024, which is included in administrative expenses on the statement of changes in net assets available for benefits. SBGI is the Plan's recordkeeper, as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules, as defined by ERISA. Fees paid to SBGI during the year ended December 31, 2024 totaled \$6,750.

Note 6. Plan Termination

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7. Risks and Uncertainties

The Plan provides for various investment options in accounts which invest in investment securities. Investment securities are exposed to various risks such as interest rate, market and credit. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that these changes could, in the near term, materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Note 8. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Significant unobservable inputs, including the Company's own assumptions in determining the fair value of investments.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: Valued based on the underlying unit value of the assets held. The assets on the underlying funds are invested in mutual funds, equity securities, debt securities. The NAV of the units of the accounts is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 9. Reconciliation of Financial Statements to the Form 5500
