- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

# JWD GROUP, INC. 401(K) PLAN

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF THE PLAN

The following description of the JWD Group, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### **General**

The Plan was originally established effective April 1, 1981 and has been restated effective June 30, 2020. The Plan is a defined contribution, salary deferral 401(k), and profit-sharing plan as permitted under Section 401(k) of the Internal Revenue Code (IRC). At December 31, 2024 and 2023, the assets of the Plan were maintained in investment funds held by Principal Trust Company (Principal), the Trustee of the Plan. The Plan is a qualified plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

The Plan covers substantially all full-time employees of John W. Danforth Company (the “Company”) who are not covered by a collective bargaining agreement. Employees are eligible to participate in the plan on the first day of the month after their hire date as long as they have attained age 21.

#### **Contributions**

Participants who are eligible to participate in the Plan are automatically enrolled with an initial contribution of 5%. Each participant may elect to contribute from 0% to 100% of his or her salary subject to the limitations set by the Internal Revenue Code (\$23,000 in 2024 and \$22,500 in 2023) as a tax-deferred contribution to the Plan. Participants who are at least 50 years old may make additional “catch-up” contributions annually (\$7,500 in 2024 and 2023). The Company will make non-discretionary matching contributions on 100% of pretax participant contributions up to 4% of the participants’ eligible wages. The Plan provides that participants may deposit payments that they receive from other retirement plans. Such contributions are referred to as employee rollover contributions.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s contribution, the Company’s contribution, and allocated earnings/losses. Earnings/losses are allocated daily from the investment chosen by a participant based on the fair value of their respective ownership in the underlying investment.

#### **Vesting**

Participants are fully vested immediately in all voluntary and Company contributions.

#### **Payment of Benefits**

Participants are entitled to receive 100% of their account balances upon normal retirement at age 65. A participant may elect to defer benefits until age 70-1/2. Benefit payments can be made either in lump sum amounts based on the account balance at retirement date, installments (only if the participant is subject to lifetime required minimum distribution), ad-hoc amounts, or in any of four types of annuities. Benefits may be paid in cash or rolled over to an individual retirement account, or a combination thereof. In-service withdrawals may be made by participants who have attained age 59-1/2 during the year. Withdrawals may also be made for reasons of financial hardship prior to age 59-1/2 or upon early retirement.

## 1. DESCRIPTION OF THE PLAN (Continued)

### **Notes Receivable from Participants**

The Plan provides for loans to participants with a minimum loan amount of \$1,000 and a maximum loan amount limited to the lesser of \$50,000 or one-half of the participant's vested account balance. The maximum term of a loan is five years. Interest is charged at a fixed rate established by the Plan as of the date of the loan.

### **Investments**

Participants have the option of directing their contributions into mutual fund accounts, and/or common collective trusts managed by Principal. Participants may elect to change the allocation of their individual accounts among the investment alternatives at any time. Common collective trusts are advisor-managed accounts sponsored by Principal that invest in investment securities or mutual funds. Many of these common collective trusts are invested in a single mutual fund.

### **Plan Administration**

The Plan is administered by the Company. Participant account records are maintained by the Plan's Trustee, Principal. A portion of the administrative expenses may be paid by the Plan. Administrative expenses not paid by the Plan are paid by the Plan Sponsor.

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The Plan prepares its financial statements on the accrual basis of accounting and presents the fair value of net assets available for benefits and changes in those net assets in accordance with accounting principles generally accepted in the United States of America.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from management's estimates and assumptions.

### **Investment Valuation and Income Recognition**

The Plan's assets are held in a trust maintained by Principal. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Security Transactions and Investment Income**

Purchases and sales of investments are recorded on a trade-date basis. Net appreciation in fair value of investments includes realized gains and losses, and unrealized gains and losses attributable to the investments. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document.

### **Benefit Payments**

Benefits are recorded when paid.

### **Administrative Expenses**

Investment fees associated with the Plan are paid by the Plan and administrative expenses not paid by the Plan are paid by the Plan Sponsor.

### **Risks and Uncertainties**

The Plan's assets include various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to the value of such investments, changes in the values of investments will occur and such changes could materially affect the amounts reported in the financial statements.

### **Income Taxes**

The Plan has relied on its determination letter received by Principal for its prototype plans and for subsequent Plan amendments that have been adopted to comply with changes under Federal law. Principal received its latest determination letter for its prototype plans on June 30, 2020, stating that the Plan is qualified under the Internal Revenue Code as exempt from Federal income taxes.

## 3. FAIR VALUE MEASUREMENTS

The Plan uses various valuation techniques in determining fair value. Accounting Standards Codification (ASC) Section 820 established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

### 3. FAIR VALUE MEASUREMENTS (Continued)

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been certain changes in the methodologies used for the year ended December 31, 2024. There were no changes in the methodologies used for the year ended December 31, 2023.

#### **Mutual Funds**

The fair values of the Plan's mutual funds are based on quoted market prices in active markets.

#### **Common Collective Trusts**

Common collective trusts contain investments in a collective trust fund as well as a variety of separate accounts and mutual funds. The fair value of the collective trust fund and the separate accounts are not publicly quoted pricing inputs. The fair value of the mutual funds are publicly quoted pricing inputs. The fair value of all these investments are used in determining the net asset value ("NAV") of the common collective trust, which is not publicly quoted. The common collective trusts can be redeemed at NAV as of the measurement date.

The common collective trusts can be redeemed on a daily basis and there are no restrictions. There are no unfunded commitments.

#### **Pooled Separate Accounts**

The pooled separate accounts invest mainly in mutual funds. The fair value of the pooled separate accounts is based on quoted market prices for the underlying assets owned by the pooled separate accounts. The pooled separate accounts invest in a variety of designated mutual funds. The investment objective of these funds is aligned with the underlying investment of the fund. There are no unfunded commitments or withdrawal restrictions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 3. FAIR VALUE MEASUREMENTS (Continued)

Financial assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurements. For the years ended December 31, 2024 and 2023, there were no changes to valuation methodologies.
