### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Servotronics, Inc. 401(k) Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

## *Notes to Financial Statements*

### 1. Description of the Plan

The following description of the Servotronics, Inc. 401(k) Profit Sharing Plan & Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan with a 401(k) feature covering substantially all employees of Servotronics, Inc. (the “Company” or “Plan Administrator”), who are age eighteen or older. There is no service requirement.

The Plan was established effective April 1, 2000 and was subsequently amended most recently on September 1, 2021 to increase the employer match. The Board of Directors are responsible for oversight of the Plan.

**Contributions** – Participants may elect to make salary-reducing contributions to the Plan of a specific percentage or dollar amount up to 92% of their annual compensation as a pre-tax or Roth contribution, limited by the amount imposed by law. Participants who are 50 years and older are eligible to make catch-up contributions. Elective deferral contributions shall be limited as needed to meet nondiscrimination tests. Participants may also make rollover contributions from other qualified plans. Rollovers into the Plan amounted to \$949,086 and \$75,548 for the years ended December 31, 2024 and 2023, respectively.

The Plan Administrator elected to make matching contributions equal to 75% of the first 4% of participant compensation contributed for the years ended December 31, 2024 and 2023. The Plan Administrator may also make discretionary contributions subject to certain limitations. The Plan Administrator did not make discretionary contributions for the years ended December 31, 2024 and 2023.

**Participant Accounts** – An account is maintained for each participant in the Plan. This account is credited with the participant’s contributions, the Plan Administrator’s contributions and earnings on the participant-directed investments. The account is reduced by the payment of benefits and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document.

**Vesting** – Participants are immediately vested in both their contributions and the Plan Administrator’s contributions plus actual earnings thereon.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, 95% of one-half of their vested account balance, or 95% of their total vested account balance excluding the Roth Elective Deferral balance. A participant may have no more than two loans outstanding at one time. The loans are secured by the balance in the participant’s account and bear interest at the prime rate plus 1%. Principal and interest is paid ratably through payroll deductions.

## *Notes to Financial Statements (continued)*

### 1. Description of the Plan (continued)

**Payment of Benefits** – Upon termination of service due to retirement, death, disability or as required by law, a participant may elect to receive annual installment distributions or a lump-sum distribution in an amount equal to the vested value of their account. For termination of service due to other reasons, a participant may receive the amount equal to the vested value of their account as a lump-sum. The Plan permits in-service distributions for participants older than age 59½. Participants may also apply for a hardship withdrawal by certifying to the Plan Administrator all of the required criteria with documentation substantiating the hardship.

**Tax Status** – The Plan uses a prototype plan document sponsored by Paychex, Inc. Paychex, Inc. received an opinion letter from the Internal Revenue Service (“IRS”) dated August 31, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (“IRC”). The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since the prototype plan received the determination letter, the Plan Administrator and the Plan’s tax counsel believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

**Plan Termination** – The Plan Administrator reserves the right under the Plan document to discontinue its contributions and to terminate the Plan at any time, subject to the provisions of ERISA. See subsequent events in Note 2.

### 2. Summary of Significant Accounting Policies

**Basis of Accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Valuation of Investments and Income Recognition** – The Plan’s investments are stated at fair value as certified by the custodian, Mid Atlantic Trust Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

#### **2. Summary of Significant Accounting Policies (continued)**

The Plan presents in the accompanying statements of changes in net assets available for benefits the net appreciation in the fair value of its investments which consists of the realized gains and the unrealized appreciation of those investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

***Payment of Benefits*** – Benefits are recorded when paid.

***Administrative Expenses*** – Certain expenses of maintaining the Plan are paid directly by the Plan Administrator and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and requests for distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in investment income.

***Risks and Uncertainties*** – Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

***Use of Estimates*** – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

***Reclassification*** – In order to facilitate comparison of financial information, certain amounts reported in the prior year have been reclassified to conform to the current year presentation.

***Subsequent Events*** – The Plan Administrator has evaluated subsequent events for recognition or disclosure, through September 17, 2025, the date the accompanying financial statements were available to be issued.

Effective July 1, 2025, the Company was acquired by TransDigm, Inc. As a result of the acquisition, the Company expects to officially terminate the Plan as of December 31, 2025 and provide distribution options to participants beginning in 2026.

#### **3. Information Certified by the Custodian (Unaudited)**

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan has elected to utilize the certification of certain financial information by the custodian, Mid Atlantic Trust Company.

**4. Fair Value Measurements**

ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.
- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security.
- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity’s own assumptions about the assumptions that market participants would use in pricing the asset or liability. There were no assets of the Plan that utilized Level 3 inputs as its primary measure of fair value as of December 31, 2024 or 2023.

**4. Fair Value Measurements (continued)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Investment Trust:* The common collective investment trust is a pooled investment vehicle sponsored and maintained by a trust company and is made up of a variety of stable value investment contracts, including conventional guaranteed investment contracts and synthetic investment contracts, as well as cash and cash equivalents. The common collective investment trust is valued daily based on the market value of the underlying assets, with fair value determined by dividing the fair value of the common collective investment trust's net assets by the total number of units owned.

The preceding methods described may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Reconciliation with Form 5500**

The accompanying financial statements, which are prepared in accordance with U.S. GAAP, calculate realized gains and losses on sales of securities and unrealized gains and losses (change in market value on securities held at year end) using historical cost. However, Form 5500, Annual Return/Report of Employee Benefit Plan, requires the calculation of such gains and losses to be measured on the basis of revalued cost on Schedule H. Revalued cost is calculated based on the market value of a security on the first day of the fiscal year plus the cost of any current year purchases, less the beginning market value of any current year sales. In total, however, the financial statement calculation of gains and losses and the calculation for Form 5500 are the same.

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Servotronics, Inc. 401(k) Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

## *Notes to Financial Statements*

### 1. Description of the Plan

The following description of the Servotronics, Inc. 401(k) Profit Sharing Plan & Trust (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General** – The Plan is a defined contribution plan with a 401(k) feature covering substantially all employees of Servotronics, Inc. (the “Company” or “Plan Administrator”), who are age eighteen or older. There is no service requirement.

The Plan was established effective April 1, 2000 and was subsequently amended most recently on September 1, 2021 to increase the employer match. The Board of Directors are responsible for oversight of the Plan.

**Contributions** – Participants may elect to make salary-reducing contributions to the Plan of a specific percentage or dollar amount up to 92% of their annual compensation as a pre-tax or Roth contribution, limited by the amount imposed by law. Participants who are 50 years and older are eligible to make catch-up contributions. Elective deferral contributions shall be limited as needed to meet nondiscrimination tests. Participants may also make rollover contributions from other qualified plans. Rollovers into the Plan amounted to \$949,086 and \$75,548 for the years ended December 31, 2024 and 2023, respectively.

The Plan Administrator elected to make matching contributions equal to 75% of the first 4% of participant compensation contributed for the years ended December 31, 2024 and 2023. The Plan Administrator may also make discretionary contributions subject to certain limitations. The Plan Administrator did not make discretionary contributions for the years ended December 31, 2024 and 2023.

**Participant Accounts** – An account is maintained for each participant in the Plan. This account is credited with the participant’s contributions, the Plan Administrator’s contributions and earnings on the participant-directed investments. The account is reduced by the payment of benefits and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document.

**Vesting** – Participants are immediately vested in both their contributions and the Plan Administrator’s contributions plus actual earnings thereon.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, 95% of one-half of their vested account balance, or 95% of their total vested account balance excluding the Roth Elective Deferral balance. A participant may have no more than two loans outstanding at one time. The loans are secured by the balance in the participant’s account and bear interest at the prime rate plus 1%. Principal and interest is paid ratably through payroll deductions.

### 1. Description of the Plan (continued)

**Payment of Benefits** – Upon termination of service due to retirement, death, disability or as required by law, a participant may elect to receive annual installment distributions or a lump-sum distribution in an amount equal to the vested value of their account. For termination of service due to other reasons, a participant may receive the amount equal to the vested value of their account as a lump-sum. The Plan permits in-service distributions for participants older than age 59½. Participants may also apply for a hardship withdrawal by certifying to the Plan Administrator all of the required criteria with documentation substantiating the hardship.

**Tax Status** – The Plan uses a prototype plan document sponsored by Paychex, Inc. Paychex, Inc. received an opinion letter from the Internal Revenue Service (“IRS”) dated August 31, 2020, which states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (“IRC”). The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since the prototype plan received the determination letter, the Plan Administrator and the Plan’s tax counsel believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

**Plan Termination** – The Plan Administrator reserves the right under the Plan document to discontinue its contributions and to terminate the Plan at any time, subject to the provisions of ERISA. See subsequent events in Note 2.

### 2. Summary of Significant Accounting Policies

**Basis of Accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

**Notes Receivable from Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Valuation of Investments and Income Recognition** – The Plan’s investments are stated at fair value as certified by the custodian, Mid Atlantic Trust Company. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

### **2. Summary of Significant Accounting Policies (continued)**

The Plan presents in the accompanying statements of changes in net assets available for benefits the net appreciation in the fair value of its investments which consists of the realized gains and the unrealized appreciation of those investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

***Payment of Benefits*** – Benefits are recorded when paid.

***Administrative Expenses*** – Certain expenses of maintaining the Plan are paid directly by the Plan Administrator and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and requests for distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in investment income.

***Risks and Uncertainties*** – Investments are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

***Use of Estimates*** – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

***Reclassification*** – In order to facilitate comparison of financial information, certain amounts reported in the prior year have been reclassified to conform to the current year presentation.

***Subsequent Events*** – The Plan Administrator has evaluated subsequent events for recognition or disclosure, through September 17, 2025, the date the accompanying financial statements were available to be issued.

Effective July 1, 2025, the Company was acquired by TransDigm, Inc. As a result of the acquisition, the Company expects to officially terminate the Plan as of December 31, 2025 and provide distribution options to participants beginning in 2026.

### **3. Information Certified by the Custodian (Unaudited)**

As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan has elected to utilize the certification of certain financial information by the custodian, Mid Atlantic Trust Company.

**4. Fair Value Measurements**

ASC 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.
- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security.
- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity’s own assumptions about the assumptions that market participants would use in pricing the asset or liability. There were no assets of the Plan that utilized Level 3 inputs as its primary measure of fair value as of December 31, 2024 or 2023.

**4. Fair Value Measurements (continued)**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Investment Trust:* The common collective investment trust is a pooled investment vehicle sponsored and maintained by a trust company and is made up of a variety of stable value investment contracts, including conventional guaranteed investment contracts and synthetic investment contracts, as well as cash and cash equivalents. The common collective investment trust is valued daily based on the market value of the underlying assets, with fair value determined by dividing the fair value of the common collective investment trust's net assets by the total number of units owned.

The preceding methods described may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Reconciliation with Form 5500**

The accompanying financial statements, which are prepared in accordance with U.S. GAAP, calculate realized gains and losses on sales of securities and unrealized gains and losses (change in market value on securities held at year end) using historical cost. However, Form 5500, Annual Return/Report of Employee Benefit Plan, requires the calculation of such gains and losses to be measured on the basis of revalued cost on Schedule H. Revalued cost is calculated based on the market value of a security on the first day of the fiscal year plus the cost of any current year purchases, less the beginning market value of any current year sales. In total, however, the financial statement calculation of gains and losses and the calculation for Form 5500 are the same.
