**1. Description of Plan**

The following description of Old Colony Hospice, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan is a tax-exempt, defined contribution retirement plan sponsored by Old Colony Hospice, Inc. (the Organization). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Reliance Trust Company (the custodian) is the custodian of the Plan. The Standard Insurance Company (The Standard) is the recordkeeper of the Plan.

**Eligibility**

The Plan is available to all employees of the Organization, except nonresident aliens. There is no age requirement for Plan participation. Eligible employees may begin making elective deferrals to the Plan upon hire and are eligible for the employer contribution upon completing one year of service.

**Vesting**

Participants are fully vested in that portion of their account which represents their contributions and the income earned thereon. Participants become 100% vested in the Organization's contributions and earnings thereon upon death, total and permanent disability, or attainment of normal retirement age. Otherwise, a participant's interest in the Organization's contributions and earnings thereon vests according to the following schedule:

**Forfeitures**

Forfeited balances are used to pay plan expenses and reduce the Organization's contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$11,519 and \$7,052, respectively.

### **Contributions**

Each year, eligible employees may make contributions to the Plan through salary deferrals on a pre-tax basis up to 100% of eligible compensation, as defined in the Plan. Eligible employees may also make Roth contributions on an after tax basis. The maximum amount that a participant may contribute is limited by provisions of the Internal Revenue Code (the Code).

The Plan did not provide a discretionary non-elective contribution for the year ended December 31, 2024.

### **Participant Accounts**

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's and employer's contributions and an allocation of investment income. A participant's account shall be reduced by any distributions, investment losses, and certain administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account.

### **Investments**

Upon enrollment in the Plan, a participant may direct his or her account balance among the various investments offered by the Plan. The Plan offers investments in shares of mutual funds and a fixed income account.

### **Payment of Benefits**

Participants shall become eligible to receive their vested account balances upon retirement (the normal retirement age is 65), death, disability, or termination. Participants may withdraw their account balances upon attaining age 59½. Participants may receive their benefit payments in a single lump sum payment or a monthly annuity. In addition, participants may withdraw their pre-tax contributions upon demonstration to the plan administrator that they are suffering a hardship, as defined in Section 403(b) of the Code.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements have been prepared on the modified cash basis of accounting. Accordingly, certain revenue and related assets are recognized when received, rather than when earned, and certain expenses are recognized when paid, rather than when incurred.

### **Use of Estimates**

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Actual results could differ from those estimates.

### **Investments**

Investments are reported at fair value, except for the fully benefit-responsive fixed income account, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 9 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the cash basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document.

### **Administrative Expenses**

Certain administrative expenses are paid by the Organization on behalf of the Plan; however, certain expenses including investment advisory services and loan administration fees are paid by the participants.

### **Payment of Benefits**

Benefit payments to participants are recorded upon distribution.

### **Subsequent Events**

Management has considered transactions or events occurring through September 15, 2025, the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### **3. Fixed Income Account**

The fixed income account is included in the financial statements at contract value. Contract value represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Investments in the Standard Stable Asset Fund D are in a guaranteed fixed-interest account. The Standard maintains the contributions in the general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The plan administrator is not aware of any withdrawal fees or restrictions on the withdrawal of funds from the Standard Stable Asset Fund D upon separation of service; accordingly, this investment is considered to be fully benefit-responsive.

#### 4. Income Tax Status

The Plan obtained its latest advisory letter on March 31, 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the advisory letter. However, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### 5. Information Prepared and Certified by the Custodian

The investments, investment transactions, net appreciation in fair value of investments, and interest and dividends amounts were obtained by management and agreed to, or derived from, the information certified by the custodian as complete and accurate. This information is included in the following:

- Statements of Net Assets Available for Benefits (Modified Cash Basis);
- Statement of Changes in Net Assets Available for Benefits (Modified Cash Basis); and
- Schedule H, line 4i - Schedule of Assets (Held at End of Year).

#### 6. Parties-in-Interest

All of the Plan's investments are managed by the custodian; therefore, these transactions qualify as party-in-interest transactions. The administrative expenses paid by the Plan for 2024 were \$35,909, and qualify as party-in-interest transactions as they are related to recordkeeper fees and investment advisor fees incurred by the Plan.

#### 7. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and these changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits (modified cash basis).

### 9. Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds were valued at the quoted price of shares held by the Plan at year-end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.


