NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following brief description of the Fuccillo Automotive Group, Inc. 401(k) Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan for employees of Fuccillo Automotive Group, Inc. (the Company) who meet certain eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

For the years ended December 31, 2024 and 2023, Reliance Trust Company served as the custodian of the Plan's assets and certified balances and Transamerica Financial Life Insurance Company (Transamerica) served as the Plan recordkeeper.

Eligibility

The Plan covers substantially all employees who have attained the age of 21 and completed one year of service. Employees are eligible to participate in the Plan on the first day of the quarter following satisfaction of the Plan's eligibility requirements.

Contributions

Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined by the Plan, subject to certain limits established by the Internal Revenue Code. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company matches each participant's elective deferrals by contributing 10% of the first 5% of compensation deferred. Additional matching contributions may be made at the option of the Company's management, subject to certain limitations. There were no additional matching contributions for the years ended December 31, 2024 and 2023.

Discretionary contributions may be made at the option of the Company's Board of Directors. In order to receive an allocation of a discretionary contribution, participants must be employed on the last day of the Plan year. Contributions are subject to certain limitations. There were no discretionary contributions for the years ended December 31, 2024 and 2023.

Participants' Accounts

Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions, the Company's contributions, and an allocation of both the Plan's actual earnings (losses) and the Plan's administrative expenses. Discretionary contributions are allocated to each participant's account based on their compensation as a percentage of the compensation of all participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus earnings (losses) thereon is based on years of continuous service as follows:

Less than 1	0%
1 but less than 2	20%
2 but less than 3	40%
3 but less than 4	60%
4 but less than 5	80%
5 or more	100%

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of the participant's vested account balance, subject to certain conditions as defined in the Plan agreement. The loan and interest thereon shall be repaid over a period not to exceed five years (except for certain residential loans which can extend up to ten years). Outstanding loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined annually by the Plan administrator. The interest rate on all outstanding loans ranged from 4.25% to 9.5% at December 31, 2024. Principal and interest are paid ratably through weekly payroll deductions.

Benefit Payments

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, partial withdrawals, or rolled over to another qualified investment. The normal retirement age for participants is 65, at which time, participants are entitled to 100% of their account balance. Actively-employed participants that have reached the age of 59 ½ may elect to receive in-service distributions.

Participants with a balance of less than \$5,000 will receive a lump sum payment.

Hardship withdrawals are permitted in the event of immediate and heavy financial need. Participants may elect to receive a hardship withdrawal in an amount equal to the value of their elective deferral contributions.

Forfeited Accounts

Forfeited non-vested accounts may be used to reduce Company matching contributions or plan administrative expenses. Forfeited non-vested accounts totaled \$0 at both December 31, 2024 and 2023. The Company used \$618 and \$3,807 of forfeitures to pay for plan administrative expenses for the years ended December 31, 2024 and 2023, respectively.

Investment Options

Investments are held in various mutual funds and a common collective trust. The common collective trust is maintained by Goldman Sachs.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value. The Plan's mutual funds are stated at fair value and the Plan's common collective trust is stated at fair value using the net asset value per share practical expedient. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit loss has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded based upon the terms of the plan document.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Benefit Payments

Benefit payments are recorded when paid.

Excess Contributions Payable

Amounts payable to participants totaling \$34,361 and \$21,932 at December 31, 2024 and 2023, respectively, for contributions in excess of amounts allowed by the IRS are recorded as a liability and are net with participant contributions in the statements of changes in net assets available for benefits. The Plan distributed the excess contributions to the applicable participants in the following year.

Administrative Expenses

Expenses incurred in connection with the purchase or sale of securities are charged against the investment funds whose assets are involved in such transactions. Certain administrative costs of the Plan are paid by the Company. All other expenses relating to participant transactions are deducted from those participant accounts as transactions occur.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

3. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standard Codification (ASC) 820, Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following is a description of the valuation methodologies used for assets for which fair values are estimated using the net asset value (NAV) practical expedient:

- *Common collective trust funds*: valued at the NAV provided by the manager of the funds. The NAV is calculated as the underlying net assets owned by the funds, divided by the number of units outstanding. The NAV is based on the fair value of the underlying securities within the funds.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To achieve its objective, the Fund invests in stable value investment contracts, fixed income instruments, and money market instruments.

4. CERTIFIED INVESTMENTS

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian of the Plan, Reliance Trust Company, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate as of and for the years ended December 31, 2024 and 2023.

5. PARTY-IN-INTEREST TRANSACTIONS

Plan investments were managed by Reliance Trust for the year ended December 31, 2024 and 2023. The Plan also utilized Transamerica as the Plan recordkeeper and Bank of America as an investment advisor. Therefore, transactions with these parties qualify as party-in-interest transactions. Additionally, transactions involving notes receivable from participants qualify as party-in interest transactions.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent vested in their accounts.

7. INCOME TAX STATUS

The Plan adopted a pre-approved plan offered by Transamerica Retirement Solutions LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
