INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of
Bentwater on The North Shore 401k Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bentwater on The North Shore 401k Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Texas Oncology, P.A. Cash Balance Pension Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information. The Plan was amended and restated effective January 1, 2024 to adopt an updated basic plan document. There were no changes to Plan provisions.

General

The Plan is a cash balance defined-benefit pension plan established January 1, 2019 for the purpose of providing retirement benefits for certain employees of Texas Oncology, P.A. (the “Company”). Employees listed in the Appendix of Eligible Employees as amended per the Plan document are eligible to participate in the Plan.

Eligible employees shall become a participant as of the first entry date coinciding with or next following the attainment of age 21 and completion of one year of service. Plan entry dates are January 1 or July 1 coinciding with or next following the completion of meeting the eligibility requirements. The Plan is subject to the provisions of the Department of Labor’s (DOL) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Assets of the Plan are held in a trust account (the “Trust”) by Vanguard Fiduciary Trust Company, the trustee of the Plan.

Funding

Participants are not allowed to make contributions to the Plan. The Plan’s funding policy is for the Company to contribute an amount which will meet or exceed the annual ERISA minimum funding requirement. Annual contributions by the Company are based on actuarial computations of funding requirements. The annual contribution is computed by FuturePlan, the Plan’s actuary, pursuant to the traditional unit credit cost method. The Plan has met the minimum funding requirements of ERISA for the year ended December 31, 2024.

Participant Accounts

Under the Plan provisions, a cash balance account shall be established and maintained for each participant. A participant’s cash balance account shall be credited with contribution credits and interest credits. A participant’s cash balance account shall be a hypothetical account and shall not be construed as an allocation of assets of the Plan or a segregation of such assets.

Participant Credits

For each Plan year, contribution credits shall be allocated at the end of each Plan year. Contribution credits for a Plan year shall be the contribution credit amount determined based on subsections defined in the Plan document. The maximum cash balance credit for any participant for any Plan year is limited based on actuarial computations as defined in the Plan document.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Each cash balance account will be credited with an interest credit by applying the net rate of return (positive or negative) earned by the Plan assets in the Trust, after adjustment for Plan expenses paid from the Trust, but will not be greater than 5%. The interest credit is credited annually as of the last day of the Plan year and is based on the value of each participant's cash balance account as of the beginning of the Plan year, weighted for contribution credits and distributions made during the Plan year. The interest credit rate for 2024 was 5%.

Vesting

A participant's account becomes 100% vested upon completion of three years of service.

Pension Benefits

Normal retirement age is the later of age 62 or the third anniversary of the first day of the Plan year in which the employee commenced participation in the Plan. Participants who retire upon attaining normal retirement age are entitled to commence benefits as of any day following retirement. Participants who terminate service prior to attaining normal retirement age and have a vested cash balance account will be entitled to commence receiving benefits following the last day of the Plan year which the participant terminates employment. Benefits are determined based on the participant's cash balance account. Plan participants are eligible for their plan benefit after terminating employment with vested rights. Upon termination of employment, the automatic form of payment is a straight life annuity for an unmarried participant or a 100% joint and survivor annuity for a married participant. A participant also has the option to select a single lump sum payment. If a participant terminates service and their cash balance account is \$5,000 or less, a lump sum payment will be made as soon as administratively feasible following the last day of the Plan year which the participant terminates employment. In-service distributions are available to participants who remain in service after age 59 ½, subject to provisions of the Plan. Direct rollovers from the Plan to other qualified retirement accounts are allowed for eligible rollover distributions, subject to conditions established in the Plan document. Participants are subject to required beginning distribution dates.

Death Benefits

If a participant dies prior to the annuity starting date, the beneficiary shall be entitled to a death benefit based on the participant's cash balance account. If the beneficiary is not the participant's surviving spouse, the death benefit shall be a lump sum payment equal to the participant's cash balance account which must be paid within the 5-year period following the participant's death. If the beneficiary is the participant's surviving spouse, such beneficiary shall receive an annuity for their life (straight life annuity) commencing on the first day of the month following the participant's date of death, or at the election of the spouse, a lump sum payment equal to the participant's cash balance account. If the participant's death occurs prior to normal retirement date, the surviving spouse may elect in writing to defer the commencement of the benefit payable in the form of a straight line annuity, or in the form of a lump sum, until the participant's normal retirement date. If the participant's cash balance account is \$5,000 or less, an immediate lump sum payment of the account will be made as soon as practicable following such participant's death.

Plan Termination

While the Company has not expressed an intent to discontinue its contributions, it is free to do so at any time. In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

- a. Benefits attributable to employee contributions, if any, taking into account those paid out before termination.
- b. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under Plan provisions in effect at any time during the five years preceding termination.
- c. Other vested benefits insured by the Pension Benefit Guaranty Corporation (the "PBGC") up to the applicable limitations (discussed below).
- d. All other vested benefits (that is, vested benefits not insured by the PBGC).
- e. All nonvested benefits.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. There is a statutory ceiling, which is adjusted periodically, on the amount of an individual's monthly benefit that the PBGC guarantees.

Should the Plan terminate in the future, all participants will receive their benefits dependent on (a) the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations, (b) the financial condition of the plan sponsor, and (c) the level of benefits guaranteed by the PBGC.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein; disclosure of contingent assets and liabilities; and the actuarial present value of accumulated plan benefits at the date of the financial statements. Accordingly, actual results may differ from those estimates.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investments

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments bought and sold, as well as held during the year.

Payments of Benefits

Benefit payments to participants or beneficiaries are recorded upon distribution.

Expenses of the Plan

All reasonable expenses of administering the Plan will be paid out of the Plan assets unless paid for by the Company. Expenses that are paid directly by the Company are excluded from these financial statements.

NOTE 3 - ACTUARIAL PRESENT VALUE OF ACCUMULATED PLAN BENEFITS

Accumulated plan benefits are those future periodic payments, including lump sum distributions that are attributable under the Plan's provisions to the service employees have rendered to the date of the actuarial valuation. Accumulated plan benefits include benefits expected to be paid to: (a) retired or terminated employees or their beneficiaries; (b) beneficiaries of employees who have died; and (c) present employees or their beneficiaries. The accumulated plan benefits for active employees are based on their compensation multiplied by a retirement credit factor on the date as of which the benefit information is presented (the valuation date). Benefits payable under all circumstances – retirement, death, disability, and termination of employment – are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

The actuarial present value of accumulated plan benefits is determined using the unit credit rate by the Plan's independent enrolled actuary, FuturePlan, and is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment. The significant actuarial assumptions used in the valuation were (a) life expectancy of participants (in 2024, the Plan used the RP-2014 combined mortality tables for males and females using Scale MP-2025 and in 2023 the Plan used the RP-2014 combined mortality tables for males and females using Scale MP-2024) (b) retirement age (weighted average retirement age was 62 for 2024 and 2023) and (c) accumulation rate (in 2024 and 2023 this was 4.0% and 3.5% per annum, respectively, compounded annually, for current and all future periods). The foregoing actuarial assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

NOTE 4 - FAIR VALUE MEASUREMENTS

Various inputs are used in determining the fair value of the Plan’s investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used for valuing securities at December 31, 2024 or 2023.

NOTE 5 - INFORMATION CERTIFIED

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company, has certified to the completeness and accuracy of all investments reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, as well as the related investment activity reflected in the statement of changes in net assets available for benefits and the schedule H, line 4j - schedule of reportable transactions for the year ended December 31, 2024.

NOTE 6 - TAX STATUS

The Plan obtained its latest determination letter dated September 28, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan provides for various investments. In general, such investments are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Plan contributions are determined and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is reasonably possible that changes in estimates and assumptions would be material to the financial statements.

NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments include mutual funds managed by entities related to the trustee. Transactions in such investments qualify as party-in-interest transactions and are exempt from the prohibited transaction rules.

NOTE 9 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 11, 2025, the date the financial statements were available to be issued.


