## Independent Auditors' Report

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Gresham Smith Employee Savings and Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the *Auditors' Responsibilities for the Audit of the Financial Statements* section of our report,

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management has determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

## Notes to the Financial Statements

December 31, 2024 and 2023

### (1) Description of the Plan

The following description of the Gresham Smith Employee Savings and Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### (a) General

The Plan is a defined contribution plan adopted to provide retirement benefits for employees of Gresham Smith (the "Plan Sponsor"). The Plan covers all eligible employees who elect to participate ("participants"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### (b) Contributions

Participants may voluntarily make qualified retirement contributions to the Plan which are deductible by the participants for federal income tax purposes under Section 401(k) of the Internal Revenue Code ("IRC") or may be made after-tax in the form of a Roth 401(k) contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. In order to participate in elective salary deferrals, employees must make a minimum contribution of 1% of compensation eligible for deferrals. Participant contributions are permitted up to 75% of compensation eligible for deferrals, subject to certain IRC limitations. Unless otherwise elected by the participant, a participant is automatically enrolled in a pre-tax salary deferral election of 3% of compensation eligible for deferrals upon employment. Participants who automatically enroll into the Plan on or after January 1, 2020, or make a manual deferral election less than 10% of compensation eligible for deferrals on or after January 1, 2020, are subject to an annual automatic increase of 1% of compensation eligible for deferrals, unless opted out. Automatic increases under this provision are effective annually. Automatic increases will not cause a participant's automatic deferral to exceed 10% of compensation eligible for deferrals.

The Plan provides that the Plan Sponsor may make discretionary matching contributions equal to a percentage as determined by the Plan Sponsor. The Plan Sponsor made matching contributions equal to 100% of the first 2% of compensation that the participant contributed in 2024 and 2023.

The Plan also provides that the Plan Sponsor may contribute each year a discretionary profit sharing contribution as authorized by the Plan Sponsor's management; however, an annual profit sharing contribution by the Plan Sponsor is not required. Participants must be employed on the last day of the year to receive an allocation of the profit sharing contribution. Profit sharing contributions were \$3,712,000 and \$3,514,000 in 2024 and 2023, respectively.

Discretionary matching contributions were \$2,464,957 and \$2,257,098 in 2024 and 2023, respectively. The Plan Sponsor's total contributions were \$6,176,957 and \$5,771,098 in 2024 and 2023, respectively.

(c) Participant accounts

Each participant's account is credited with the participant's and Plan Sponsor contributions, and allocations of investment earnings and is charged with his or her withdrawals and an allocation of investment losses and administrative expenses. Allocations are based on a per participant basis or participant contributions or account balances as defined in the plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants are allowed to direct their investments among the funds made available through the Plan.

(d) Vesting

Participants are immediately vested in their elective salary deferral plus actual earnings (losses) thereon. Vesting in the Plan Sponsor's matching and discretionary contributions plus actual earnings (losses) thereon are based on years of credited service defined as being credited with at least 1,000 hours of service during any plan year. Participants become 20% vested after 1 year of credited service and vest ratably in 20% increments until they become 100% vested after five years of credited service.

(e) Participant notes receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The participant notes receivable are secured by the balance in the participant's account and bear interest at fixed rates equal to the prime rate plus 1% at the time of the loan and ranged from 4.25% to 9.50% for loans outstanding during 2024. Loans may have a maturity term of more than five years if for the purchase of a primary residence. Principal and interest on the loans are collected ratably through payroll deductions.

(f) Payment of benefits

On termination of service due to death, permanent disability, or retirement, a participant may elect to receive a lump-sum payment equal to his or her entire account. For termination of service due to other reasons, a participant will be entitled to receive only the vested interest in his or her account as a lump-sum distribution.

(g) Forfeited accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their accounts. Such forfeitures may be reallocated to eligible participants as additional Plan Sponsor contributions or used to pay any administrative expenses of the Plan for the Plan year in which the forfeitures occur provided they are paid within a reasonable time after the end of the Plan year in which they occur. Forfeitures totaling \$47,995 and \$207,906 were used in 2024 and 2023, respectively, to reduce administrative expenses and reduce Plan Sponsor's contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$333,471 and \$157,190, respectively.

(h) Hardship withdrawals

The Plan permits distributions in the event of a hardship, as defined in the plan agreement. These distributions are taxable and subject to a tax penalty equal to 10% of the hardship distribution amount if the participant is younger than age 59½. Hardship withdrawals are limited to the participant's elective account balance. In-service withdrawals from 100% vested balances are also permitted for participants 59½ years of age.

(i) Administrative expenses

Certain administrative expenses are paid directly by the Plan. The Plan Sponsor pays for certain fees for professional services for the Plan's oversight and design. Investment expenses are paid by the Plan and are included in the investment income reported by the Plan.

(j) Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

(2) Summary of Significant Accounting Policies

(a) Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

**(b) Investment valuation and income recognition**

Investments are stated at fair value or contract value as reported by Empower Trust Company, LLC ("ETC") and Massachusetts Mutual Life Insurance Company ("Mass Mutual"), as of December 31, 2024 and 2023. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisor, ETC and Mass Mutual. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**(c) Participant notes receivable**

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document.

**(d) Payment of benefits**

Benefits are recorded when paid.

**(e) Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**(f) Events occurring after reporting date**

The Plan Sponsor has evaluated events and transactions that occurred between December 31, 2024 and August 25, 2025, which is the date that the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

### (3) Summary of Certified Information

Information related to investments and participant notes receivable disclosed in the accompanying financial statements and supplemental information, including investments at fair value, investments at contract value and participants notes receivable at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest on participant notes receivable for the years ended December 31, 2024 and 2023, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate for the respective periods by ETC and Mass Mutual.

### (4) Fair Value Measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

- (i) *Mutual funds*: Valued based on the funds' reported closing net asset values as of the last business day of the plan year. The funds are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**(5) Investment Contract with Insurance Company**

The Plan has entered into a Separate Account Guaranteed Interest Contract ("SAGIC") with an insurance company, MassMutual. The SAGIC is a market value separate account investment option with a general investment account guarantee that provides a stated rate of return and insulates participants' accounts from daily fluctuations in the market. Under the terms of the SAGIC group annuity contract, participants may direct permitted withdrawal and or transfer transactions of all or a portion of their balance in the SAGIC investment option at contract value. MassMutual considers the SAGIC contract to be fully benefit-responsive notwithstanding the market value events under the SAGIC contract that limit the ability of the plan to transact at contract value. Certain events limit the ability of the Plan to transact at contract value with the issuer.

As of December 31, 2024 and 2023, the contract value of the investment in the SAGIC was \$14,874,650 and \$15,354,859, respectively.

### (6) Income Tax Status

The Plan Sponsor adopted a non-standardized pre-approved plan effective January 1, 2023, which replaced its previous volume submitter profit sharing plan. The pre-approved plan has obtained its latest favorable opinion letter from the Internal Revenue Service ("IRS") dated November 14, 2022, which stated that the pre-approved plan was designed and in compliance with the applicable sections of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and is therefore, qualified and exempt from taxation.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (7) Related Party Transactions

The Plan invests in the MassMutual SAGIC insurance contract, which is managed by Empower and, therefore, these transactions qualify as party-in-interest transactions under ERISA. As described in Note 1, the Plan paid expenses of \$246,440 and \$257,912 in 2024 and 2023, respectively, to various service providers which also qualify as party-in-interest transactions. The Plan also holds participant notes receivable; these transaction also qualify as party-in-interest transactions.

### (8) Risks and Uncertainties

The Plan utilizes various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the fair values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
