Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Learning Network 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank, similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audits of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following brief description of Learning Network 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

General — The Plan is a defined contribution pension plan covering eligible employees of Learning Network LLC (the Company). Employees who are at least 18 years old and are not union employees, non-resident aliens, leased employees, independent contractors or interns are eligible to participate in the Plan beginning on the first day of the next Plan month following eligibility. Employees who are also employed on the last day of the Plan year or have at least 500 service hours during the Plan year are eligible to receive discretionary profit-sharing contributions made by the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions — A participant may elect to have a percentage of his/her compensation withheld by the Company and contributed to the Plan on his/her behalf as an elective contribution in lieu of receiving such amount as compensation. Such contributions may not exceed the limits established in the Internal Revenue Code (IRC). The Company makes safe harbor matching contributions to the Plan equal to 100% of participants' elective deferrals up to 5% of compensation. The Company may also make discretionary profit-sharing contributions.

Participants' Accounts — Each participant shall have one account and such account will be credited with the participant's contributions, an allocation of the Company's contributions and an allocation of the Plan's earnings and losses. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan's earnings or losses, excluding those related to participants' loans, are allocated to the participants' accounts based upon the proportion that each participant's account bears to the total participants' account balances related to that fund. Earnings resulting from loans to participants are credited to the respective participant's account.

Notes Receivable From Participants — Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) \$50,000 or (b) 50% of their vested account balance. A participant may only have one loan outstanding at any one time. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with prevailing rates. Principal and interest are paid pro rata through regular payroll deductions.

Vesting — Participants are 100% vested in the amounts they contribute, the Company's safe harbor contributions and earnings thereon.

Participants vest in the Company's discretionary profit-sharing contributions and earnings thereon, as follows:

Payment of Benefits — Upon separation of service, the Plan will distribute vested account balances not exceeding \$5,000 in a lump-sum as soon as administratively practicable. Upon separation of service, a participant with a vested account balance greater than \$5,000 may elect to receive a lump-sum payment or maintain the vested balance in the Plan. A participant may also elect to receive an account distribution if the participant has attained the age 59 ½ or incurred a hardship in accordance with the Plan provisions.

Forfeitures — Forfeitures may be used to reduce contributions by the Company or to pay reasonable plan expenses. The Plan held forfeited balances of \$26,733 as of December 31, 2024. The Plan held no forfeited balances as of December 31, 2023. Forfeitures used to reduce employer contributions were \$32,011 and \$23,974 during the years ended December 31, 2024 and 2023, respectively.

Administrative Expenses — Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation or depreciation in fair value of investments.

Plan Termination — Although it has not expressed any intent to do so, the Company has the right to terminate the Plan, subject to the provisions of ERISA. In the event of termination of the Plan, all participant accounts would become fully vested.

Plan Tax Status — The Plan is a non-standardized plan of FIS Business Systems LLC (FIS). FIS obtained its latest prototype determination letter dated June 30, 2020, stating that the non-standardized plan is qualified under Section 401 of the IRC. The Internal Revenue Service (IRS) stated that the non-standardized plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has concluded that as of December 31, 2024, the Plan has no material uncertain tax positions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting — The accompanying financial statements have been prepared on the accrual basis of accounting.

Valuation of Investments and Income Recognition — Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. The Plan administrator determines the Plan's valuation policies utilizing information provided by the asset custodian. See Note 3 for information on fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants — Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan payments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Benefit Payments — Benefits are recorded when paid.

Use of Estimates — Preparation of the financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent Events — The Company has evaluated subsequent events for recognition or disclosure through the date of the Independent Auditors' Report, which is the date the financial statements were available for issuance.

3. INVESTMENTS AND FAIR VALUE MEASUREMENTS

Generally accepted accounting principles require the Plan to use a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.

Level 2: Prices determined using significant other observable inputs. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Prices determined using significant unobservable inputs.

The investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered Investment Companies – Valued at the price of shares held by the Plan at year-end. The share prices are quoted in active markets.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

6. PARTY-IN-INTEREST TRANSACTIONS

Plan assets include registered investment companies of American Funds, a division of Capital Bank and Trust Company, the custodian of the assets, and therefore these transactions qualify as party-in-interest transactions. Notes receivable from participants are considered party-in-interest transactions.
