NOTE 1 DESCRIPTION OF PLAN

The following description of The Imagine Group 401(k) Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan was originally established effective January 1, 1990 and most recently amended effective September 1, 2023. The Plan is a defined contribution plan covering substantially all employees of The Imagine Group (the Company). Through August 31, 2023, employees were eligible to make salary reduction contributions and receive Company matching contributions on the first day of the month following or coincident with the completion of one month of service and attainment of age 18. Employees become eligible for discretionary profit sharing contributions upon completion of one year of service and attainment of age 18. Effective September 1, 2023, the service requirements were removed for all contribution types. Collective bargaining employees, nonresident aliens, household employees, reclassified employees, and leased employees are not eligible to participate in the Plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Under this arrangement and subject to Plan provisions, participants may elect to make salary reduction contributions to the Plan up to 75% of their eligible compensation. New participants are automatically enrolled at 3% of eligible compensation unless otherwise elected by the participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

The Company may elect to make a discretionary profit sharing contribution to the Plan. There were no Company profit sharing contributions for the years ended December 31, 2024 and 2023.

The Company may elect to make a matching contribution to the Plan participants. The Company matched 50% of the first 5% of eligible compensation a participant contributed to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contributions, Plan earnings, and forfeitures of terminated participants' nonvested accounts, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participant accounts are valued on a daily basis.

Vesting

Participants are fully vested in all contributions.

Notes Receivable from Participants

The Plan allows participants to borrow from their vested account balance a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account. All notes provide for repayment within a period of time not exceeding five years and bear interest at rates established from time to time by an Advisory Committee. Repayments are made ratably through payroll deductions.

Payment of Benefits

Upon termination, retirement, death, or disability, a participant whose account balance exceeds \$1,000 may elect to receive either a lump sum amount or installment payments over a period of time not exceeding the participant's life expectancy or joint life expectancy of the participant and a designated beneficiary. If the participant's balance is \$5,000 or less, it will automatically be distributed without the participant's consent. The Plan allows for hardship withdrawals under certain circumstances with spousal consent. The Plan also allows for withdrawals of the participant's account upon attainment of age 59½.

Tax Status

The Company adopted a prototype non-standardized profit sharing plan with a deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Forfeited Accounts

Forfeitures of nonvested balances are used to reduce Company matching contributions to the Plan. Forfeitures remaining after reducing Company contributions may be used to reduce Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts were \$-0- and \$-0-, respectively. There were \$110,003 and \$26,991 of forfeitures used to reduce Company contributions during the years ended December 31, 2024 and 2023, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisers. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The Company pays certain administrative expenses on behalf of the Plan.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 8, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Delaware Charter Guarantee & Trust Company dba: Principal Trust Company, a qualified institution, has supplied the Plan administrator with a certification as to the completeness and accuracy of all notes receivable from participants and investment information, presented in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants account would not be impacted as all contribution sources vest immediately.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
