Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the **Techno-Coat, Inc. 401(k) Salary Reduction Plan and Trust** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.



December 31, 2024 and 2023

Note 1 – Description of the Plan

The following description of the Techno-Coat, Inc. 401(k) Salary Reduction Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established January 1, 1988, restated effective January 1, 2022 and restated again effective July 1, 2023. The Plan is sponsored by Techno-Coat, Inc. (the “Company”). The Plan covers substantially all employees of the Company who are full-time employees, as defined by the Plan, have completed 30 days of service, and are at least 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may elect to contribute up to the maximum amount allowed by law. Participants may designate these deferrals to be pre-tax or Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an auto-enrollment provision whereby all new eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have deferral rates set at 4% of eligible compensation and are subject to an annual increase provision of the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and are subject to an annual automatic increase provision of the plan. Effective January 1, 2023, the Plan adopted a non-elective safe harbor contribution equal to 4% of each eligible participant's compensation. Effective January 1, 2024, the Plan elected to update the non-elective safe harbor contribution to a safe harbor matching contribution equal to 100% of the first 4% of eligible compensation that a participant contributes to the Plan. The Company may make a discretionary matching contribution based on a percentage of eligible compensation that a participant contributes to the Plan. The Company may also make discretionary profit-sharing contributions, as determined by the Company. All contributions are participant directed and are directed into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company contributions, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

On termination of service due to death, disability, separation, or retirement, a participant (or a participant's beneficiary in the event of death) may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account, annual installments, or partial withdrawals, provided the minimum withdrawal is \$1,000. In-service distributions, as defined by the Plan, are allowed from all types of contributions. Hardship withdrawals, as defined by the Plan, are allowed from employee pre-tax or Roth Contributions.

Vesting

Participants are vested immediately in their contributions and safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary contributions is based on continuous service. The Company's discretionary contributions begin to vest after 2 years of service at a rate of 20% per year and are fully vested after 6 years of service. Participant accounts become fully vested in the event of death, total disability, early retirement and normal retirement while still employed.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to maximum equal to the lesser of \$50,000 or 50% of their vested account balance in the event of certain financial conditions. The loans are secured by the balance in the participant's account and bear a fixed rate of interest based on the prime rate at the date of each note. Principal and interest are repaid ratably through payroll deductions over a period of five years or less, unless for the purchase of a principal residence, in which case the loan terms may exceed five years.

Forfeited Accounts

These accounts may be used to reduce employer contributions, pay administrative expenses or be added to the Company discretionary contributions and allocated in the same manner. For the years ended December 31, 2024 and 2023, approximately \$5,200 and \$6,300 of forfeited accounts were used to pay administrative expenses, respectively. For the years ended December 31, 2024 and 2023, approximately \$900 and \$11,300 of forfeited accounts were used to reduce employer contributions, respectively. At December 31, 2024 and 2023, the balance in forfeited non-vested accounts totaled approximately \$26,800 and \$5,100, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 2 – Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of the Plan, of notes receivable from participants, and of benefit payments are charged directly to the participant's account and are included in administrative expenses. Total administrative expenses paid by the Plan for the years ended December 31, 2024 and 2023 were approximately \$50,000 and \$46,800, respectively. Investment related expenses are included in net appreciation of fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a deemed distribution is recorded.

Payments of Benefits

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued. Effective February 2025, the plan assets were transferred from Greenleaf Trust, the former trustee, to ADP Retirement Trust Services, the current trustee. Participant eligibility and vesting were unaffected by this transfer of assets. Management has determined that no additional disclosure in these financial statements was necessary.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, other inputs that are observable, or can be corroborated by observable market data.

Level 3 – Inputs to the valuation methodology are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

Note 5 – Related Party and Party-In-Interest Transactions

For the years ended December 31, 2024 and 2023, the Plan made a direct payment to Greenleaf Trust of approximately \$50,000 and \$46,800, respectively. Greenleaf Trust is the trustee, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for additional investment management services are included in net appreciation in fair value of the investment. The Company pays directly any other fees related to the Plan's operations. Notes receivable from participants also qualify as party-in-interest transactions.

Note 6 – Income Tax Status

The IRS has determined and informed Greenleaf Trust, the trustee of the Plan, by a letter dated June 30, 2020 that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan (the prototype plan upon which the Plan is based) is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been restated since receiving the opinion letter, the Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirement of the IRS and, therefore, believes the Plan is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 – Prohibited Transactions

In 2020, the Company failed to remit participant contributions of \$19,124 to the trustee in a timely manner. The Company remitted \$6,417 to the Plan in January 2020, \$6,526 in July 2020 and \$6,181 in September 2020. In 2021, the Company failed to remit participant contributions of \$29,871 to the trustee in a timely manner. The Company remitted \$8,184 to the Plan in August 2021, \$6,480 in September 2021, \$6,284 in October 2021 and \$8,923 in November 2021. These transactions constitute prohibited transactions as defined by ERISA.

The Company applied to the Voluntary Fiduciary Correction Program ("VFCP") established by the Employee Benefits Security Administration ("EBSA"). During May 2024, the Company received correspondence from the Department of Labor, that the actions taken as described in the Company's VFCP filing, were consistent with the requirements of the VFCP and the EBSA will take no civil enforcement action against the Company for these prohibited transactions.
