NOTE 1 - Description of the Plan

The following description of the Hi Pro, Inc. Health and Welfare Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan's provisions.

The Plan and Trust were established April 1, 2022 to provide health and other benefits to eligible participants. The sponsoring employer, Hi Pro, Inc. has agreed in writing to be bound by the terms and conditions of the Trust Agreement establishing the Plan. The Plan is an employee benefit plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan provides medical, dental, vision, prescription drug coverage, and death and supplemental accident benefits for eligible participants and their dependents. The Plan provides most of these benefits through contracts with third party insurance companies. The Plan also provides Health Reimbursement Arrangement (HRA) benefits. The HRA benefit is self-funded and allows employees to be reimbursed for certain out of pocket health benefits incurred by participants.

Employees are eligible to participant in the Plan on the first day of the month following one month of continuous employment under a fringe contract. Participants will receive coverage for any month in which they remain eligible for the Plan and for which the Plan management makes contributions to the Plan on their behalf. The participants' coverage will end at the midnight on the last day of the month in which eligibility cease.

The Plan shall remain in existence from year-to-year unless written termination notice is given by the Plan Sponsor or Plan Administrator to the other at least 60 days prior to the anniversary date of effective coverage under this Plan.

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to employees, to discontinue its contributions at any time, and terminate the Plan subject to the provisions set forth in ERISA.

NOTE 2 - Summary of Significant Accounting Policies

Accounting Method

The accounts of the Plan are maintained on an accrual basis of accounting for financial reporting purposes.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Employer Contributions

Employer contributions are recognized as income in the month the employees worked.

Contributions Receivable

Employer contributions due but not paid at year-end are recorded as contributions receivable. An allowance for uncollectible accounts is considered unnecessary and is not provided.

Benefits

Benefits expense is recorded when paid. Hours worked through December provide participants with benefits eligibility through December. The participants' coverage will end at midnight on the last day of the month in which eligibility ceases.

Insurance Premiums Payable

Insurance premiums payable is based upon the actual premiums due for December and prior coverage, but paid by the Plan after December 31.

Subsequent Events

In preparing the financial statements as of December 31, 2024, management considered the impact of subsequent events occurring through September 18, 2025 the date the financial statements were available to be issued, for potential recognition or disclosure in these financial statements.

NOTE 3 - Income Taxes

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from California or federal income taxes, and is currently subject to income tax on its net investment income. The Trustees believe that the Trust does not have any net taxable income for the tax years ended December 31, 2024 and 2023, therefore, no tax liability is reflected in these financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the Internal revenue Service and California Franchise Tax Board. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audit for any tax periods in progress.

NOTE 4 - Health Reimbursement Arrangement (HRA) Benefits

The Plan provides health reimbursement arrangement (HRA) benefits to eligible participants. A participant's account balance is funded by employer contributions and allows employees to be reimbursed for eligible out of pocket health benefits incurred by participants. Included in the accompanying statement of net assets are amounts available to provide HRA benefits as of December 31, 2024 and 2023 totaling \$35,959 and \$23,714, respectively.

NOTE 5 - Party-In-Interest Transactions

FCE Benefit Administrators, Inc. receives commissions and reimbursement of administrative fees from the Plan's insurance carriers of approximately \$54,187 and \$41,906 for December 31, 2024 and 2023, respectively. The insurance commissions and fees are paid by the insurance company and are not an expense of the Plan.

NOTE 6 - Retirement Plan Contribution

Part of employer's contributions, after the cost of benefits, are forwarded to the company's retirement plan. These contributions were \$347,510 and \$279,221 for the years ending December, 31, 2024 and 2023, respectively.
