NOTE 1 - Description of the Plan

The following description of Adams and Associates, Inc. Health & Welfare Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan's provisions.

The Plan and Trust were established January 1st, 2023 to provide health and other benefits to eligible participants. The sponsoring employer, Adams and Associates, Inc. has agreed in writing to be bound by the terms and conditions of the Trust Agreement establishing the Plan. The Plan is an employee benefit plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan provides medical, dental, vision, prescription drug coverage, life and accidental death and dismemberment, short-term disability and supplemental benefits for eligible participants and their dependents. The Plan provides these benefits on a self-funded basis and through contracts with third party insurance companies. The Plan carries a stop-loss insurance policy, which covers both specific and aggregate claims in excess of the deductibles as specified in the contract.

Employees are eligible to participant in the Plan on the first day of the month following one month of continuous employment. Participants will receive coverage for any month in which they remain eligible for the Plan and for which the Plan management makes contributions to the Plan on their behalf.

The Plan shall remain in existence from year-to-year unless written termination notice is given by the Plan Sponsor or Plan Administrator to the other at least 60 days prior to the anniversary date of effective coverage under this Plan.

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to employees, to discontinue its contributions at any time, and terminate the Plan subject to the provisions set forth in ERISA.

NOTE 2 - Summary of Significant Accounting Policies

Accounting Method

The accounts of the Plan are maintained on an accrual basis of accounting for financial reporting purposes.

NOTE 2 - Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions Receivable

Employer contributions due but not paid at year-end are recorded as contributions receivable. An allowance for uncollectible accounts is considered unnecessary and is not provided.

Employer Contributions

Employer contributions are recognized as income in the month the employees worked.

Benefits

Benefits expense is recorded when paid. Hours worked through December provide participants with benefits eligibility through December. The participants' coverage will end at midnight on the last day of the month in which eligibility ceases.

Benefit Claims Payable

The obligation for benefit claims payable is an estimate for self-funded benefits incurred on or prior to December 31, but paid after December 31. The estimate was calculated based on a review of actual claims paid subsequent to year-end, with incurred and received dates of December 31, and prior.

Benefit Claims Incurred, But Not Reported

The obligation for benefit claims, incurred but not reported is an estimate for self-funded benefits incurred on or prior to December 31, but reported to and paid by the Plan after December 31. The estimate was calculated using available claims experience data and projected future claims.

Subsequent Events

In preparing the financial statements as of December 31, 2024, management considered the impact of subsequent events occurring through September 16, 2025 the date the financial statements were available to be issued, for potential recognition or disclosure in these financial statements.

NOTE 3 - Excess Loss Indemnity Policy

The Plan has entered into administrative only (ASO) with excess loss arrangements with Anthem Blue Cross Blue Shield in an effort to limit its exposure for self-insured benefits and to process the claims for the annual policy ending June 30, 2025 and 2024. The policy contains two excess loss provisions. The first of which applies to individual participant claims, whereby when the claims paid on behalf of an eligible participant or dependent exceeds the \$250,000 Specific Stop Loss Limit and the \$150,000 Aggregating Specific Stop Loss Limit, during a policy year, respectively, the insurance carrier will reimburse the plan for 100% of the excess. The second provision involves aggregate plan claims, whereby when the total aggregate claims paid on behalf of all eligible participants or dependents exceed the Aggregate Stop Loss Limit based on the number of eligible participants and rate factors (“aggregate factor”), the insurance carrier will reimburse the Plan 125% of the excess up to a maximum aggregate amount of \$1,000,000, less the amount reimbursed for individuals under the specific individual policy noted above. During the years ended December 31, 2024 and 2023, there was no reimbursement.

Anthem Blue Cross Blue Shield pays claims directly to or on behalf of participants which are funded by the Plan based on the claim billing and is responsible for funding claims incurred in excess of the Aggregate Stop Loss Limit. Despite the Plan’s utilization of third-party claims processor, ultimate responsibility of payments to providers and participants is retained by the Plan.

NOTE 4 - Income Taxes

The Trust established under the Plan to hold the Plan's assets has not applied for exemption from California or federal income taxes, and is currently subject to income tax on its net investment income. The Trustee believes that the Trust does not have any net taxable income for the tax years ended December 31, 2024 and 2023, therefore, no tax liability is reflected in these financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examinations by the Internal Revenue Service and California Franchise Tax Board. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
