## **INDEPENDENT AUDITOR'S REPORT**

To the Shareholders of Essential Services Intermediate Holding Corporation dba TurnPoint Services

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of TurnPoint 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). ### NOTES TO FINANCIAL STATEMENTS

#### Note 1. Plan Description

The following description of the TurnPoint 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution 401(k) plan sponsored by Essential Services Intermediate Holding Corporation dba TurnPoint Services (TurnPoint Services), covering certain full-time employees of Dauenhauer Acquisition Corp. (Dauenhauer), Dauenhauer Plumbing Construction, Inc., Greenwell Acquisition Corporation, Maeser Services Corporation, Fayette Heating and Air Conditioning, Inc., Elmore Service Corporation, Hunter Super Techs Service Corporation, Aztec Plumbing, Inc., Corley Service Corporation, Ellington Service Corporation, Meetze Plumbing, Inc., Cool Air Mechanical, LLC, Service Success, LLC, Home Comfort Experts of Mishawaka, Inc., Stone Service Corporation, Four Seasons Service Corporation, Apollo Heating & Air Conditioning Inc., A-ABC Appliance & Heating, LLC, Accutemp Service Corporation, Blake Brothers Service Corporation, Cassell Brothers Heating & Cooling, LLC, Chapman Heating & Air Conditioning, Inc., Gaithersburg Air Conditioning & Heating, Inc., Getzschman Heating, LLC, Roth-Zachry Heating, Inc., Schaal Heating & Cooling, Inc., Scott R Hale Plumbing, Inc., Sun Electric Works, LLC, T Webber Plumbing, LLC, T Webber Service Corporation, Webb Heating & Air Conditioning Company, Inc., Walter Anderson Plumbing, LLC, Campbell & Company Service Corporation, All Clear Plumbing & Heating Co, LLC, Rooter Ranger, LLC, Tiger Services, LLC, Limric Service Corporation, Cool Air Mechanical, LLC, Cool Bear Services, LLC, Bell Brothers Heating and Air Conditioning, LLC, Gulf Shore Cooling, LLC, Black Hills, LLC, Gilmore Services, LLC, Anytime Plumbing, LLC, Arctic Air Conditioning, Arctic Mechanical, LLC, Arctic Electric, LLC, Home Power Systems, LLC, Comfort By Design Inc., Wolfgangs Cooling & Heating Corporation, Cool Touch Operating LLC, Dutch Enterprises LLC, ECK Services, G&G Heating & Air Conditioning LLC, Golden Home Services LLC, John Betlem Heating & Cooling Inc, Mercurio's Natural Gas Service, LLC, Mountain Investments LLC, Jafco Company, LLC, Love Plumbing, Air, and Electrical, LLC, Stutzman Services, Inc., and Wolf HVAC Holdings, LLC (collectively the Company).

Individuals participating in the Plan must have two months of service and be age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

## NOTES TO FINANCIAL STATEMENTS

### Note 1. Plan Description (Continued)

#### Contributions

Each year, participants may elect to contribute up to the maximum legal limit, as determined by the Internal Revenue Service (IRS), of pre-tax annual compensation as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching and discretionary non-elective contributions. The Company elected to make discretionary matching contributions of \$6,402,228 for the year ended December 31, 2024. Contributions are subject to certain IRS limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's discretionary matching and discretionary non-elective contributions, and (b) Plan earnings, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$48,305 and \$26,512, respectively. These accounts will be used first to pay administrative expenses, reduce future Company discretionary matching contributions and then to reduce future Company discretionary non-elective contributions as decided by the administrator of the Plan.

#### Vesting

Participants are immediately vested in both their contributions and actual earnings thereon. Vesting in the Company's discretionary matching and discretionary non-elective contribution portion of their accounts and actual earnings thereon was based on years of continuous service. Vesting under the Plan is based upon the elapsed time method and a year of service is obtained after a whole year of service.

A participant is 100% vested in employer matching contributions and earnings after three years of credited service as described in the following schedule:

### Note 1. Plan Description (Continued)

#### Vesting (continued)

Discretionary employer non-elective contributions are subject to its own vesting schedule.

Upon termination, the amount of a participant's account not vested is forfeited. Participants who terminate service due to disability or death become 100% vested in their account balance.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may not have more than two loans outstanding at any time. Loan transactions are treated as a transfer to (from) the investment fund from (to) the participant loans fund. Loan terms range from 1-5 years, unless used for the purpose of purchasing a participant's principal residence. The loans are secured by a maximum of 50% of the vested balance in the participant's account and bear interest at prevailing rates and are fixed at the date of origination. Principal and interest is paid through payroll deductions each pay period. Loans will become payable in full if a participant is terminated.

#### Payment of Benefits

On termination of service due to disability, the value of the participant's vested interest in his or her account is payable in the form of a lump-sum amount as soon as feasible after separation of service. On termination of service due to retirement, death or any other reason, the value of the participant's vested interest is payable by a lump-sum amount if the vested account is \$1,000 or less. If the vested amount is less than \$5,000, the plan administrator may direct the trustee to distribute the account to an IRA or annuity for the participant's benefit. If the vested amount is greater than \$5,000, the participant must provide the Plan with an affirmative distribution election. In-service distributions are permitted after age 59 1/2.

### Note 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

## NOTES TO FINANCIAL STATEMENTS

### Note 2. Summary of Significant Accounting Policies (Continued)

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees may be deducted from the proceeds of the loan or charged directly to the borrowing participant's account and included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Payment of Benefits

Benefit payments are recorded when paid. Under the rules for preparation of Form 5500, the Plan's Form 5500 will reflect an accrual for the amount to be paid to participants who withdrew from the Plan prior to year-end, and who had requested a distribution which was approved but not yet paid at year-end, if any. There were no unpaid distributions as of December 31, 2024 and 2023.

#### Administrative Costs

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The Company does not intend to request reimbursement from the Plan for these costs. Fees related to the administration of certain withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### Subsequent Events

Management has evaluated subsequent events through July 29, 2025, the date the financial statements were available to be issued.

### Note 3. Information Prepared and Certified by Trustee

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, and dividends and interest for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

### Note 4. Fair Value Measurements

U.S. GAAP provides a framework for fair value measurements. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The methodology for measuring fair value specifies a three-tier hierarchy of valuation techniques based upon whether the inputs to those valuation techniques are based on quoted prices of identical assets or liabilities (Level 1), significant other observable inputs (Level 2), or significant other unobservable inputs that reflect a plan's own assumptions of market participant valuation (Level 3).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

All financial assets and liabilities as of December 31, 2024 and 2023 are measured at fair value on a recurring basis (at least annually) into the most appropriate level within the fair value hierarchy based on the inputs used to determine the fair value at the measurement date.

Interest-bearing cash – Interest-bearing cash is valued at market value of cash held by the Plan at year end.

Mutual funds – Shares of publicly traded mutual funds are measured at Level 1 since they are valued at net asset value (NAV) which is the published market price in an active market.

## NOTES TO FINANCIAL STATEMENTS

### Note 4. Fair Value Measurements (Continued)

Common/collective trusts – Trust accounts are valued at NAV of units held by the Plan at year end. The NAV is determined by the custodian of the fund and is based upon the fair value of the underlying assets held by the fund. NAV is used as a practical expedient to estimate fair value. The common/collective trusts have no unfunded commitments and can be redeemed daily, with no redemption notice period, without specific terms or conditions at the underlying investments' NAV.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## NOTES TO FINANCIAL STATEMENTS

### Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

### Note 6. Tax Status

The Plan is based on a pre-approved plan which has received a favorable opinion letter dated June 30, 2020 from the IRS stating that the Plan is designed to qualify as being exempt from federal income taxes. The plan administrator has not separately applied for a determination letter from the IRS. However, the plan administrator and the Plan's legal counsel believe the Plan was designed and is currently being operated as a tax-exempt plan in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

### Note 7. Related Party Transactions and Party-In-Interest Transactions

Fidelity Management Trust Company is the trustee and Fidelity Workplace Services LLC is the recordkeeper of the Plan. Robert W. Baird & Co., Inc. and Strategic Advisors, Inc. provide investment advisory services to the Plan. Jones, Nale and Mattingly PLC is the independent auditor of the Plan. Each of these service providers are a party-in-interest to the Plan. Fees paid by the Plan to these service providers totaled \$660,479 for the year ended December 31, 2024. Fees paid by the Company for administrative services are excluded from these financial statements.

### Note 8. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note 9. Plan Amendments

The Securing a Strong Retirement Act (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2023 and later. Written amendments to the Plan to reflect these operational changes have been and will be adopted in accordance with applicable law and IRS guidance.

## NOTES TO FINANCIAL STATEMENTS

### Note 10. Prohibited Transaction

During the year ended December 31, 2023, the Company failed to remit certain employee contributions totaling \$67,702 to the Plan within the period described by the Department of Labor. During 2024, the Company remitted lost earnings to the Plan to compensate affected participants.
