### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lighthouse Masonry, Inc. ## Notes to Financial Statements

### December 31, 2024 and 2023

#### 1. Description of Plan

The following description of Lighthouse Masonry, Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Plan was established for the purpose of providing eligible employees of Lighthouse Masonry, Inc. (the "Company") and their beneficiaries, funds for retirement. Employees of the Company who provide services under federal contracts subject to the Davis-Bacon Act or any other federal, state, or municipal prevailing wage law are eligible to participate in the Plan immediately upon employment on prevailing wage contracts and receive employer Davis-Bacon Act contributions. Other employees who have completed one year of service (1,000 hours) and are 18 (previously 21) or older are eligible to participate in the Plan. The Plan administrator is responsible for the oversight of the Plan.

The Plan was amended, effective February 29, 2024 to change the age requirement from 21 to 18.

##### Contributions

The Plan is funded by employer contributions only. The Company makes contributions to the Plan for participants subject to prevailing wage laws at the rates stipulated by the specific federal, state, or municipal prevailing wage contracts. Participants may also contribute amounts representing distributions from other qualified plans.

The Company may elect to make discretionary nonelective contributions to the Plan. These contributions are allocated to eligible participants based on the method elected by the Company. Participants must be employed on the last day of the Plan year to receive discretionary nonelective employer contributions. During the year ended December 31, 2024, the Company elected to make a discretionary nonelective contribution of \$61,955 to the Plan.

##### Participant Accounts

Each participant's account is credited with the prevailing wages contributions, allocations of the Company's discretionary nonelective contributions, of the Plan's earnings and administrative expenses that are paid by the Plan. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Investment Options

Participants direct the investment of contributions into various investment options offered by the Plan. The Plan currently offers pooled separate accounts and guaranteed interest accounts as investment options for participants. Plan management determines funds to be included in the Plan's investment portfolio and monitors its investment performance.

##### Vesting

Participants are vested immediately in prevailing wage contributions, plus actual earnings thereon. Vesting in the Company's discretionary nonelective contributions, plus earnings thereon is based on years of credited service in accordance with the following schedule. A participant is required to provide 1,000 hours of service during the Plan year to be credited with the year of vesting.

The participants vest in the Company's discretionary nonelective contributions as follows:

## **Notes to Financial Statements**

### **December 31, 2024 and 2023**

#### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes must be repaid over a period not to exceed five years unless the loan proceeds are used for the purchase of a primary residence. Participants may have one loan outstanding at any time. The notes are secured by the balances in the participants' accounts. The loan interest rates, determined monthly, are set at 2% above the prime rate, as defined. Principal and interest are paid ratably through weekly payroll deductions. Participant notes are recorded at their unpaid principal balance plus accrued interest.

#### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the Plan document. For termination of service due to termination, attainment of age 59 1/2 or early retirement upon attainment of age 55, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In addition, the Plan provides for participant withdrawals in the event of serious financial hardship. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed to the participant in the form of a \$5,000 distribution without the participant's consent. The vested account balance will be rolled over to an individual retirement account established by the Plan administrator.

#### **Forfeited Accounts**

Forfeitures are created if the participants are terminated or retire prior to becoming fully vested in discretionary nonelective profit sharing contributions. Forfeitures can be used to reduce prevailing wage or nonelective profit sharing contributions or to pay for Plan expenses. During 2024, forfeitures were not used to reduce the prevailing wage or nonelective profit-sharing contributions or pay for Plan expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,933 and \$2,676, respectively.

## **2. Summary of Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value or net asset value ("NAV"), which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment adviser and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant does not make note repayments and the Plan administrator considers the participant note to be in default, the note balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain administrative expenses incurred in operations of the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments and are not readily determinable.

#### Subsequent Events

The Plan's management evaluated events that occurred after December 31, 2024 through September 12, 2025, the date the financial statements were available to be issued. Based on that evaluation, management has determined that no subsequent events have occurred that require adjustment to or disclosure in the financial statements.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

*Level 1* - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of December 31, 2024 and 2023.

*Pooled Separate Account:* Units held in pooled accounts are valued at NAV of the underlying assets, which is based on the quoted prices for similar assets in active markets.

*Guaranteed Interest Accounts:* The group annuity contract is valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **5. Party-in-Interest Transactions**

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. For the year ended December 31, 2024, the Plan's transactions with parties-in-interest were as follows:

##### **Investments**

Certain Plan investments are managed by the Plan's custodian, Voya Retirement Insurance and Annuity Company. A portion of the income or loss of the Plan is derived from these investments. Fees paid by the Plan to Voya Retirement Insurance and Annuity Company for certain investment management fees were deducted from the net asset values of the funds held by the Plan.

##### **Expenses**

All administrative expenses are to be paid by the Plan unless paid by the plan sponsor. Also, certain employees of the Company, who are also plan participants, perform administrative services on behalf of the Plan at no cost to the Plan. The plan sponsor paid substantially all costs related to the administration of the Plan in 2024. Fees related to the administration of notes receivables for participants or to process distributions are charged directly to the participant accounts and are included in administrative expenses.

##### **Notes Receivable From Participants**

Notes receivable from participants are also party-in-interest transactions.

These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

#### **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their discretionary nonelective profit sharing contributions.

#### **7. Tax Status**

The Plan adopted a pre-approved plan offered by CCH Incorporated. The pre-approved plan received an Internal Revenue Service ("IRS") Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. As of December 31, 2024 and 2023, one investment represented a concentration greater than 10% of the Plan's net assets available for benefits.
