Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 And 2023**

### **1. Description Of The Plan**

The following description of the Basler Electric Highland Manufacturing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan sponsored by Basler Electric Company (the Company) for the benefit of its factory employees covered under a collective bargaining agreement and who are age 18 and older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Fidelity Management Trust Company (the Trustee) is the trustee and custodian of the Plan.

#### **Eligibility**

Employees become eligible to make salary deferral contributions after the employee has completed 90 days of service and has attained the age of 18. The Plan provides for enrollment to eligible employees on the first day of each Plan year and the first day of the fourth, seventh, and tenth months of each Plan year.

#### **Contributions**

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 60% of their eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company makes nonelective contributions based on a fixed formula. Effective June 27, 2020, employees covered by the collective bargaining agreement receive a 401(k) contribution equal to \$0.64 per hour in year one, \$0.65 in year two, \$0.66 in year three and \$0.67 in year four. Effective July 1, 2024, the 401(k) contribution equaled \$0.68 per hour in year one and \$0.69 in year two through the expiration of the contract in June 2030. Contributions are subject to certain limitations.

#### **Participant Investment Account Options**

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

### Notes To Financial Statements *(Continued)*

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, Plan earnings and administrative expenses. Allocations are based on the investment election percentages selected by each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

#### **Notes Receivable From Participants**

Participants may borrow from their accounts a minimum of \$1,000 or up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balance in the participant's account and bear interest at a rate determined by the Plan Administrator based on prevailing interest rates. Principal and interest are paid ratably through payroll deductions.

#### **Vesting**

Participants are immediately vested in their voluntary and Company nonelective contributions plus actual earnings thereon.

#### **Payment Of Benefits**

Upon termination of employment, retirement, disability, or death, a participant may elect to receive either a lump-sum amount equal to the value of the vested interest in their account or equal installments over a period of time, subject to certain minimum requirements of the Plan.

#### **Administrative Expenses**

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

## **2. Summary Of Significant Accounting Policies**

#### **Basis Of Accounting**

The accompanying statement of net assets available for benefits and related statement of changes in net assets available for benefits have been prepared on a modified cash basis of accounting whereby all activity is recorded on a cash basis except for changes in fair value of investments and investment income. Accordingly, the accompanying financial statements are not intended to present net assets available for benefits and changes in net assets available for benefits in accordance with accounting principles generally accepted in the United States of America.

### Notes To Financial Statements (*Continued*)

As permitted under the Department of Labor's Rules and Regulations, the Plan prepares its financial statements on the modified cash basis of accounting. Accordingly, the accompanying financial statements do not include certain assets, liabilities, revenues, and expenses and are not intended to be presented in conformity with accounting principles generally accepted in the United States of America.

#### **Estimates And Assumptions**

The preparation of financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

#### **Investment Valuation And Income Recognition**

The Plan's investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

#### **Contributions Receivable And Credit Loss Policy**

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions, and when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

#### **Payment Of Benefits**

Benefit payments are recorded upon distribution.

#### **Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

### **3. Certified Investment Information**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants as of December 31, 2024 and 2023, and net change in fair value of investments, interest and dividends for the years then ended, was obtained or derived from the Plan Administrator and certified as complete and accurate by Fidelity Management Trust Company. This information has not been audited by the Plan's independent auditor.

### **4. Fair Value Measurements**

The Plan follows accounting rules that establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

#### **Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Notes To Financial Statements *(Continued)*

#### **Collective Trust Fund**

Valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. There are no unfunded commitments or redemption restrictions.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the valuation methodologies used at December 31, 2024 or 2023.

### **5. Parties In Interest Transactions**

Party in interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, a person who owns 50% or more of such an employer or relatives of such persons.

The Plan invests in certain mutual funds and a collective trust fund managed by the Trustee. Fees incurred by the Plan for the investment management services are included in net change in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. Also, certain participants have outstanding loans as of December 31, 2024 and 2023.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their accounts.

### **7. Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### **8. Income Tax Status**

The Plan operates under a non-standardized adoption agreement in connection with a pre-approved 401(k) profit-sharing plan and trust sponsored by FMR LLC. This pre-approved plan document has been filed with the appropriate agency. The pre-approved plan has obtained an opinion letter dated June 30, 2020, from the Internal Revenue Service stating that the pre-approved plan document was qualified under Section 401 of the Internal Revenue Code. The Plan has been amended since the pre-approved plan document received the opinion letter. However, the Plan Administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan's federal tax returns for the tax years 2021 and later remain subject to examination by taxing authorities.
