Notes to the Financial Statements

Note 1 - Plan Description

The following description of Ready Foods, Inc. Employee Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a contributory defined contribution plan covering all eligible employees of Ready Foods, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Company is the plan administrator and is responsible for oversight of the Plan. Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (collectively "Principal") serve as the custodian and provides recordkeeping and third party administration services. Management of the Company determines the appropriateness of the Plan's investment offerings and monitors investment performance utilizing information provided by the custodian of the Plan.

On December 29, 2022, the Securing a Strong Retirement Act of 2022 (SECURE 2.0 Act) was signed into law. The SECURE 2.0 Act introduces numerous provisions intended to improve retirement savings opportunities and administration for retirement plans. There are both optional and required provisions as a result of the Act which become effective at various dates through 2028. As of December 31, 2024, the Plan Sponsor has evaluated the provisions of the SECURE 2.0 Act and has adopted or intends to adopt certain provisions as outlined below:

Required Minimum Distributions - Effective January 1, 2023, the Plan adopted the required minimum distribution age of 73.

Mandatory Distribution Threshold - Effective January 1, 2024, the Plan increased the mandatory distribution threshold to \$7,000.

Catch-Up Contributions - Effective January 1, 2025, participants aged 60 to 63 may be eligible to make higher catch-up contributions.

The Plan Sponsor is working with its Plan partners and advisors to ensure timely compliance with relevant SECURE 2.0 Act provisions as they become effective. The impact on the Plan's financial position, changes in net assets, and plan operations is not expected to be material as of the date of this report.

Eligibility

The Plan covers all employees who are 21 years of age and older and have completed one year of service (defined as 1,000 hours of service within a Plan year). Plan entry dates are first day of each calendar quarter.

Note 1 - Plan Description (continued)

Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined by the Plan. Deferral contributions shall not exceed certain limits set forth by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are also eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Company makes qualified nonelective safe harbor contributions equal to 3% of participant compensation and may also make discretionary matching contributions. For the year ended December 31, 2024, the Company made matching contributions equal to 50% of the participant contributions up to 2% of participant compensation.

The Plan has adopted auto-enrollment and deferral escalation provisions. Employees are automatically enrolled in the Plan upon meeting eligibility requirements at a rate of 6% unless the participant elects out of participating in the Plan. Additionally, unless otherwise elected, the deferral rate automatically escalates 1% each year on April 1 until the participant's contribution is 10%.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Company's qualified nonelective safe harbor contribution, discretionary matching contribution, and Plan earnings (losses) and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings (losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of their account to any of the investment options available under the Plan.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers pooled separate accounts, mutual funds, and a collective trust fund. Participants may change their investment options at any time.

Vesting

Participants are always 100% vested in their contributions, Company qualified nonelective and matching contributions, and earnings thereon.

Note 1 - Plan Description (continued)

Payment of Benefits

Upon termination of service due to death, disability, retirement, or other reasons a participant will receive a lump-sum amount equal to the value of the participant's account. The Plan also allows for in-service distributions upon attaining the age 59 1/2. Hardship withdrawals are not permitted. Benefits will be paid as soon as administratively feasible following the date on which a distribution is requested or otherwise payable.

Note 2 - Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefits are recorded when paid.

Note 2 - Significant Accounting Policies

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are also included in administrative expenses.

Subsequent Events

Subsequent events have been evaluated through September 17, 2025, which is the date the financial statements were available to be issued. Plan management has not identified any material subsequent events that require reporting or disclosure.

Note 3 - Information Prepared and Certified by the Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal, the custodian of the Plan, has certified that the following unaudited data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Interest and dividend income, and net change in fair value of investments as shown in the Statement of Changes in Net Assets Available for Benefits.
- The schedule of assets held at end of year included as supplemental information.

This information has not been audited by the Plan's independent auditors.

Note 4 - Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 inputs for the periods presented.

Note 4 - Fair Value Measurements (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Accounts: Pooled separate accounts are invested primarily in mutual funds and are valued at the daily closing price as reported by the fund and have Level 1 inputs and are considered to be actively traded.

Stable Value Fund: The stable value fund is a collective investment trust for which the value is based on the market value of its underlying investments. Because it is valued similar to mutual funds, the collective investment trust is considered a Level 1 asset.

The following tables set forth, by level within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

Note 5 - Party in Interest Transactions

Principal and certain affiliates are the custodian, recordkeeper, prepare the Form 5500 and performs compliance testing. Additionally, certain plan investments are managed by Principal Life Insurance Company. Pensionmark provides fiduciary advisory services and Olson, Reyes & Sauerwein performs the annual audit. Transactions with these companies qualify as party-in-interest transactions. For the year ended December 31, 2024, the Plan made direct payments totaling \$70,208 to parties-in-interest, which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

Note 7 - Tax Status

The Plan utilizes a volume-submitter plan, which obtained a favorable advisory letter from the United States Treasury Department dated June 30, 2020, stating that the form of the plan is acceptable under Section 401 of the Internal Revenue Code (IRC), and is therefore exempt from Federal income taxes. The plan administrator and Company management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, management believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
