***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Global 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

DECEMBER 31, 2024 AND 2023**

**1. Description of Plan**

The following description of the Global 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution plan originally established May 23, 2005 by Owl International dba Global (the “Company,” “Employer,” “Plan Sponsor” or “Plan Administrator”), as defined in the Plan document, under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

The Plan was amended and restated effective July 1, 2022.

b. Administration

The Plan Administrator is responsible for the day-to-day administration and operation of the Plan. The Company delegates its duties under the Plan to its Retirement Plan Committee (the “Committee”). The Committee is appointed by the Company’s Board of Directors and is responsible for monitoring the Plan’s investments. The Plan’s contract administrator, third-party trustee and custodian is Delaware Charter Guarantee & Trust Company, conducting business as Principal Trust Company (“Principal”).

c. Eligibility

The Plan covers all employees of the Company and GPC, a Joint Venture (“GPC”), (collectively referred to as the “Companies”) who are age 18 or older, excluding certain nonresident aliens, leased employees, reclassified employees, and employees classified by GPC as contract employees.

d. Participant Contributions

Participants may contribute to the Plan up to 50% of eligible compensation through elective, pre-tax, and Roth salary deferrals, subject to IRC limits of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Upon reaching the age of 50, participants may make additional catch-up contributions limited to \$7,500 for the years ended December 31, 2024 and 2023.

Participants may also make rollover contributions from other qualified defined plans and certain individual retirement accounts.

e. Employer Contributions

Through December 31, 2015, the Company made safe harbor matching contributions to eligible participants equal to 100% of participants' elective salary deferrals, limited to 3% of compensation, plus 50% of elective salary deferrals between 3% and 5% of compensation. Safe harbor matching contributions satisfied certain "safe harbor" requirements of the IRC, which eliminates the requirement for the Plan to perform certain annual non-discrimination testing.

Effective January 1, 2016, the Company no longer makes safe harbor matching contributions to eligible employees; instead the Company makes a discretionary matching contribution to eligible employees equal to 50% of the participants' elective salary deferrals, limited to 8% of compensation. The Plan includes catch-up deferrals in the elective deferrals amount used to determine the amount of the matching contributions. Employer matching contributions totaled \$181,756 and \$222,369 for the years ended December 31, 2024 and 2023, respectively.

GPC makes qualified non-elective contributions ("QNECs") pursuant to a prevailing wage contract ("prevailing wage contributions") based on the compensation paid under such contract. Participants entitled to these prevailing wage contributions are not eligible for discretionary matching contributions. Effective January 1, 2024, highly compensated employees are not eligible to receive prevailing wage contributions. Prevailing wage contributions totaled \$92,532 and \$98,087 for the years ended December 31, 2024 and 2023, respectively.

The Company may also make a discretionary non-elective contribution to the Plan each year. If made, such contributions are allocated to eligible participants' accounts based on each participant's compensation in proportion to total compensation for all eligible participants. All participants are eligible to receive discretionary non-elective contributions. The Company did not make any discretionary non-elective contributions for the years ended December 31, 2024 and 2023.

All contributions are invested in the participants' accounts according to their specified investment allocations as of the date of the contribution.

f. Participant Accounts

Separate accounts are maintained for each participant. Participants direct the investment of their account balances. Earnings or losses from investments are allocated to the participant account balances on a daily basis using a weighted average of participant account balances. The benefit to which a participant is currently entitled is the benefit that can be provided from the participant's vested account.

g. Vesting

Participants are always 100% vested in their contributions, catch-up contributions, rollover contributions, safe harbor matching contributions, QNEC's and the earnings thereon.

Participants vest in discretionary non-elective contributions as follows:

Effective January 1, 2016, the above vesting schedule applies to prior discretionary non-elective contributions and to all new discretionary matching contributions.

Participants become 100% vested in all their accounts if they are employed with the Companies and reach normal retirement age (59 ½), become totally disabled, pass away, or if the Plan terminates.

h. Forfeitures

Participants who terminate employment forfeit the non-vested portion of their discretionary non-elective contributions and earnings thereon. Forfeitures may be used to pay for Plan administrative expenses or to offset employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$33,197 and \$19,428, respectively. For the years ended December 31, 2024 and 2023, forfeitures of \$65,180 and \$12,998, respectively, were used to offset employer contributions.

i. Notes Receivable from Participants

Participants may borrow from their accounts the lesser of a) \$50,000, reduced by their highest outstanding note balance during the prior year, or b) 50% of their vested account balance, subject to a \$1,000 minimum. Notes are secured by the vested balance in the participant's account. Note payments are made through payroll deductions over periods up to five years, unless the note is used to acquire a primary residence, in which case the loan term may not exceed 15 years. New notes bear interest at the prime rate plus 2% per annum, fixed at inception of the note. As of December 31, 2024, notes mature through 2033 and bear interest rates ranging between 5.25% and 10.50%, which is commensurate with local prevailing rates as determined by the Plan Administrator at the time of the note.

j. Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant or beneficiary may elect to receive an amount equal to the participant's vested account balance in a lump-sum payment, installment payments over the participant's or beneficiary's assumed life expectancy, roll the amount to an individual retirement account or other eligible transferee plan, or delay payment until the beginning date of required minimum distributions, depending on the value of the account.

In addition, the Plan permits in-service distributions for participants who are age 59 ½ or older. A participant must be 100% vested in the distributing account in order to receive the in-service distribution, except for deemed severance distributions.

Distributions paid prior to the participant attaining age 59 ½ and not rolled into another retirement account are subject to federal income tax of 20% and a federal excise tax of 10%.

Vested account balances less than \$7,000, but more than \$1,000 may be distributed as a lump-sum cash payment or in the form of a direct rollover to an individual retirement account or eligible retirement plan at the consent of the participant or beneficiary. Vested account balances less than \$1,000 are distributed in a single lump-sum cash payment to the participant or beneficiary.

k. Hardship Withdrawals

Upon certain conditions, participants, while still employed by the Companies, are permitted to withdraw, in a single lump sum, a portion of their vested account balances as a result of an immediate and heavy financial need. These conditions include the payment of tax-deductible medical expenses, post-secondary education tuition for immediate family members, funeral or burial costs of immediate family members, natural disaster clean-up on the participant's primary residence, the purchase of the participant's primary residence, or to prevent eviction or foreclosure from the participant's primary residence.

l. Administrative Expenses

The Company pays certain administrative fees of the Plan, including legal, trustee and audit fees. All reasonable expenses of administration may be paid out of the Plan assets unless paid by the Company. Direct expenses paid by the Plan for investment management and recordkeeping were \$55,043 and \$58,435 for the years ended December 31, 2024 and 2023, respectively. Certain expenses are included in the transaction prices of investments bought and sold and are not separately quantifiable. The Plan charges certain transaction fees for notes receivable and distribution fees to the impacted participants.

m. Revenue Sharing

The Plan has a revenue sharing agreement in place whereby fees earned by the mutual fund companies or other collected fees on a periodic basis are shared with the Plan. These earnings are used for the benefit of the Plan to pay administrative expenses. For the years ended December 31, 2024 and 2023, revenue sharing earnings in the amount of \$25,343 and \$45,896, respectively, were included in other income in the statements of changes in net assets available for benefits.

## 2. Summary of Significant Accounting Policies

### a. Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”) as set forth by the Financial Accounting Standards Board (the “FASB”).

### b. Use of Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the amounts of net assets available for benefits, changes therein, the accompanying notes and the supplemental schedule. Actual results could differ from those estimates.

### c. Investment Valuation and Income Recognition

The Plan’s investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The common collective trust fund with underlying investments in investment contracts is valued at the net asset value (“NAV”) of the underlying investments. See Note 4 for discussion of fair value measurements.

Net appreciation (depreciation) in fair value of investments consists of the net change in unrealized gains or losses during the year and the realized gain or loss on investments sold during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

### d. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If an active participant fails to make payments for more than 90 days after they are due, the note will be in default. Under certain circumstances, as indicated in the Plan document, a note that is in default may be treated as a taxable distribution from the Plan and will be included in the statements of changes in net assets available for benefits as a benefit payment.

### e. Payment of Benefits

Benefits are recorded when paid.

### f. Subsequent Events

The Plan Administrator has evaluated subsequent events through September 10, 2025, the date the financial statements were made available for issuance.

### **3. Information Certified by Asset Custodian (Unaudited)**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA section 103(a)(3)(c) pursuant to Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal.

The classification of the investments into the appropriate fair value hierarchy levels (1, 2 or 3) as disclosed in Note 4 is not certified by the custodian and is the responsibility of the Plan's management.

### **4. Fair Value Measurements**

#### **a. Fair Value Hierarchy**

Accounting Standards Codification ("ASC") 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

This hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 – inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – inputs to the valuation methodology are unobservable and significant to the fair value.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Investments held in the Plan primarily consist of mutual funds and a common collective trust. These assets are recorded at fair value on a recurring basis. The common collective trust is measured at fair value using the NAV per share (or its equivalent) as a practical expedient.

The following is a description of the valuation methodologies used for the Plan's investments at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at quoted market prices, which are available on active markets.

*Common Collective Trust:* Valued at the NAV of units of a bank collective trust. The NAV is used as the practical expedient to estimate fair value and it is based on the fair value of the underlying investments. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. See discussion at Note 5.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes these valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

b. Investments Calculated at Net Asset Value per Share

The common collective trust is a stable return fund whose primary objective is to provide investors with a moderate level of stable income without principal volatility. There were no unfunded commitments at December 31, 2024 and 2023.

**5. Investments**

All Plan investments are participant-directed as of December 31, 2024 and 2023. Participants can direct their accounts among various mutual funds and a common collective trust.

The Plan invests in the Galliard Stable Return Fund PN60 (“SRF”), formerly the Wells Fargo Stable Return Fund N60 common collective trust fund. The SRF invests all of its assets in the Galliard Stable Return Fund Core (the “Fund”), formerly the Wells Fargo Stable Return Fund G. This investment is reported at fair value, which approximates contract value. The Fund invests in fully-benefit responsive investment contracts and security-backed contracts. An investment contract is a contract issued by a financial institution to provide a stated rate of return to the buyer of the contract for a specified period of time. A security-backed contract has similar characteristics to a traditional investment contract and is comprised of two parts: the first part is a fixed-income security or portfolio of fixed-income securities; the second part is a contract value guarantee (wrapper) provided by a third party. Wrappers provide contract value payments for certain participant-initiated withdrawals and transfers, a floor crediting rate, and return of fully accrued contract value at maturity. The Fund contains several redemption restrictions including the right to require a 12-month notice for withdrawal of assets from the Fund initiated by the Company. Withdrawals initiated by participants of the Plan will be honored when received. There are no unfunded commitments or reserves as of December 31, 2024 and 2023.

## **6. Party-in-Interest Transactions**

A party-in-interest is defined as a fiduciary or employee of the Plan, any person who provides service to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or a relative of such persons mentioned.

Certain Plan investments were managed by Principal serving as a custodian of the Plan. Therefore, any investment transaction executed with the custodian qualifies as a party-in-interest transaction.

In addition, the Companies are parties-in-interest to the Plan. However, there were no transactions with the Companies, other than the funding of contributions to the Plan and the payment of certain administrative expenses.

## **7. Plan Termination**

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue Employer contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in discretionary non-elective contributions and the earnings thereon.

## **8. Tax Status**

The Plan utilizes the Principal Life Insurance Company Defined Contribution Volume Submitter Plan and Trust which received an opinion letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that as of that date the Plan document was designed in compliance with the applicable IRC requirements. The Plan has been amended and restated since Principal Life Insurance Company received the opinion letter. However, Plan management believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, Plan management believes that the Plan is qualified and the related trust is tax exempt as of December 31, 2024 and 2023, and for the years then ended.

Assuming it meets certain initial and ongoing requirements, the Plan is generally exempt from federal and state income taxes. However, GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **9. Risks and Uncertainties**

The Plan invests in various investment securities, including mutual funds and a common collective trust. Investment securities, in general, are exposed to various risks such as interest rate, credit, foreign currency and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

## **10. Non-Exempt Transaction**

During the year ended December 31, 2023, the Plan Sponsor failed to remit \$16,363 of participant deferrals and loan repayments within the required timeframe as stated by the U.S. Department of Labor (“DOL”). These deferrals were deposited beyond the earliest expected date on which assets could be segregated from the Company’s assets. The DOL considers late deposits to be prohibited transactions. The Plan Sponsor has self-corrected this prohibited transaction restoring any lost earnings and applicable excise taxes.
