## INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of  
the Rochester Regional Health 403(b) Defined Contribution Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Rochester Regional Health 403(b) Defined Contribution Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

## **Notes to the Financial Statements**

### **Note 1. Description of the Plan**

The following description of the Plan provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution retirement plan that operates under Section 403(b) of the Internal Revenue Code (the Code) and was established for employees of Rochester General Health System (RGHS), Unity Health System (UHS) and United Memorial Medical Center (UMMC) (subsidiaries of Rochester Regional Health (RRH), or the Company). The Plan was established effective July 1, 2017 and is subject to the provisions of ERISA.

Effective July 1, 2017, the Unity Health System Tax-Sheltered Annuity (TSA) Savings Plan, Rochester General Health System 403(b) Plan and United Memorial Medical Center 403(b) Retirement Plan merged into the Rochester Regional Health 403(b) Defined Contribution Plan at which time all employee deferrals were remitted into the Plan and all participant assets were transferred into the Rochester Regional Health 403(b) Defined Contribution Plan.

#### **Administration**

The Plan is administered by RRH. The RRH Audit Committee is responsible for oversight of the Plan. The RRH Investment Committee determines the appropriateness of the Plan's investment offerings, monitors performance, and reports to the Audit Committee. Fidelity Management Trust Company (Fidelity) is the custodian of the Plan's assets. All current participant contributions are allocated to investments maintained by Fidelity.

#### **Eligibility and Contributions**

All employees are eligible to participate in the Plan upon their employment commencement date. Participants may elect to defer up to 80% of compensation or a dollar amount permissible under the Code section 403(b) immediately upon being hired. Participants who will attain age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled into the Plan at a deferral percentage of 3% unless they affirmatively elect not to participate in the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participants from UHS are eligible for employer match contributions if they are employed as of the last day of the year and have worked 1,000 hours within the calendar year. UHS will make matching contributions to the Plan annually equal to 25% of the participant's contribution up to 4% of the participant's eligible compensation. Employer matching contributions amounted to \$2,079,935 and \$1,974,424 for the years ended December 31, 2024 and 2023, respectively.

## Notes to the Financial Statements

### Note 1. Description of the Plan (Continued)

Participants from UMMC are eligible for employer match and non-elective contributions if they have completed two years of service defined by completing at least 1,000 hours of service in each year. UMMC will make matching contributions in the amount equal to 50% of an eligible participant's contributions subject to a maximum of 6% of the participant's eligible compensation beginning when service requirements are met. Employer matching contributions amounted to \$973,374 and \$871,702 for the years ended December 31, 2024 and 2023, respectively.

UMMC may contribute an employer non-elective base contribution to eligible participants amounting to 1.5% of eligible compensation. Employer non-elective contributions amounted to \$614,359 and \$539,870 for the years ended December 31, 2024 and 2023, respectively.

### Participant Accounts

Each participant's account is credited with the participant's contributions and Company's matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon.

UHS participants vest in UHS' matching contribution upon completion of three years of eligible service. Participants who leave RRH with less than three years of eligible service forfeit the non-vested portion of UHS' matching contributions.

UMMC participants are immediately vested in their elective deferral contributions and employer contributions.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate. Principal and interest are paid ratably directly through Fidelity on a monthly basis.

### Payments of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive a benefit payment equal to the value of the participant's vested interest in their account as a lump sum payment, installment payment, or partial withdrawal. Participants may also request an in-service distribution upon attainment of age 59 ½ or for financial hardship.

### **Note 1. Description of the Plan (Continued)**

#### **Forfeitures**

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$125,937 and \$119,728, respectively. These accounts will be used to reduce future employer contributions and pay qualified expenses of the Plan. Employer contributions were reduced by \$117,957 and \$137,945 for the years ended December 31, 2024 and 2023 from forfeited non-vested accounts.

### **Note 2. Significant Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor, trustee, custodian and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### **Payment of Benefits**

Benefits are recorded when paid.

### Note 2. Significant Accounting Policies (Continued)

#### Expenses

Certain expenses for maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

#### Subsequent Events

The Plan has been evaluated for subsequent events through September 9, 2025, the date the financial statements were available to be issued.

### Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level I) and the lowest priority to unobservable inputs (level III). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described as follows:

Level I: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level II: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level II input must be observable for substantially the full term of the asset or liability.

Level III: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

#### Note 3. Fair Value Measurements (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds that are held by the Plan are deemed to be actively traded.

**Money market funds:** Valued at cost plus interest, which approximates fair value.

#### Note 4. Party-in-interest Transactions

Certain Plan investments are managed by Fidelity. Fidelity is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

#### Note 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will be fully vested in their employer contributions.

### Note 6. Tax Status

The Plan adopted a volume submitter plan sponsored by Fidelity. The volume submitter plan has received an opinion letter from the IRS dated August 7, 2017, as to the volume submitter plan's qualified status. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is being operated in compliance with the requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

### Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in their values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of changes in net assets available for benefits.

### Note 8. Financial Certification

The following unaudited financial information as of December 31, 2024 and 2023, as well as transactions for the years ended December 31, 2024 and 2023, has been furnished by the Plan Administrator and certified by the trustee, Fidelity. The incorporation of this financial information in the accompanying financial statements is based solely on their certifications, and the information relating to assets as well as transactions has not been audited by independent accountants. In addition, the Plan's trustee has certified the unaudited financial data contained in the supplemental schedule at December 31, 2024.
