Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Sharethrough USA, Inc. 401(k) Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of April 14, 2025, December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the period from January 1, 2025 through April 14, 2025, and for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of April 14, 2025, December 31, 2024 and 2023, for the period from January 1, 2025 through April 14, 2025, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter – Plan Merger

As discussed in Note 1 to the financial statements, in June 2024, the Plan Sponsor made the decision to merge the Plan into the Justworks Retirement Savings Plan, effective January 1, 2025. All plan assets were transferred to the Justworks Retirement Savings Plan on April 14, 2025. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Sharethrough USA, Inc. 401(k) Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that was established in 2011 by Sharethrough USA, Inc. (the “Company” or “Employer” or “Plan Sponsor”) to provide benefits to eligible employees, as defined in the Plan document. The Plan is currently designed to be qualified under the applicable requirements of the Internal Revenue Code (“IRC”) and the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Effective August 2023, the Plan name was changed to Sharethrough USA, Inc. 401(k) Plan & Trust.

The Plan Sponsor made the decision to merge the Plan into the Justworks Retirement Savings Plan, effective January 1, 2025. All Plan assets were transferred to Justworks Retirement Savings Plan as of April 14, 2025.

Administration

The Company has appointed a 401(k) Committee to manage the operation and administration of the Plan. The Plan has contracted with Fidelity Management Trust Company (“Fidelity”) as the custodian and trustee and Fidelity Recordkeeping Services as a third-party plan administrator to maintain the records of participant data.

Eligibility

Employees of the Employer are eligible immediately upon hire and may enroll in the Plan on the first day of each month of the Plan year once eligibility requirements have been satisfied.

Participant Accounts

Individual accounts are maintained for each of the Plan’s participants to reflect the participant’s contributions, rollovers from qualified plans of the participant’s previous employers, allocations of the Plan’s earnings and administrative expenses and the Employer’s contribution, if any.

Contributions

Each year, participants may contribute a specified dollar amount or specific percentage of their pretax or Roth semi-monthly eligible compensation, not to exceed elective deferral limits imposed by the Internal Revenue Service (“IRS”), as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also rollover amounts representing distributions from other qualified defined-benefit or contribution plans. Contributions are subject to certain limitations, as defined in the Plan. In addition, the employer may make discretionary matching contributions and nonelective contributions to eligible participants. Participants must complete 1,000 hours of service and be employed on the last day of the Plan year to receive the employer match. There has been no discretionary matching or discretionary nonelective contributions made since inception of the Plan.

Investment Options

Participants must direct their salary deferral contributions to selected investments as made available and determined by the Plan Sponsor. Participants may change their investment options any time throughout the year via the Internet website or through the Plan Administrator.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the employer's contribution portion of their account plus actual earnings thereon is based on years of continuous service as follows:

<u>Completed Years of Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
1 but less than 2 years	33%
2 but less than 3 years	66%
3 or more years	100%

Notes Receivable from Participants

Participants may borrow from their vested account balances a minimum of \$1,000, up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Loan terms are specified for each loan. Loans must be repaid within a five-year period, unless the loan is used to purchase a principal residence, in which case the repayment term can be longer but may not extend beyond a 10 year-period. Principal and interest are paid ratably through semi-monthly payroll deductions. A participant may have no more than one loan outstanding at a time. The outstanding notes receivable carried an interest rate of 9.50% at December 31, 2024 and mature throughout 2029. The outstanding notes receivable carry an interest rate of 7.25% at December 31, 2023 and mature throughout 2027. There was no outstanding notes receivable as of April 14, 2025.

Forfeited Accounts

Forfeitures are used to pay Plan expenses and to reduce Employer discretionary matching contributions. At April 14, 2025, December 31, 2024 and 2023, there were no balances of forfeited non-vested accounts.

Plan Expenses

The Company currently pays for most of the Plan's expenses. Plan expenses not paid by the Company, or out of the forfeitures account, will be charged on a pro-rata basis to the value of the participants account balances.

Financial Hardship Distributions

The Plan allows hardship withdrawals in accordance with IRS regulations. Among other things, the withdrawal must be necessary in light of immediate and heavy financial needs of the participant and is limited to certain purposes.

NOTE 1 – DESCRIPTION OF THE PLAN (Continued)

Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. For termination of service due to other reasons, a participant whose account balance is less than \$1,000 will receive the value of the vested interest in his or her account as a lump-sum distribution. Additionally, the Plan allows for an automatic rollover provision for any balances between \$1,000 and \$5,000 into an Individual Retirement Account. Participants with account balances of \$5,000 or more must elect to receive the vested interest in his or her account in one lump-sum before retirement age is reached.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought or sold as well as held during the year.

Management fees charged to the Plan for investments are based on assets invested and are deducted on a daily basis. Management fees are reflected as a reduction of investment returns for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of April 14, 2025, December 31, 2024 or 2023.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for plan benefits.

Income Taxes

The Company adopted a volume submitter agreement with a cash or deferral arrangement which received a favorable opinion letter from the IRS, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS or the DOL. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of April 14, 2025, December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in question.

NOTE 3 – CERTIFIED INFORMATION

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. According, Fidelity Management Trust Company, the trustee of the Plan, has certified the completeness and accuracy of:

- Investments reflected in the accompanying statements of net assets available for plan benefits as of April 14, 2025, December 31, 2024 and 2023;
- Net appreciation (depreciation) in fair value of investments and dividend and interest income, reflected in the accompanying statement of changes in net assets available for plan benefits for the period from January 1, 2025 to April 14, 2025 and December 31, 2024;
- Assets reflected in the Supplemental Schedule H, Line 4i - Schedule of assets (Held at End of Year) as of December 31, 2024.

NOTE 4 – FAIR VALUE MEASUREMENT

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at April 14, 2025, December 31, 2024 and 2023.

Interest-bearing cash

Valued at the carrying value, which approximates fair value due to the short-term nature of such investments.

Registered investment companies (mutual funds)

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4 – FAIR VALUE MEASUREMENT (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
