The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of the Plan

The Northstar Travel Media, LLC 401(k) Plan (Plan) is administered by Northstar Travel Media, LLC (Company or Sponsor). The following brief description of the Plan is provided for general information purposes only. More complete information is provided in the Summary Plan Description and Plan Document, which are available from the Company.

General

The Plan is a voluntary, participant-directed, defined contribution savings plan which became effective November 1, 2001, was restated on January 1, 2022, and then amended on January 31, 2023, to revise the safe harbor matching contribution provisions. The Plan covers all eligible non-union employees of the Company and its affiliates (PhoCusWright, Inc., Ryan Solutions LLC, Sterling Valley Systems, Inc. DBA Inntopia, and TravAlliancemedial, LLC) and who have completed three months of service and are age twenty-one or older. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Contributions

Each Plan year, participants may elect to make voluntary contributions up to 100% of eligible compensation to their tax deferred account or Roth after-tax account subject to certain statutory limitations. Elective deferrals can be changed by a participant at any time, with the change taking effect in the next administratively feasible payroll period. The participant may elect to rollover contributions which were received from another qualified plan. Participants 50 or older may make an additional pre-tax and/or Roth after-tax contribution subject to Internal Revenue Service limitations. Participants are automatically enrolled to defer 3% of pay and will increase 1% annually up to 8%, unless they choose to opt out of the Plan or make a change to the contribution amount. The Company may make discretionary matching contributions as part of the Plan. The Company provided discretionary matching contributions equal to 25% of the Elective Deferral Contributions made by Participants on or after January 31, 2023, up to a maximum of 1.5% of each such Participant's base salary earned during any allocation period. As employer matching contributions are paid out five weeks after the end of the quarter they are earned, at December 31, 2024, there were employer contributions receivable of \$110,616.

The Company may also make a discretionary profit-sharing contribution to all eligible participants who are enrolled in the Plan on the last day of the Plan year. Profit-sharing contributions, if made, are allocated based upon the proportion that the participants' compensation bears to the aggregate compensation of all such participants in the Plan for the year. The Company did not make a discretionary profit-sharing contribution in 2024.

Participant Accounts

Participants are immediately vested in their elective contributions plus actual earnings thereon. Each participant's account is credited with the participant's contribution and the Company's matching contribution, discretionary matching, and profit-sharing contributions, if any, as well as Plan investment income or losses and administrative expenses. Portfolio fees normally charged by the investment funds are applied against the participant's account and reported as a reduction of investment income.

Vesting

A participant's vesting in the Company's employer matching contributions and discretionary profit-sharing contributions plus earnings thereon, are based on years of service. A participant becomes 100% vested after one year of credited service for the Company's employer matching contributions and 100% vested after three years for the discretionary profit-sharing contributions.

Benefit Payments

A participant who terminates employment is generally entitled to their vested account balance. Upon termination of employment due to a participant's death, disability, early retirement, or attainment of age 65 (normal retirement age), the participant's account is considered fully vested and is eligible for distribution in either a lump-sum payment, partial payments, or through installment payments for a certain dollar amount.

In-Service Withdrawals

Participants attaining the age of 59-1/2 or who reach early retirement age (defined as 55 years of age with three years of vested service) may request a withdrawal of all or part of the vested portion of their accounts. Also, in the event a participant suffers financial hardship, as defined in the Plan, the participant may withdraw all or part of their salary deferrals account.

Forfeitures

Forfeiture accounts may be used to offset Plan expenses or are used to reduce employer contributions, added to employer contributions, or reallocated, as elected by the Company. As of December 31, 2024 and 2023, the forfeiture balance had approximately \$800 and \$0 available, respectively. During the year ended December 31, 2024, approximately \$800 was added to the forfeitures account and no forfeitures were used to pay for a portion of employer matching contributions and administrative expenses.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of 50% of their vested account balances or \$50,000 (reduced by the highest value of any outstanding loan balance in the preceding 12 months). The interest rate is set at the prime rate plus 1%. The maximum number of loans available to a participant at any given time is two. Loan terms are for up to five years, except for loans for the purchase of a primary residence, which are not to exceed thirty years or the term of the mortgage. Loans are repaid through payroll deductions and are secured by the vested balances in the participants' accounts.

As of December 31, 2024, notes receivable from participants accrue interest at rates ranging from 4.25% to 9.5% per annum with maturities ranging from January 2025 to February 2032. As of December 31, 2023, notes receivable from participants accrue interest at rates ranging from 4.25% to 9.5% per annum with maturities ranging from January 2024 to February 2032.

Investment Options

Investments with Charles Schwab Trust Bank, the trustee of the Plan, may be made in the fund vehicles offered by the Plan and participants may elect to have their contributions invested in any of these funds. A separate account is maintained for each participant and interest and dividends earned by each fund are reinvested in that fund. Participants may change their investment options daily.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments in mutual funds and the money market fund are stated at fair value. Investment in the common collective trust fund is measured at net asset value per share, a practical expedient to fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held at year end.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan Document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Revision

Certain revisions have been made to the 2023 financial statements disclosures presented in the current year. The mutual funds and the money market fund are categorized as Level 1 investments and common collective trust fund as a reconciling line item to the table since they are at net asset value which is a practical expedient to fair value. These were incorrectly presented in the fair value hierarchy table footnote in the prior year. These revisions did not have any impact on the financial statement line items impacted.

Note 3. Information Certified by the Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103 8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the trustee, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Net appreciation in fair value of investments, dividends and interest income, and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

Note 4. Fair Value Measurements

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

The levels of the fair value hierarchy are described below:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023:

Mutual Funds/Money Market Funds

Valued at the daily closing price as reported by the fund, which represents the net asset value of the shares held by the Plan at year-end. The funds held by the Plan are deemed to be actively traded (Level 1 inputs).

Common Collective Trust Fund

Composed primarily of benefit responsive investment contracts and is valued at the net asset value of units of the bank collective trust. The net asset value is used as a practical expedient to estimate the fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchase and sales) may occur daily. There are no participant redemption restrictions for these investments and the redemption notice period of 12 months is applicable only at the Plan level. There are no unfunded commitments as of December 31, 2024 and 2023.

- a) In accordance with Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) as a practical expedient to fair value have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

Note 5. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust document sponsored by Schwab Retirement Plan Services. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Plan Termination

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time subject to the provisions of ERISA. Upon termination of the Plan, participants will become 100% vested and entitled to their full account balance, including all Company contributions and earnings thereon, as of the termination date.

Note 7. Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by the Plan's trustees and, therefore, transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. Other fees and expenses, such as investment fees and certain Plan Administrative expenses, maybe deducted directly from investment returns in accordance with the applicable investment option selected by the participants. During the year end December 31, 2024, the Plan made payments of \$178,845 for services provided to the Plan by parties-in-interest including investment advisors, managed services, and trustee/recordkeeper services.

Note 8. Risks and Uncertainties

The assets of the Plan are invested in financial instruments that are liquid, readily tradable, and subject to fluctuations in fair value. General market and economic conditions have a significant impact on the Plan's investment performance. Investments are subject to risk conditions of the individual fund objectives, equity market fluctuations, interest rates, economic conditions and world affairs. It is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits

Note 9. Subsequent Events

The Company has evaluated subsequent events through September 19, 2025, the date the Plan's financial statements were available for issuance.
