## INDEPENDENT AUDITORS' REPORT



To the Trustees of the

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits*

We have performed audits of the financial statements of the Search for Change, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

***Other Matter - Supplemental Schedule Required by ERISA***

The supplemental schedule H, line 4(i) - Schedule of Assets (Held At End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that

agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

This summary of significant accounting policies of the Search for Change, Inc. 401(k) Plan (the "Plan") is presented to assist in understanding the Plan's financial statements and supplemental information. These financial statements, supplemental information, and notes are representations of Search for Change, Inc.'s (hereinafter, the "Plan Sponsor" or "Employer") management, who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to accounting principles generally accepted in the United States of America ("U.S. GAAP") and have been consistently applied in the preparation of the financial statements and supplemental schedule.

Basis of Accounting: The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with U.S. GAAP.

Use of Estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition: All Plan investments were held by John Hancock Life Insurance Company of New York (the "Custodian") at December 31, 2024 and 2023. The Plan's investments are stated at fair value. Pooled separate accounts are reported at the value reported to the Plan by the Custodian, which represents the fair value of the underlying investments comprising the accounts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussions of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded when earned. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. During the year ended December 31, 2024, the Plan's net investment gains (including gains and losses on investments bought and sold, as well as held during the year) were \$696,733.

Participant Notes Receivable: Notes receivable from participants are measured at their unpaid principal balance. If a participant ceases to make loan repayments and the plan administrator deems the loans to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits: Benefits are recorded when paid to the Plan's participants.

Events Occurring After Report Date: The Plan Sponsor has evaluated events and transactions that occurred between January 1, 2025 and September 15, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

**NOTE 2 - DESCRIPTION OF THE PLAN**

The following brief description of the Plan provides general information. Participants should refer to the Plan document, which is available from the plan administrator, for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all eligible employees of the Employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions: Employees are eligible to participate in the Plan upon reaching the age of 21. Each year, participants may contribute to the Plan a percentage of compensation, as defined by the Plan, or in specific dollar amounts. Eligible compensation is defined by the Plan as wages under Internal Revenue Code ("IRC") Section 3401(a), excluding taxable employee benefits for elective deferrals only. Such contributions are excluded from the participant's federal taxable income until received as a withdrawal or distribution from the Plan. A participant may elect to increase, decrease, or suspend their contributions according to procedures established by the Employer. There is an annual dollar limit as to the amount that can be contributed on a pre-tax basis into the Plan, which is determined by the Internal Revenue Service ("IRS") and adjusted annually. Participants who attain age 50 by the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts distributed from other qualified plans.

The Employer may make a discretionary non-elective contribution to the Plan in an amount determined annually by the Board of Directors. An employee must be employed for one year with at least 1,000 hours completed and be at least 21 years of age in order to receive the discretionary non-elective contribution. For the 2024 Plan year, the Board of Directors approved an Employer non-elective contribution in an amount equal to 5.35% of a participant's eligible compensation. These contributions are also subject to IRS limitations and adjusted annually.

Vesting: Participants are immediately vested in their contributions plus allocated earnings thereon. Participants are vested in their Employer non-elective contributions as follows:

Forfeitures: In the event a participant terminates employment prior to vesting in any portion of his/her benefits, the Employer contributions are forfeited. Forfeitures are used to reduce the Plan Sponsor's future contributions or administrative expenses. At December 31, 2024 and 2023, forfeited account balances were \$7,660 and \$2,586, respectively, and are held in a non-interest bearing cash account. During 2024, there were \$39,807 of new forfeitures added to the Plan, and \$34,733 of forfeitures were used to offset employer contributions. No forfeitures were used to reduce administrative expenses during 2024.

Participant Accounts: The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with each participant's contribution, employer contributions, and earnings thereon. As a participant-directed plan, each participant's investment choices determine their share of earnings or losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have a maximum of two outstanding loans at a time. The maximum payment term allowed for any loan is five years unless the loan qualifies as a residential mortgage loan, in which case the term may not exceed 15 years. The loans are secured by the participant's vested account balance and bear interest at rates that range from 4.25% to 9.50%, which are commensurate with local prevailing rates at the time the loans were taken as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

In-Service Withdrawals: In-service withdrawals are permitted by the Plan for active employees when they reach the age of 59 ½ or normal retirement age, defined by the Plan as the later of age 65 or the fifth anniversary of participation in the Plan. The Plan also allows for in-service withdrawals in the event of financial hardship. Hardship withdrawals are subject to restrictions as to use of the proceeds.

Payment of Benefits: Upon termination of service due to death, disability, or retirement, a participant's balance will be paid in a lump sum payment. If a participant terminates with a vested account balance that does not exceed \$7,000 and did not consent to a distribution, the participant's account will either be distributed into a rollover IRA to be established by the Custodian on the participant's behalf, or paid directly to the participant or beneficiary, if the account balance is not in excess of \$1,000.

Required minimum distributions as mandated by IRS regulations will commence when a participant attains age 70 ½. Participants who are not 5% owners and attain age 70 ½ may elect to defer distributions until April 1<sup>st</sup> following the calendar year in which they reach age 70 ½ or, if later, terminate employment. Due to changes made by the Setting Every Community Up for Retirement Enhancement Act of 2019 (“SECURE Act”), effective January 1, 2020, if a participant’s 70<sup>th</sup> birthday is July 1, 2019 or later, required minimum distributions may be deferred until the participant reaches age 72. Due to changes made by the SECURE 2.0 Act of 2022 (“SECURE 2.0 Act”), effective January 1, 2023, participants who turned 72 in 2023 or later may defer required minimum distributions until the participant reaches age 73.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Investment Options: Upon enrollment in the Plan, participants may direct their contributions to any of the various investment options available by the Plan. Participants may change their contribution investment options, transfer part or all of past investments to other funds, and change their deferral amounts at any time during the Plan year.

The Plan offers various pooled separate accounts established by the Custodian. Each of the pooled separate accounts are invested in portfolios of non-affiliated trusts. Each pooled separate account represents the net contributions of a unit holder that are allocated to the underlying fund of the sub-account maintained by the Custodian.

Plan Amendments: The Employer has the right under the Plan to amend the Plan at any time. The Plan was amended in 2024 retroactively to January 1, 2021 to change the definition of compensation and create an exclusion for taxable employee benefits for elective deferrals.

The Plan Sponsor has until the 2026 Plan year to amend the Plan to include mandatory and any voluntary SECURE Act and SECURE 2.0 Act provisions.

Plan Termination: The Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of the Plan’s termination, participants would become 100% vested in their Employer contributions, and any unallocated assets of the Plan shall be allocated to participant accounts and distributed in a manner as the Employer may determine.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Accounting standards establish a framework for measuring fair value, providing a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset and liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts: Pooled separate accounts consist of investments in mutual funds and are valued at the net asset value ("NAV") at which the mutual fund shares are actively traded. The NAV is determined by the Custodian of the fund and is based upon the fair value of the underlying assets held by the fund.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 - INFORMATION CERTIFIED BY THE CUSTODIAN**

Investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian.

**NOTE 5 - INCOME TAX STATUS**

The Plan Sponsor elected to adopt the Plan Custodian's prototype plan, which received a favorable opinion letter from the IRS dated June 30, 2020, which states that the Plan is designed in accordance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 6 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**NOTE 7 - TRANSACTIONS WITH PARTIES-IN-INTEREST**

At December 31, 2024 and 2023, certain Plan investments were managed by the Custodian and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments. Participant loans also qualify as party-in-interest transactions.
