To the Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of BlueForce 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of BlueForce 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

NOTE 1 - DESCRIPTION OF THE PLAN

The BlueForce 401(k) Profit Sharing Plan (the Plan) is a defined contribution plan providing retirement income for eligible employees. The Plan was adopted effective January 1, 2004, and was most recently restated on June 13, 2021. The Plan is sponsored and administered by BlueForce, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

A summary of the Plan's major provisions follows. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

Eligibility

Employees are eligible to participate in the Plan after completing three months of service based on elapsed time. There is no age requirement for the Plan. Eligible employees are able to enter the Plan immediately upon satisfaction of the service requirements. The Plan excludes leased employees.

Contributions

A participant may elect to defer pre-tax and/or Roth contributions up to 75 percent of eligible compensation as defined by the Plan, subject to Internal Revenue Service limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company has elected to make safe harbor matching contributions on behalf of the participants equal to 100% of the first 5% of eligible compensation. The Company, at its discretion, may also make non-elective employer contributions or matching contributions to the Plan. Employees must be employed on the last day of the Plan year to be eligible for non-elective contributions. For the years ended December 31, 2024 and 2023, total safe harbor matching contributions were \$196,984, and \$285,768, respectively. The Company elected not to make any additional non-elective contributions for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's match contribution, (b) plan earnings, and (c) charged with an allocation of administrative expenses and plan investment losses. Allocations are based on participant earnings or account balances, as defined by the plan provisions. Allocation of the Company's matching contributions are based upon eligible compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in salary deferrals contributions, rollover accounts, safe harbor contributions plus actual earnings thereon. For the Company's matching and discretionary profit sharing contributions there is a 3 year graded vesting schedule. A participant is vested in the Company's matching and discretionary profit sharing contributions based on the following schedule:

Forfeitures

Forfeitures occur when a participant terminates prior to fully vesting. The nonvested portion of the participants account will be forfeited a) if the inactive participant elects to receive a distribution of his entire vested account balance or b) if the inactive participant has incurred five consecutive breaks in service. The forfeited amounts may be used to pay Plan expenses or reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$20,447 and \$18,969, respectively. For the year ending December 31, 2024, no forfeitures were used to offset employer contributions or plan expenses.

Notes Receivable from Participants

Participants may borrow from their investment account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant loan must be payable within a period not exceeding 5 years from the date the participant receives the loan, unless the loan is for the purchase of the Participant's principal residence, in which case the loan may be payable within a reasonable time commensurate with the repayment period permitted by commercial lenders for similar loans. The notes receivable are secured by the balance in the participant's account and bear a reasonable interest rate as determined by the administrator based on the prevailing interest rates.

Payment of Benefits

The Plan provides for the payment of benefits to the participant or beneficiary at retirement, death, disability or termination of employment. Participants terminating their employment with the Company of their vested account balance. Hardship distributions are allowed under plan provisions. Participants who qualify for retirement benefits and withdrawals will receive their benefits in the form of a lump sum distribution. Benefits under the Plan shall be distributed solely from the assets of the Trust.

Participants who separate from service and have vested account balances of \$5,000 or less will automatically have their account balances distributed either by direct payment to the individual or as a direct rollover to an individual retirement plan (IRA).

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires in the United States (U.S. GAAP) management to make estimates and assumptions that may affect the reporting amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from such estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Interest income is shown on an accrual basis from notes receivable from participants and investment contracts.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued, but unpaid interest. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Cash and Cash Equivalents

The Plan considers highly liquid investments with an original maturity of three months or less to be cash and cash equivalents.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

Plan fees and administrative expenses (exclusive of investment related expenses) are generally paid by the Company. Account maintenance fees and some administrative costs are paid by the Plan.

Subsequent Events

The Plan has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued and concluded there were no events that require recording or disclosure in the financial statements as of December 31, 2024.

NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE

NOTE 4 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities, (2) quoted prices for identical or similar assets or liabilities in inactive markets, (3) inputs other than quoted prices that are observable for the asset or liability, and (4) inputs that are derived principally from the corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market funds: These investments are included in mutual funds and are public investment vehicles valued using NAV provided by the administrator of the fund. The underlying asset generally comprise of short-term securities representing high-quality, liquid debt, and monetary assets. These funds are classified within Level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. Plan investments are managed by Fidelity Management Trust Company as the asset custodian as defined in the Plan and, therefore, these transactions are considered to be exempt party-in-interest transactions. The Plan issues notes receivable to participants which are secured by the balances in participants' accounts. The Plan paid certain administrative fees in 2024. The Company paid certain administrative expenses of the Plan, including audit fees. These transactions qualify as party-in-interest transactions for which a statutory exception exemption exists.

NOTE 6 - PROHIBITED TRANSACTIONS

During the Plan year 2023 it was discovered that one participant's deferral elections had not been updated properly resulting in missed deferrals. The error was corrected in the full amount of missed deferrals totaling \$10,684 as of September 2025. However, the Company is still in process of working with the third party administrator of the Plan to confirm the QNEC contribution in total estimated amount of \$5,342 and determine the lost earnings, of which the corrective contributions will be made as soon as administratively possible.

NOTE 7 - PLAN TERMINATION

Although the Company has not expressed any intent to do so, it has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100 percent vested in their employer matching and profit sharing contributions.

NOTE 8 - TAX STATUS

The Company adopted a prototype plan document sponsored by the trustee. The IRS has determined and informed the trustee by a favorable opinion letter dated June 30, 2020, that the prototype plan document is designed in accordance with the applicable sections of the Internal Revenue Code (the Code). The prototype plan's opinion letter is being relied on by the Plan. The plan has been restated since receiving the opinion letter. However, the trustee and plan management believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code, and therefore, believe that the Plan is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principals generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
