1. Plan Description

The following brief description of the SAFEBuilt 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits to the employees of SAFEBuilt, LLC (the Company), and its wholly-owned subsidiaries, MTCI Private Provider Services, LLC, Florida Municipal Services, LLC, Cornerstone Inspection Svcs, LLC, Winston Services, Inc., Esgil Corporation, Independent Inspections, Ltd., LSL Planning, LLC, M.T. Causley, Inc., Meritage Systems, Inc., Municipal Building Inspection Solutions, LLC, Kutzmann & Associates, Inc. Calvin, Giordano & Associates, Inc., MEP Structural, Engineering and Inspections, Inc., J2LB, LLC dba Countywide Inspection Services, BroadSpec Inc, Interwest Consulting Group, Inc., Dal-Tech Engineering, Inc. and MNSPECT, LLC. During 2023, the employees of ProCode Inc. and PMCA were added to the Plan (see Note 9).

Employees, excluding union, leased and non-resident alien employees, are eligible to make pre-tax salary deferral contributions and designated after-tax Roth salary deferral contributions on the first day of the quarter after attaining 21 years of age and completing one month of service. Participants are eligible to receive discretionary matching contributions upon meeting the same eligibility requirements. Additionally, participants may be able to receive discretionary profit-sharing contributions after obtaining 1,000 hours of service annually and are employed on the last day of the Plan year.

Contributions

Participants may elect to defer up to 100% of their annual eligible compensation as defined by the Plan, up to the maximum dollar amounts allowable by law. Participants may also contribute amounts representing distributions from other qualified plans. All employees are automatically enrolled with a 3% deferral contribution once they become eligible for the Plan. At any time, a participant may elect not to contribute or may increase or decrease his or her deferral rate. The Company may also make discretionary matching contributions and discretionary profit-sharing contributions. Participants who are eligible to make deferral contributions and who will attain age 50 before the close of the calendar year are eligible to make catch-up contributions. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of a) the Company's discretionary matching contributions and discretionary profit-sharing contributions, b) plan earnings and losses and c) an allocation of administrative expenses paid by the Plan. The Company's discretionary matching contributions are allocated among participants based upon each participant's elected salary deferral. The Company's discretionary profit-sharing contributions are allocated based on the eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts maintained by Voya Retirement Insurance and Annuity Company (Voya).

Vesting

Participants are immediately vested in their participant contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching contributions and discretionary profit-sharing contributions credited to participants' accounts is based on years of continuous service. Participants are 100% vested after three years of credited service. Participants from acquired companies may be subject to different vesting schedules.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the participant's highest outstanding loan balance during the previous twelve months or 50% of their vested account balances, subject to plan provisions. Notes receivable terms range from one to five years or longer for the purchase of a primary residence. Notes receivable are secured by the balance in the participants' accounts and bear interest at the prime rate plus 1%. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

Upon death, termination, retirement, or disability, a participant or beneficiary may elect to receive a lump-sum or installment amounts equal to the value of the vested funds allocated to the participant's account. The Plan requires that distribution payments between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. Participants may also receive hardship and in-service distributions, as permitted in the Plan document. Benefits are recorded when paid.

Forfeitures

Upon a participant's termination of employment before normal retirement, disability or death, the portion of their Company contribution not then vested shall be forfeited. The forfeited portion of any participant's account may be used to reduce Company contributions or to pay plan expenses or may be re-allocated to participants. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$220,884 and \$262,142, respectively. During 2024 and 2023, forfeitures of \$347,075 and \$78,141, respectively, were used to reduce discretionary matching contributions.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments, except for fully benefit-responsive investment contracts, are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Company invests in investment contracts through a guaranteed interest account.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the plan document.

Other

Audit fees are paid by the Company and are excluded from these financial statements. Other certain expenses specifically incurred by or attributable to individual participants are paid from the applicable participants' accounts and are included in administrative expense. Investment-related expenses are included in net appreciation in fair value of investments.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through September 16, 2025, noting no items requiring disclosure.

3. Information Certified by Voya

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Voya, the custodian of the Plan, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Money Market Fund: Valued at the net asset value (NAV) of shares held by the Plan as of year-end.

Pooled Separate Accounts: Valued at the NAV of its underlying investments. The pooled separate accounts include underlying investments in mutual funds which have observable level 1 or level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. FASB ASC 820, *Fair Value Measurement*, allows NAV per share to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that these accounts meet those requirements. Since the participants have the ability to redeem the accounts at NAV as of the measurement dates on a daily basis, the accounts are properly categorized as a Level 2 fair value measurement.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment Contract with Insurance Company

The Plan has entered into an investment contract with Voya. Voya maintains the contributions in pooled separate accounts, a money market fund, and a guaranteed interest account. The accounts are credited with earnings on the underlying investments and charged for plan withdrawals and administrative expenses charged by Voya.

The pooled separate accounts and money market fund, as reported to the Plan by Voya, are included in the financial statements at fair value, which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses.

As the guaranteed interest account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest account. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The credited interest rate for the guaranteed interest account was 1.50% for the years ended December 31, 2024 and 2023.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic developments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

6. Tax Status

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested. Distribution of account balances to participants would be made as soon as practicable after the termination date.

8. Related-Party Transactions

Certain plan investments are a money market fund and a guaranteed interest account managed by Voya. Voya is the custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions.

9. Plan Mergers

The trustees and plan administrators allowed the ProCode Inc. employees to begin participation in the Plan effective on January 1, 2023. The Plan approved the transfer of ProCode Inc. 401(k) Profit Sharing Plan assets into the Plan in January 2023. Through a series of transactions initiated in January 2023, assets of \$38,601 were settled and received into the Plan. As of January 13, 2023, this process was completed.
