**Independent Auditor's Report**

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Shady Canyon Golf Club 401(k) Savings Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). ### NOTES TO FINANCIAL STATEMENTS

#### 1. Description of Plan

The following description of the Shady Canyon Golf Club 401(k) Savings Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provision.

##### **General**

The Plan is a defined contribution plan covering all eligible employees of the Shady Canyon Golf Club, Inc. (the "Club"), as defined in the Plan agreement. The Plan is designed to qualify under Section 401(k) of the Internal Revenue Code (the "Code"), as amended. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

##### **Contributions**

Each year, participants may contribute a percent of their pretax annual compensation, as defined in the Plan and as permitted by the Internal Revenue Service. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Club may make discretionary contributions as authorized by its Board of Directors. The Club's matching contribution is in accordance with the requirements of a "Safe Harbor" plan.

##### **Forfeited accounts**

The Plan permits the employer to reduce its contributions or expenses by the amount of forfeitures, if any. At December 31, 2024 and 2023, the forfeiture account was \$2,264 and \$1,726, respectively. No forfeitures were used during the year ended December 31, 2024 and 2023.

##### **Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of (a) the Club's contribution, (b) Plan earnings, and (c) forfeitures of terminated participant's nonvested accounts, if any, and charged with an allocation of administrative expenses. Allocations are based on participant's earnings or account balance, as defined. The benefit which the participant is entitled is the benefit that can be provided from the participant's accumulated vested account.

##### **Vesting**

The Club voluntarily elected to fund the plan in accordance with the "Safe Harbor" provisions. Accordingly, Plan participants are immediately vested in the Club's contribution. The Club has not indicated that it intends to change this funding method but may do so at any time.

##### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate is established time to time in accordance with provisions of the Plan. Principal and interest is paid ratably through payroll deductions and recognized as income upon receipt by the Plan.

### NOTES TO FINANCIAL STATEMENTS

#### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

#### **Withdrawals of Contributions**

A participant demonstrating a financial hardship may withdraw any amount of their account value consisting of the participant's contributions.

#### **Investment Options**

The Club maintains the retirement assets with an investment company that provides a selection of mutual funds. This company serves as custodian and Trustee of the Plan. Assets in the separate investment allocation account are held by the Trustee on behalf of the Plan in one or more of the Trustee's separate investment accounts.

The participants direct their account balances between the funds and may change their account distribution in accordance with the terms of the Trust agreement.

## 2. Summary of Accounting Policies

#### **A . Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting and were reconciled or agreed to the Form 5500.

#### **B. Investment Valuation and Income Recognition**

Investment are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrator determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during- the year.

#### **C. Payment of benefits**

Benefits are recorded as paid.

#### **D. Contributions**

Participant contributions are recorded in the period in which the Club makes payroll deductions from Plan participants. The Club's matching contribution is calculated and contributed at the same time the participants' contribution is made to the Plan.

#### 2. Summary of Accounting Policies, continued

##### **E. Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Club. Expenses that are paid by the Club are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

##### **F. Estimates**

The preparation of financial statements requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

##### **G. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is a least reasonable possible that changes in the values of investment securities will occur in the near term and that such changes can materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

##### **H. Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2023 or 2022.

##### **I. Subsequent Events**

The Plan has evaluated subsequent events through the date the financial statements were available to be issued, September 19, 2025. Plan investment securities may have declined in fair value since December 31, 2024. It is reasonably possible that market fluctuations have materially affected participants' account balances.

#### 3. Information Prepared and Certified by Trustee

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan management instructed the plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Empower Trust Company LLC, the trustee of the plan, as complete and accurate, except for comparing such information certified by the trustee with information included in the plan's financial statements and supplemental schedules.

#### 4. Fair Value Measurements

The framework for measuring fair value provides fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are as follows:

##### Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

##### Level 2

Inputs to valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified term, the level 2 input must be observable for substantially the full term of the asset or liability.

##### Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. Fair Value Measurements, continued

Following is a description of the valuation methodologies used for assets measured at fair value end. Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Accounting standards permit, as a practical expedient, the measurement of certain investments at their net asset value (NAV) per share. These investments are not included within the fair value hierarchy discussed above.

5. Investments at Contract Value

The Plan may invest in benefit-responsive investment contracts issued by insurance companies and other financial institutions ("Contract"). If the Contract meets the fully benefit-responsive investment contract criteria it would be reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

#### 5. Investments at Contract Value, continued

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events

that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

#### 6. Income Tax Status

The Internal Revenue Service has determined and informed the Trustee of the Plan that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code ("the Code"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The Plan is subject to routine tax audits by taxing jurisdictions. There are currently no audits for any tax periods in progress. The Plan is subject to exam by authorities for the preceding four years.

#### 7. Plan Termination

Although it has not expressed any intent to do so, the Club has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100 percent vested in their accounts.

#### 8. Related-Party Transactions and Party-in-interest

Certain plan investments are shares of mutual funds managed by and Empower Trust Company LLC ("Empower"). Empower is the Trustee and record keeper. Therefore, these transactions qualify as party-in-interest transactions. Administrative fees presented on the accompanying statement of changes in net assets were paid to the related parties.
