NOTES TO FINANCIAL STATEMENTS

December 31, 2024 And 2023

(1) THE PLAN

GENERAL

The following description of the Brennan Center For Justice 401(K) Profit Sharing Plan (**“Plan”**) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- A. General** – The Plan is a defined contribution pension plan covering substantially all Brennan Center For Justice (the **“Center”**) employees. The Plan was adopted January 1, 2000. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (**ERISA**). All employees who have obtained the age of 21 are eligible to participate in the plan. Effective January 1, 2021, interns and temporary employees who work less than 1,000 hours in an eligibility computation period are excluded from participation in the Plan for all contribution purposes.
- B. Contributions** – Employees are eligible to participate in the Plan on their date of hire through voluntary payroll reductions up to the lesser of 100% of their salaries or \$23,000. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Center may make a yearly discretionary matching and profit sharing contribution. In addition, beginning in 2021, the Center will make Safe Harbor contributions to the Plan in an amount not less than 3% of participants’ compensation. Participant contributions are fully vested at all times with respect to their contributions and any matching, profit sharing and Safe Harbor contributions.
- C. Participant Accounts** – Participants are provided a selection of mutual funds in which to invest contributions. Each participant’s account is credited with the contributions described in B. Earnings are credited to each participant’s account, which are distributed by the respective mutual funds. Each investment account is revalued daily on the basis of fair market value. Periodic statements are provided to all participants.
- D. Investment Options** – Upon enrollment in the Plan, a participant may direct all future employee and employer contributions into any of the investment options which provide a spectrum of investment strategies. When no direction is provided by an employee with regard to investment options, employee and employer contributions will be invested in a qualified default investment alternative which takes into account the individual’s age or retirement date, such as a life-cycle or targeted-retirement-date fund.
- E. Payment of Benefits** – A participant’s vested benefits will normally be distributed to the participant or the participant’s beneficiary upon the retirement, disability or death of the participant. If the vested benefit in the Plan does not exceed \$1,000, then such distributions will be in one lump-sum cash payment. Otherwise, the distribution may be in one lump-sum cash payment, or in monthly, quarterly or annual installments.

In-service withdrawals of all or a portion of a participant’s vested account balance may be made by participants who have attained the age of 59-1/2. Hardship withdrawals from a participant’s deferral contribution accounts are permitted when criteria are met. In-service withdrawals of all or a portion of a participant’s rollover account balance may be withdrawn at any time.

- F. Administration** – The Center is the administrator of the Plan. Lincoln Financial Group (**“Lincoln”**) is the Plan’s record keeper and the Plan’s trustee. Lincoln provides custodial and investment management services with respect to the net assets of the Plan, maintains the individual participant account records and advises the Plan on other matters related to the operation of the Plan.

G. *Forfeited Accounts* – Forfeited non-vested accounts are used to reduce employer contributions and expenses.

H. *Loans to Participants* – Participants may borrow, from the Plan, up to 1/2 of their vested account balance, limited to \$50,000, at a reasonable rate of interest determined by the Administrator not to exceed limits set by the Internal Revenue Code. Loans are generally repaid within five years.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investment contracts held by a defined-contribution plan are required to be reported at fair value except fully benefit responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. Certain guaranteed investment contracts are considered fully benefit responsive and are presented at contract value as of December 31, 2024 and 2023.

USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

CONCENTRATION OF CREDIT RISK

Financial instruments which potentially subject the Plan to concentrations of credit risk are investments. Plan investments are held in trust and consist of mutual funds which are administered by the sponsor company.

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are in shares of registered investment companies which are stated at fair value except fully benefit responsive investment contracts which are reported at contract value. Shares of registered investment companies are valued at quoted market prices which represent the net asset value of shares held by the Plan at year-end.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

(3) INVESTMENTS

The Plan utilizes various methods to measure the fair value of most of its investments on a recurring basis. Generally accepted accounting principles establish a hierarchy that prioritizes inputs to valuation methods. The three levels of inputs are described below:

- Level 1 – Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 – Observable inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly. These inputs may include quoted prices for the identical instrument on an inactive market, prices for similar instruments, interest rates, prepayment speeds, credit risk, yield curves, default rates and similar data.)
- Level 3 – Unobservable inputs for the asset or liability, to the extent relevant observable inputs are not available, representing the Plan’s own assumptions about the assumptions a market participant would use in valuing the asset or liability, and would be based on the best information available.

The inputs methodology used for valuing securities are not necessarily an indication of the risk associated with investing in those securities. For example, amortized cost approximates the current fair value of a security, but since the value is not obtained from a quoted price in an active market, such securities are reflected as Level 2.

(4) GUARANTEED INVESTMENT CONTRACT WITH LINCOLN FINANCIAL GROUP

The plan offers evergreen contract with Lincoln Financial Group ("*Lincoln*"), an insurance company. Lincoln maintains the contributions in a general account. The evergreen contract is offered through one contract type: Lincoln Stable Value Account ("*LSV*"). Unlike traditional guaranteed investment contracts with a defined maturity date, evergreen contracts do not have a specified maturity date. Therefore, unlike a traditional guaranteed investment contract, there are no known scheduled cash flows associated with this contract. The principal, which is the amount one contributes to the Guaranteed Account (minus withdrawals, charges, and adjustments), is protected from the risk of investment loss. Protection of principal is guaranteed by the claims-paying ability of The Lincoln National Life Insurance Company and, in New York, Lincoln Life & Annuity Company of New York. Transfers and withdrawals from the Guaranteed Account may require Lincoln to sell some of the investments backing the assets in the account, which may result in a loss. The contract has a provision to determine the size of the market value adjustment to protect the value of the account for other remaining participants.

The Lincoln NY Stable Value Account portion of the contract is reported at contract value in the plan year report. Contract value represents the amount participants would receive if they were to initiate a transaction under the terms of the ongoing plan. Interest is credited daily at an interest rate not less than the guaranteed minimum interest rate, as shown on the contract specifications. The interest crediting rate is declared on a quarterly basis. The contract amount maintained in LSV is guaranteed against loss of principal, minus all withdrawals, including charges and adjustments.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair values of the investment contract at December 31, 2024 and 2023 was approximately \$1,137,000 and \$737,000, respectively, for the LSV contract. The crediting rates are set to be at least as high as the guaranteed minimum interest rate for a given contract, are communicated to plan sponsors before they go into effect and are guaranteed for at least one quarter.

Certain events would allow Lincoln to terminate an annuity contract under the following circumstances: (1) failure to pay any charges Lincoln has billed to the contract owner within 30 days, (2) failure to furnish requested information or other documentation, (3) discovery by Lincoln that the contract owner has misrepresented any material information, (4) the plan fails to meet the requirements of the appropriate code sections, (5) following the third contract year the plan fails to meet the growth guidelines, (6) plan terminates its recordkeeping with Lincoln, (7) Lincoln discontinues offering this contract form to the public. The plan administrator does not believe that any events which would limit the plan's ability to transact at contract value with participants are probable of occurring.

(5) PLAN TERMINATION

Although it has not expressed any intent to do so, the Center has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

(6) TAX STATUS

The Internal Revenue Service has determined by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code.

Management has reviewed the tax positions for each of its open tax years (2021 – 2023) or expected to be taken in the Plan's 2024 tax return and has concluded that there are no uncertain tax positions that would require recognition in the financial statements.

(7) RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities which employ various investment strategies. The investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(8) PARTY-IN-INTEREST TRANSACTIONS

Certain administrative costs of the Plan are paid by the employer/sponsor. Transactions between the Plan and Lincoln qualify as party-in-interest. Administrative costs incurred by the Plan to Lincoln were \$106,461 during 2024.

(9) SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 19, 2025 the date which the financial statements were available to be issued.
