Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Dunham Associates, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year), as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1. Plan Description

The following description of Dunham Associates, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering substantially all employees of Dunham Associates, Inc. (the Company) who have completed three months of service, as defined, and are age 21 or older. Effective July 1, 2025, the Plan was amended to allow employees age 18 or older to participate in the Plan. The Company's Retirement Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan operations: The Plan is administered by the Company. Fidelity Management Trust Company (Fidelity) acts as the trustee. The trustee is responsible for holding the assets of the Plan, participant record keeping, administering notes receivable from participants and making disbursements to participants.

Contributions: Participants may elect to contribute up to 60% of compensation, as defined, up to the maximum dollar amount permitted by law. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Effective January 1, 2024, the Plan was amended to include an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants will have their deferral rate set at 6% of eligible compensation, and their contributions invested in a designated balanced fund until changed by the participant. In 2024, the Company made discretionary matching contributions equal to 50% of the first 6% of a participant's eligible compensation contributed to the Plan, for a maximum matching contribution of 3% of participant eligible compensation. The Plan also allows for additional discretionary contributions by the Company. No additional discretionary contributions were made in 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant accounts: Each participant's account is credited with the participant's contributions and the Company's discretionary matching contributions, if any, as well as allocations of additional discretionary contributions, if any, and Plan earnings and is charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting: Participants are 100% vested in their accounts at all times.

Investment options: Fidelity manages the Plan's assets. Participants are allowed to invest in a variety of investment choices, including self-directed investment options, as more fully described in the Plan's literature. All choices vary in types of investments, rates of return and investment risk. Participants may elect to have all or part of their account balances and future contributions transferred from one fund to another or in any combination.

Notes receivable from participants: Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Note terms range from one to 10 years. The notes are secured by the balance in the participant's account and bear interest at a rate determined periodically by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants as of December 31, 2024, range in interest rates from 5.25% to 10.50%, maturing at various dates through December 2029.

Note 1. Plan Description (Continued)

Payment of benefits: Upon termination of service due to death, permanent disability, retirement or any other reason, benefits are paid in one lump sum, other amounts elected by the participant, or equal installments not less frequently than annually, as permitted by the Plan. Participants who terminate service with the Company and have an account balance of less than \$1,000 will automatically have their account balance distributed in a single lump sum. Participants who terminate service with the Company and have an account balance less than \$7,000, but greater than \$1,000, will automatically have their account balance distributed to an individual retirement account. The Plan also allows in-service distributions when certain requirements defined in the Plan document are met by participants.

Plan termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: The Plan's investments are stated at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company's Retirement Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions: Contributions from Plan participants and the discretionary matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Note 2. Summary of Significant Accounting Policies (Continued)

Payment of benefits: Benefit payments are recorded when paid.

Administrative expenses: Expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included as an offset to net appreciation in fair value of investments.

Subsequent events: The Plan has evaluated subsequent events through September 22, 2025, the date on which the financial statements were available to be issued. See Note 1.

Note 3. Information Certified or Provided by Fidelity

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity, a qualified institution:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Registered investment companies are valued at the quoted market prices for identical assets in active markets for investments held by the Plan at year-end.

Self-directed brokerage accounts: The self-directed brokerage accounts are valued based on quoted market prices of the underlying investments. The self-directed brokerage accounts consist of registered investment companies, common stock, and cash.

Interest-bearing money market account: The money market account is valued at cost plus accrued interest, which approximates fair value measured by similar assets in active markets.

Collective trust fund: The collective trust fund is valued at the net asset value (NAV) as reported by the investment advisor using the audited financial statements of the fund at year-end. The NAV is used as a practical expedient to estimate fair value. The fund's underlying assets consist of investment contracts and security-backed contracts.

Note 5. Tax Status

The Plan has adopted a nonstandardized pre-approved plan sponsored by FMR LLC. FMR LLC has received an opinion letter from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments held are shares of registered investment companies or shares of the interest-bearing money market account managed by Fidelity. Fidelity is the trustee as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions.

Note 7. Risks and Uncertainties

The Plan provides for investments in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is possible that changes in the values of the investments have occurred since December 31, 2024, and that such changes could materially affect participants' account balances and the amounts reported in the 2024 statement of net assets available for benefits.
