### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Tidewater Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements is complete and accurate.

### **Opinion**

### 1. Description of Plan

The following description of the Tidewater Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document, copies of which are available from the plan administrator, for more complete description of the Plan's provisions.

#### General

This Plan is a defined contribution plan sponsored by Tidewater Inc. and certain of its subsidiaries (collectively, the Company). All employees except those who are members of a collective bargaining agreement, leased employees, nonresident aliens, or cadet employees are eligible to participate in the Plan. Employees become eligible to participate in the Plan on the first day of the month after attaining age 18 and completing one month of service. Interns and seasonal employees are eligible to participate in the Plan after attaining age 21 and completing 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Eligible employees are automatically enrolled into the Plan, and pre-tax contributions are withheld at 6% of eligible compensation unless the employee elects differently. The Plan allows for an annual 1% automatic increases of participant pre-tax contributions, on April 1<sup>st</sup> of each year, up to a maximum of 10%, unless the employee elects differently. For employees who were automatically enrolled into the Plan prior to January 1, 2020, pre-tax contributions are withheld at 8% with annual 1% automatic increases of the participant pre-tax contributions up to a maximum of 15%, unless the employee elects differently. Each participant may elect to make pre-tax and/or Roth contributions of up to 75% of eligible compensation as defined by the Plan document, not to exceed a maximum of \$23,000 in 2024, plus catch-up contributions of \$7,500 for those participants who are at least 50 years of age.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan allows for in-plan Roth conversions for participants that are currently employed with the Company. In-plan Roth conversions allow participants to transfer amounts from their pre-tax accounts into a Roth account and pay all applicable taxes in the year of the transfer.

The Company may make a discretionary matching contribution on behalf of all eligible employees. The Company elected to contribute discretionary matching contributions of 50% of participants' contributions up to 6% of eligible compensation for the year ended December 31, 2024 totaling \$1,088,332, net of forfeitures. Additionally, the Company may make a discretionary profit-sharing contribution based on a participant's eligible compensation, for eligible participants who have completed at least 501 hours of service and are employed on the last day of the Plan year. There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

### Participant Accounts

Each participant account is credited with the participant's contributions, rollovers, Company contributions, and earnings or losses on the investments in their account and is charged with administrative expenses and certain fees related to specific transactions. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may change their investment options on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are vested immediately in their contributions plus actual earnings and losses thereon. Vesting for the Company's discretionary matching and profit-sharing contributions vest according to the following table:

Number of Years of Service	Vested Percentage
Less than 1 year	0%
1 year but less than 2 years	33%
2 years but less than 3 years	64%
3 years or more	100%

All amounts become fully vested upon the participant's attainment of normal retirement age, disability, or death. Participants who previously participated in predecessor plans may be subject to different vesting schedules.

### Payment of Benefits

At the time of death, disability, termination of service, or retirement, the participant or their beneficiary may receive payment of the vested interest in their account in a lump-sum amount, equal to the value of the participant's vested interest in their account. In-service withdrawals of all or part of the participant's vested account, are also permitted for participants who have attained age 59½. The participant's contributions may also be withdrawn for certain hardship situations. If a participant terminates employment and has an account balance less than \$1,000, the participant will automatically receive a lump-sum payment equal to the value of their account. If a participant terminates employment and has an account balance greater than \$1,000 but less than \$7,000, the participant's balance will be rolled over to an individual retirement plan or annuity account.

### **Forfeitures**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$51 and \$1,610, respectively. Forfeitures may be used to pay the administrative expenses of the Plan or used to reduce future Company discretionary contributions. In 2024, \$0 of forfeitures were used to pay administrative expenses and \$53,465 of forfeitures were used to reduce Company contributions.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance of their account. A participant may have one note outstanding at a time. The notes are secured by the balance in the participant's account and bear a fixed rate of interest. During 2024, notes had fixed rates of interest ranging from 3.25% to 9.50% for the term of the note, not to exceed 5 years unless used to for the purchase of a participant's principal residence. Principal and interest are paid through payroll deductions. Notes become due and payable immediately when a participant terminates employment with the Company.

### **Administrative Expenses**

Certain administrative expenses are permitted to be paid by the Plan in accordance with the Plan's provisions and are allocated proportionately based on the value of the participant account balances. Note receivable origination fees and certain transaction fees for withdrawals are charged directly to the respective participants' accounts. These expenses are paid to service providers of the Plan and therefore qualify as party-in-interest transactions. Certain expenses incidental to the administration of the Plan are paid by the Company. The Company does not expect reimbursement from the Plan for any expenses paid on behalf of the Plan.

## **2. Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates, and such differences may be material to the financial statements.

### Contributions

Participant contributions are considered payable to the Plan upon the withholding of contributions from the participant's paycheck. The Company discretionary matching contributions are considered payable to the Plan when the related participant's contributions are payable to the Plan and approved by the Company. The Company discretionary profit-sharing contributions are considered payable to the Plan when approved by the Company.

### Valuation of Investments and Income Recognition

The investments of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Net increase in fair value of investments includes interest, dividends, and realized and unrealized gains and losses on investments. Interest income is recorded when received.

### Notes Receivable from Participants

Notes receivable from participants are carried at their outstanding balance. Interest income is recognized when received. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded. Notes receivable from participants qualify as party-in-interest transactions.

### Payment of Benefits

Benefits are recorded when paid.

### Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through July 30, 2025, which is the date the financial statements were available to be issued.

### 3. Information Certified by the Qualified Institution

All information in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, net increase in fair value of investments and interest income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as

complete and accurate by Fidelity Management Trust Company (Fidelity), the Plan's qualified institution.

#### 4. Investments

Certain Plan investments include shares of mutual funds, a common collective trust fund, and the money market fund which is managed by Fidelity. Fidelity is a service provider of the Plan; therefore, transactions in these investments qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net increase in fair value of investments, as they are paid through revenue sharing rather than a direct payment.

Investments are exposed to various risks, such as market, currency, interest rate and credit risks. Market risks include U.S. and global events which could impact the value of Plan investments. Such events would include a healthcare crisis, such as a pandemic, international conflicts, supply chain disruptions, global monetary policy decisions, significant exogenous economic influences, significant cyber security attack, or other similar events. It is at least reasonably possible that changes in their fair value will occur in the near term and that such changes could materially affect participants' account balances.

The Financial Accounting Standards Board established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three levels. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 – unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 – other observable data, including quoted prices for identical assets in inactive markets

Level 3 – unobservable inputs

Observable inputs are those based on market data obtained from sources independent of the Plan, and unobservable inputs reflect the Plan's own assumptions based on the best information available. The input levels are not necessarily an indication of the risk or liquidity associated with financial instruments at that level but rather the degree of judgment used in determining those values.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Investments in mutual funds and the money market fund are stated at quoted market prices for the identical security in an active market (Level 1).

Fair value of the common/collective trust fund is determined by prices provided by the trust manager, which is the net asset value (NAV) of the trust (Level 1). NAV is determined by the fair value of the securities in the trust. Participants can trade the common/collective trust fund daily at the published NAV.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in all Company contributions.

### 6. Income Tax Status

In June 2021, the Plan that was based on a Volume Submitter Profit Sharing Plan with CODA (volume submitter plan) sponsored by Fidelity Management & Research Co. (FMRC) moved to a Non-Standardized PreApproved Profit Sharing Plan with CODA (pre-approved plan) sponsored by FMR LLC (doing business as Fidelity Institutional Asset Management).
