Independent Auditor's Report

To the Trustees and Plan Administrator
Baker Distributing Corporation 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Baker Distributing Corporation 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audits). Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal-control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Description of Plan

The following brief description of the Baker Distributing Corporation 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General: The Plan is a defined contribution plan covering all employees of Baker Distributing Corporation (the Company) who have at least 12 consecutive months and 1,000 hours of service and are 21 years of age or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants may contribute up to 100% of pretax annual eligible compensation. Participants who have reached age 50 before the end of the Plan year are eligible to make an additional catch-up contribution. In addition, the Plan allows rollover contributions from other qualified plans.

Effective January 1, 2024, the Company will make safe harbor matching contributions in an amount equal to 100% of the amount of a participant's elective deferrals up to 3% of the participant's compensation, plus 50% of the next 2% of the participant's compensation, for a maximum match of 4% of compensation for participants contributing 5% or more.

The Company may make discretionary or non-elective (profit sharing) contributions, as determined by the Company. The Company did not make any discretionary or non-elective contributions in 2024.

Contributions and eligible compensation are subject to certain limitations.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contributions, and allocations of the Company's discretionary or non-elective contributions, and Plan expenses and earnings. Allocations of Plan expenses and earnings are based on a participant's account balance relative to the total account balances of all participants in the same investment. Allocations of the Company's discretionary or non-elective contributions are based on a participant's eligible compensation relative to the total eligible compensation of all participants in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions and in their safe harbor matching contributions plus actual earnings thereon. Vesting in discretionary and non-elective contributions is based on years of service. A participant is 20% vested after two years of service, increasing 20% each year up to 100% after six years of credited service. Participants become fully vested upon reaching the normal retirement age (age 60) while employed, death or disability.

Payment of benefits: Benefits are distributed under the Plan based on the normal retirement date, in-service distributions based on the normal retirement age, disability, death, the termination of the participant's employment, or qualified reservist status. A participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a partial withdrawal of at least \$1,000.

Note 1. Description of Plan (continued)

Forfeitures: As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$1,020, respectively. These amounts will be used to restore participant accounts, reduce future employer contributions or pay Plan expenses. During 2024, forfeitures of \$1,020 were used to pay Plan expenses.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP) using the accrual basis of accounting.

Investment valuation and income recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisors, Trustees, and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions: Contributions from Plan participants and the related matching contributions from the employer are recorded in the year the employee contributions are withheld from compensation.

Expenses of the Plan: Substantially all expenses of maintaining the Plan are paid by the Company. Certain administrative fees are paid by the Plan. Certain transactions fees are paid by Plan participants.

Payment of benefits: Benefits are recorded when paid.

Use of estimates: The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Risks and uncertainties: The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent events: The Plan has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by Ascensus, LLC, as an Authorized Representative of Ascensus Trust Company

The following is a summary of the Plan's information as of December 31, 2024 and 2023 and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to, or derived from, information certified as complete and accurate by Ascensus, LLC, as an authorized representative of Ascensus Trust Company, a qualified institution:

- All investments;
- All investment income;
- Information regarding investments in Note 4; and
- Information included on Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year).

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level 1: Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

Level 2: Observable market-based inputs or observable inputs that are corroborated by market data.

Level 3: Unobservable inputs for the assets or liabilities that are not corroborated by market data.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used in the current or prior year.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and, therefore, are considered Level 1 investments.

Common collective trust: The stable value collective trust is primarily composed of fully benefit-responsive investment contracts and is valued at the NAV of units of the stable value collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The stable value collective trust provides for daily redemptions by the Plan at the reported NAV per share, with no advance notification requirement.

Note 5. Tax Status

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the pre-approved plan document; however, the Plan Administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Plan Termination

Although it has not expressed any intent to date, the Company has the right under the Plan to discontinue contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 7. Related-Party Transactions

ERISA defines a party in interest as including, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, the management of investments held by the qualified institution or an affiliate are considered party-in-interest transactions. Additionally, the Company pays certain administrative fees of the Plan, as described in Note 2.
