## INDEPENDENT AUDITOR'S REPORT

To the Trustees and Participants of  
Scandrill, Inc. 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Scandrill, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**1. DESCRIPTION OF THE PLAN**

The following description of the Scandrill, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the *Plan Document* for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution retirement plan covering all employees, except for employees who are residents of Puerto Rico, covered by a collective bargaining agreement, nonresident aliens with no U.S. income, and independent contractors of Scandrill, Inc. (the “Company or Plan administrator”). The Plan was established on September 1, 2001, amended and restated on March 17, 2022, and most recently amended on November 3, 2023. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. The Plan is qualified under Section 401(a) of the Internal Revenue Code (“IRC”), which allows employees to make tax-deferred contributions.

**Plan Trustee**

Fidelity Management Trust Company (“Fidelity”) is the trustee for the Plan and holds all Plan assets. The duties of the trustee are to receive contributions and to invest and reinvest the trust assets of the Plan.

**Eligibility and Contributions**

Participants may elect to reduce their compensation by a specific percentage and have that amount contributed to the Plan as a salary deferral. There are two types of salary deferrals: pre-tax 401(k) deferrals and Roth 401(k) deferrals. The Plan provides for voluntary contributions of up to 25% of the employee’s eligible compensation up to the maximum limits of the IRC. Total deferrals in any taxable year may not exceed a dollar limit which is set by law. Participants at least age 50 or will attain age 50 before the end of a calendar year may elect to defer additional amounts as catch-up contributions, as defined in the Plan.

Employees are automatically enrolled in the Plan upon meeting the eligibility requirement of two months of service at 5% of the employee’s compensation which includes an annual auto-escalation increase of 1% (15% maximum). Participants may elect a different percentage or elect not to participate by notifying the Company or Fidelity at any time.

The Company’s discretionary matching contribution on behalf of each participant is equal to 100% of a participant’s salary deferral, subject to a maximum of 1% of eligible compensation contributed to the Plan. The Company may also make a non-elective discretionary contribution to the Plan. For the year ended December 31, 2024, no non-elective discretionary contribution was made.

Participants can roll over part of or all of an eligible rollover distribution they receive from an eligible retirement plan as a rollover contribution.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions, the Company’s contributions, and an allocation of Plan earnings or losses and Plan administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined.

Participants direct the investment of their account balances in any of several investment options. Participants can change their investment allocation among the various investments offered by the Plan either through direct transfers from one option to another or by changing the percentage of future contributions allocated among the investment options. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

**Vesting**

Participants are immediately vested in their contributions, rollovers, and any earnings thereon. A participant is vested in the Company's contributions and related earnings as follows:

**Forfeited Accounts**

Forfeitures from employer matching contributions will be used to pay administrative expenses or used to reduce any employer contributions as directed by the Company. During the year ended December 31, 2024, the Plan utilized forfeitures of \$91,677 to reduce employer contributions. Forfeitures of \$14,759 and \$15,127 were available for use by the Company as of December 31, 2024 and 2023, respectively.

**Notes Receivable from Participants**

Participants are permitted to borrow funds from the balance in their respective accounts subject to a minimum loan of \$1,000 and limited to the lesser of 50% of the participant's vested balance or \$50,000. Participants may only have one loan outstanding at any given time. All loans must be repaid over a five-year period unless it is for the purchase of a principal residence. Participant loans bear terms as deemed appropriate by the Plan administrator subject to certain provisions of the Plan.

**Payment of Benefits**

Withdrawals may be made from participant vested account balances, subject to certain restrictions, upon termination of employment, retirement, reaching the age of 59½, or by incurring a disability or hardship, as defined by the Plan. In the case of death, distributions are made to the participant's beneficiary. Distributions ordinarily are made in single lump-sum cash payments.

If the value of the participant's account balance is less than \$1,000, the payment will be made in cash in a single lump-sum without the participant's consent. Any taxable distribution paid by the Plan directly to the participant will be subject to mandatory federal income tax withholding of 20% of the requested distribution. If the participant's account balance is between \$1,000 and \$5,000 and the participant does not affirmatively consent to receive a distribution, the balance will be rolled into an individual retirement account established on behalf of the participant.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in the administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, each participant would become 100% vested in their accounts.

**2. SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as distributions, based upon the terms of the *Plan Document*, upon liquidation of their account balance.

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Unrealized appreciation or depreciation in the fair value of investments held at year-end is determined using the fair value at the beginning of the year or the purchase price if the investment is acquired during the year. The realized gain or loss on the sale of investments is determined using historical cost. Unrealized appreciation or depreciation along with realized gains and losses are reported as net appreciation or depreciation in fair value of investments in the statement of changes in net assets available for benefits.

**Financial Instruments and Credit Risk**

Financial instruments which potentially subject the Plan to credit risk, include investments in a money market fund and mutual funds. Investments are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits. Plan participants bear the risk of any investment losses.

**Payment of Benefits**

Benefits paid to participants are recorded when paid.

**Subsequent Events**

The Plan has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued, and has determined there are no subsequent events to be disclosed.

**3. FAIR VALUE MEASUREMENTS**

The Plan uses a three-level hierarchy, in accordance with the fair value standard, that establishes a hierarchy for grouping assets and liabilities, based on the significance of inputs. The hierarchy of fair value measurements is described below:

*Level 1* - quoted prices in active markets for identical assets or liabilities;

*Level 2* - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of these assets or liabilities; or

*Level 3* - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Money Market Fund:* Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the Securities and Exchange Commission (“SEC”). This fund is required to publish its daily net asset value and to transact at that price. The money market fund is deemed to be actively traded.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**4. TAX STATUS**

The prototype plan adopted by the Company received its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service (the “IRS”) stated that the prototype plan, as then designed, was in compliance with applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of December 31, 2024 and 2023.

Accordingly, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audits by the IRS and Department of Labor; however, there are currently no audits for any tax periods in progress.

**5. CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company.

**6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by Fidelity. Fidelity is the trustee and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan provides for notes receivable from participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.
