## SHERBAN SPINE CASH BALANCE PLAN

### SUMMARY OF PLAN PROVISIONS

**Effective Date:** February 1, 2014.

**Plan Year:** January 1 to December 31.

**Participation:** An eligible employee shall participate on the January 1 or July 1 coinciding with or next following attainment of age 21 and 1 year of service. If you were employed on 2/1/14, you immediately became a participant as of then.

**Year of Service for Vesting and Eligibility:** 1000 hours of service during a plan year.

**Year of Service for Benefit Computation:** 1000 hours of service during a plan year.

**Compensation:** Form W-2 compensation that is actually paid in gross income during a plan year while a participant. If a participant enters plan mid-year, their entire compensation for that plan year is used. For Sole Proprietors, shall use self-employment earnings. Effective 1/1/21, the entity of the sponsor, Sherban Spine Institute, P.A., is an S Corporation.

**Eligible Employee:** An employee of the employer with the exclusion of leased employees, union employees, and non-resident aliens.

**Normal Retirement Date:** Actual date on which you turn age 62.

**Early Retirement Date:** The plan does not provide for retirement prior to the normal retirement date.

**Normal Form of Benefit:** Life annuity payable monthly for single employees or actuarially equivalent qualified joint and 50% survivor annuity payable monthly for married employees.

**Accrued Benefit:** Actuarial equivalent of participant's cash balance account at determination date projected with interest credits to Normal Retirement.

**Vesting:** Shall be 100% vested with 3 or more years of vesting service. Shall also become 100% vested at death, disability, or attainment of your Normal Retirement age, while active. In addition, the following eight participants will become 100% vested as of 3/5/21: Amy Albert, Roselind Darby, Jamie Daughtery, Cheryl Gregorio, Stephanie Marzullo, Jennifer Pierantoni, Gail Rogers, and Roger Rogers.

**Pre-Retirement Death Benefit:** The participant's accrued benefit.

**Principal Credits:** 32% of compensation for Ross Sherban, 28.5% of compensation for Roger Rogers, and 2% of compensation for all other employees. Note that for 2020, participant Jennifer Pierantoni received 2.25% of her compensation, while for 2021 she will receive 2.5% of her compensation, even though she didn't have 1000 hours in 2021. For 2021, participant Roselind Darby shall receive 2.0% of her compensation, even though she didn't have 1000 hours. For 2021, participant Stephanie Marzullo shall receive 2.25% of her compensation, even though she didn't have 1000 hours. For 2021 and 2022, participant Norcilis Bango shall receive 2.25% of her compensation, instead of the usual 2.0%. For 2022, participant Sharon Barrera shall receive 2.25% of her compensation, instead of the usual 2.0%. For 2022, participant April Kemper shall receive 2.75% of her compensation, instead of the usual 2.0%. Typically, only participants that work at least 1000 hours during a plan year shall receive principal credits.

**Interest Credits:** Interest accumulated to prior cash balance account and principal credits. Shall cease accumulating at time participant's full benefits have commenced.

**Cash Balance Account:** Sum of accumulated principal and interest credits.

**Top Heavy:** Minimum benefits shall be governed under defined contribution plan.
