1. DESCRIPTION OF PLAN

The following description of ChromaDex, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan effective January 1, 2008, and most recently amended and restated effective August 1, 2021, under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of ChromaDex, Inc. (the "Company", "Plan Sponsor" or "Employer") and its subsidiary ChromaDex Analytics, Inc., as a participating employer. Employees of the Company are eligible to participate in the Plan if they are at least 21 years of age. Nonresident aliens and employees covered by a collective bargaining agreement are excluded from the Plan. After meeting the eligibility age requirement, employees are auto-enrolled in the Plan on the first day of each calendar month beginning after the date on which such eligible employee satisfied such age requirement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may elect to reduce their compensation, as defined by the Plan, by a certain amount and have that amount contributed to the Plan as a pre-tax, or post-tax (roth) salary deferral. Participants who have attained age 50 before the Plan year-end are also eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans in which participants have previously participated. The Company may make a discretionary employer matching contribution of 50% of the participant's elective deferrals (including catch-up contributions), up to a maximum of 6% of participant's annual compensation. In order to be eligible for the employer discretionary match contributions, the participant is required to be age 21 or older during the Plan year. The Company may also make discretionary profit sharing contributions to the Plan. In order to be eligible for the discretionary profit sharing contribution, the participant is required to have worked at least 1,000 hours during the Plan year and be an employee on the last day of the Plan year. No discretionary profit sharing contributions were contributed to the Plan during the year ended December 31, 2024. Contributions are subject to certain limitations.

Participant Accounts

Participants direct the investment of their accounts into various investment funds offered by the Plan. Each participant's account is credited with the participant's contribution and an allocation of the Employer's profit sharing and matching contributions, Plan earnings and expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

ChromaDex, Inc. 401(k) Plan Notes to Financial Statements

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their own contributions, rollovers from other qualified plans, and actual earnings thereon. Vesting in the Employer's profit sharing and matching contributions is based on years of service with participants becoming 100% vested only after completing three years of service. A participant becomes fully vested in all contribution accounts in the event the participant reaches normal retirement age, dies or becomes totally disabled.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts were \$45,671 and \$8,754, respectively. Forfeited nonvested accounts will be used to pay plan administrative expenses or as a credit to reduce future Employer's contributions. For the year ended December 31, 2024, forfeitures of \$2,500 was applied toward administrative expenses and \$1,180 used for Employer's matching contributions.

Payments of Benefits

On termination of employment, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested account balance. Under certain conditions, in-service withdrawals are allowed.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan repayment terms are for a period not to exceed 5 years, except in the case of loans used to acquire a principal residence, wherein the loan repayment term may be for a longer period. A participant may have a maximum of one loan outstanding at a time. Loans are secured by the balance in the participant's account and bear interest at a fixed rate commensurate with market prevailing rates at the date the loan is issued. At December 31, 2024 and 2023, the interest rates on loans range between 5.00% and 9.50%. Principal and interest are normally paid ratably through bi-weekly payroll deductions.

Plan Termination

Although it has not expressed any intent to do so, the Company is under no obligation or liability to continue its contributions and may discontinue such contributions or terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Employer's contribution portion of their account.

2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis, which approximates when interest is received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income associated with the notes receivable is recorded as earned as per the related loan amortization schedules. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid or upon distribution.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Company, at its option, and are excluded from these financial statements. Fees related to specific participant transactions, such as for participant loans and benefit payments, are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements and Schedule of Assets (Held at End of Year), which include investments and notes receivable from participants held at December 31, 2024 and 2023, and interest, dividends, net appreciation in fair value of investments, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan, in accordance with Section 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

4. INVESTMENTS AND FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under ASC 820 with the related inputs to the valuation methodology are described as follows:

Level 1 - Quoted prices (unadjusted) in active markets for identical assets that the Plan has the ability to access.

Level 2 - Significant other observable (directly or indirectly) inputs, including quoted prices for similar assets in active markets or in inactive markets and other market observable inputs such as interest rate, credit risks, etc.

Level 3 - Significant unobservable inputs, including the Plan's own assumptions in determining the fair value of investments.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Mutual funds are valued at their quoted market prices.

Common/Collective Trust Funds

Valued at the net asset value (NAV) units of the common/collective trust. The net asset value, as provided by the trustee, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. For the common/collective trust funds, there are no unfunded commitments, redemption frequency is daily and there is no required redemption notice period.

In addition, the Plan pays other expenses for services rendered by the trustee as the plan recordkeeper and also by its third party administrator, investment advisor and auditor. The above transactions, including notes receivable from participants, qualify as allowable party-in-interest transactions for which there are statutory exceptions.

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service on June 30, 2020, stating that the written form of the underlying pre-approved plan is qualified under section 401(a) of the IRC, and that any employer adopting this form of the plan will be considered to have a plan qualified under section 401(a) of the IRC. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan takes an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. SUBSEQUENT EVENTS

In preparing these financial statements, the Plan administrator has evaluated subsequent events and transactions for potential recognition or disclosure through August 29, 2025, the date the financial statements were available to be issued.
