Dudek Employee Health and Welfare Plan Notes to Financial Statements

Note 1 – The Plan and Its Significant Accounting Policies

General – The following description of Dudek Employee Health and Welfare Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan is a health and welfare plan adopted by Dudek (the Company), covering all eligible employees. Effective January 1, 2021, the Company established a Voluntary Employees' Beneficiary Association (the VEBA or Trust) to fund medical program benefits. Certain of the Company's other health and welfare benefits, including medical for Hawaii employees, vision, dental, short-term disability, long-term disability, accidental death and disability, critical illness, hospital indemnity, employee assistance, and life insurance benefits, are paid by the Plan outside of the Trust. The Plan is designed to comply and operate in accordance with the applicable requirements of the Internal Revenue Code (the Code) and the Employee Retirement Income Security Act of 1974 (ERISA).

Basis of accounting – The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America. Accordingly, contributions are recorded as earned. Claim payments are recorded when paid by the third-party claims processor. Claims payable and claims incurred but not reported are included in the statements of benefit obligations and net assets available for benefits.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, incurred but not reported claims payable, and claims incurred and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Plan administrative expenses – The Company manages the operation and administration of the Plan. The third-party administrator processes claims for the Plan. The plan document provides that either the Plan or the Company pays the Plan's administrative expenses, which consist of fees charged by the Plan's contract administrators, and the trustee of the Plan's assets, legal, accounting, and consulting fees. The Plan pays substantially all administrative expenses.

Insured benefits – The Plan offers Preferred Provider Organizations (PPOs) that participants can choose. The Plan fully insures medical benefits for Hawaii employees, vision, dental, short-term disability, long-term disability, accidental death and disability, critical illness, hospital indemnity, employee assistance, and life insurance benefits. The Company purchases annual insurance contracts for these insured benefits. Premiums for all insured benefits are paid by the Company.

Self-insured benefits – All medical Plan benefits, other than those offered to Hawaii employees through PPOs, are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processor under administrative services only (ASO) arrangements. The claims processor pays claims directly to or on behalf of participants and are then reimbursed by the Plan's trust. Despite the Plan's utilization of a third-party claim's processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

Dudek Employee Health and Welfare Plan Notes to Financial Statements

Stop-loss arrangements – The Company entered into a stop-loss arrangement with an insurance company. Premiums for stop-loss insurance are included in insurance premiums paid and stop-loss recoveries are netted against claims paid in the accompanying statements of changes in benefit obligations and net assets available for benefits. Stop-loss proceeds netted against claims for Plan year 2024 was approximately \$1,295,000.

Insurance premiums and administrative fee refunds receivable – Rebates and refunds contractually due from service providers are recorded as Plan assets when collection is probable, and the amount is estimable. These amounts are recorded as an offset to benefit payments, as applicable. Rebates netted against claims for Plan year 2024 was approximately \$208,000.

Health Reimbursement Account – The Plan has a health reimbursement arrangement (HRA) that is funded solely through Company contributions. The HRAs allows eligible participants to be reimbursed tax-free for qualified medical expenses subject to a specified ceiling. Amounts remaining at the end of the year can generally be carried over to the next year. The Company is not permitted to refund any part of the balance to the employee; the account cannot be used for anything other than reimbursements for qualified medical expenses; and the remaining amounts are not payable upon termination once the employee leaves the Company. HRA payments included in claims for Plan year 2024 was approximately \$154,600.

Flexible Spending Account (FSA) – The Plan has an FSA that is funded solely through employee contributions. The FSA allows eligible participants to be reimbursed tax free for qualified medical expenses subject to a specified ceiling. Amounts remaining at the end of the year or upon an employee's termination during the year are forfeited. The account cannot be used for anything other than reimbursements for qualified medical expenses. FSA payments included in claims for Plan year 2024 was approximately \$152,000.

Non-interest bearing Cash – The Plan considers all highly liquid investments with an original maturity from the date of purchase of three months or less to be cash equivalents. Cash and cash equivalents are deposited with a federally insured commercial bank in the United States and at times cash balances may be in excess of federal insurance limits.

Income taxes – The trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated May 22, 2023, with an effective date of exemption of January 1, 2021, stating that the trust is tax-exempt under Section 501(c)(9) of the Code as a Voluntary Employee Beneficiary Association (VEBA). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the Code to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the related trust is tax exempt.

The Internal Revenue Service has determined and informed the Company by a letter dated January 1, 2021, that the Plan, and the Trust established under the Plan, is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and ERISA as a VEBA. As a result of the Plan's funding policy, from time to time it may be subject to income taxes. No federal or California unrelated business income taxes were incurred for the years ended December 31, 2024 and 2023.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. No uncertain positions have been identified that would require recognition of a liability (or asset) or disclosure in the financial statements as of the years ended December 31, 2024 and 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS audits for any tax periods in progress.

Subsequent events – The Plan has evaluated subsequent events through August 26, 2025, which is the date the financial statements were available to be issued.

Note 2 – Contributions and Participation

The Plan generally covers regular employees who work at least 30 hours per week. Eligible dependents include spouses, domestic partners, and dependent children up to the age of 26. Participation in the Plan begins on the first day an employee becomes eligible and generally ends on the last day of the month that includes the last day of active employment. Employees who are terminated or become ineligible may elect continued coverage in compliance with the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA).

Premium amounts, deductible and co-payment amounts, maximum dollar coverage, and service coverage vary depending on the plan options chosen by the participants.

Participants contribute to the Plan in the form of monthly premiums based on their elected benefits. All other benefits not funded by participant contributions are funded by contributions from the Company. Participants contribute to the Plan by payroll deductions based on their elected benefits. Participants who have elected continued coverage under COBRA contribute to the Plan through direct remittances billed monthly based on their elected benefits. The Company contributes to the Trust the cash necessary to secure the benefits provided. Determination of the amount of the contributions is made on an annual basis, or more often if deemed appropriate, based upon experience relating to the average level of monthly benefit payments under the Plan.

Note 3 – Premiums Paid

Certain benefits under the Plan are covered by PPOs and stop-loss insurance as described in Note 1, in exchange for payment of insurance premiums. Such amounts are paid by either the Company or the VEBA trust and are recorded as premium payments in the accompanying statement of changes in benefit obligations and in net assets available for benefits. Total premiums paid for the year ended December 31, 2024, was approximately \$2,761,000.

Note 4 – Payment of Benefits and Administrative Expenses

Payment of benefits is based on predetermined amounts and percentages as specified in contracts with the service providers. Certain medical claims, administrative service fees, and certain stop-loss insurance premiums to service providers were paid from assets held in the VEBA. In addition, other insurance premiums were paid for by the Company and are recorded in these financial statements.

Note 5 – Benefit Obligations

Plan benefit obligations as of the years ended December 31, 2024 and 2023, for health claims incurred by active participants but not reported at that date are estimated by Hub International Insurance Services, Inc. (HUB), in accordance with accepted actuarial principles. The reserve estimates reflect the enrolled population as of December 31, 2024 and 2023, respectively. HUB did not assume any further increases or decreases in enrollment.

For the years ended December 31, 2024 and 2023, HUB used the completion factor method, which uses past payment lag patterns to estimate the incurred claim amount for each month. The load for margin and fluctuations was assumed at 10%. Excluded from this liability is a reserve for administrative expenses associated with paying the claims liability. In accordance with U.S. Department of Labor (DOL) guidelines, claims payable as well as claims and insurance premiums paid as shown on the Form 5500 include claims incurred but not reported. Claims incurred but not reported are reflected in the accompanying statements of benefit obligations and net assets available for benefits, and the statement of changes in benefit obligations and in net assets available for benefits.

As of the years ended December 31, 2024 and 2023, the Plan had a deficit of net assets available for benefits over benefit obligations of approximately \$132,000 and \$348,000, respectively. As provided for in the Plan document, the Company funds any deficit of net assets below benefit obligations from its general assets. Additionally, the continued inflow of contributions from Plan participants will fund any deficit.

Note 6 – Risks and Uncertainties

The Plan's benefit obligations are reported based on certain assumptions pertaining to historical trends and projections, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term could be material to the financial statements.

Note 7 – Plan Termination or Modification

The Company intends to continue the Plan indefinitely for the benefit of its employees; however, it reserves the right to terminate or modify the Plan at any time by resolution of its Company Board of Directors and subject to the provisions of ERISA. Any remaining undistributed funds are to be disposed of for the benefit of covered individuals. In the event that benefits due and payable exceed available funds, the Company will contribute to the Plan such amounts as may be necessary to ensure continuance of such benefit payments. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan's participants.
