Opinion

Note 1 - Description of Plan

The following brief description of Energy Laboratories Employee Stock Ownership Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

Energy Laboratories, Inc., a wholly-owned subsidiary of Environmental Services of Wyoming, Inc. (Company), established the Energy Laboratories Employee Stock Ownership Plan effective January 1, 2006. The Plan operates, in relevant part, as an employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (Code), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by Energy Laboratories, Inc. Energy Laboratories, Inc. appoints the Plan's Trustee.

Eligibility

Employees are eligible to participate in the Plan if they have completed one-year of service and are 21 years of age. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service. Employees are eligible to receive an allocation of Employer contributions only if they are employed on the last day of the Plan year and have at least 1,000 hours of service.

Entry Date

Employees may enter the Plan on the first day of January or July coinciding with or following the date they satisfy the Plan's eligibility requirements.

Contributions

Contributions to the Plan are made by the Company at the discretion of the Company. The contributions are allocated according to the pro rata share of each participant's compensation to total eligible compensation. Participants must have completed 1,000 hours of service and be actively employed at the end of the year, unless terminated due to retirement, death or disability, to receive an allocation of the contribution. In 2024 and 2023, the Company made a discretionary contribution of \$361,162 and \$370,434, respectively.

Voting Rights

Full and fractional shares of stock in the Plan shall be voted by the Trustee. The Trustee shall follow a participant's instructions for voting of full and fractional shares of stock allocated to the participant's account with respect to the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all assets of a trade, or business or such similar transaction as may be provided in regulations.

Notes to Financial Statements

The Trustee will vote shares of stock allocated to participant's accounts for which instructions are not received from the participants, and stock contributed to or acquired by the Plan that is not yet allocated, in a manner that, according to the Trustee's sole discretion, is in the best interests of the participants and that complies with the Code and ERISA.

Put Option

Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with a sum of cash or an allocation of shares of the Company's common stock released by the Trustee and forfeitures of terminated participants' non-vested accounts, in such an amount as determined at the sole discretion of the Company. Only those participants who are eligible employees of the Company will receive an allocation. Allocations are based on a participant's eligible compensation, relative to the total eligible compensation. Plan earnings and losses are allocated to each participant's account based on the ratio of the participant's account balance.

Vesting

Vesting is based on years of credited services as set forth in the following table:

<u>Participant's Years of Service</u>	<u>Vested Percentage</u>
Less than 2 years	0%
2 years and less than 3 years	20%
3 years and less than 4 years	40%
4 years and less than 5 years	60%
5 years and less than 6 years	80%
6 years or more	100%

Participants are 100% vested in their account balances upon retirement, death, or disability.

Forfeitures

At December 31, 2024 and 2023, there was no balance in the forfeited non-vested account as all forfeitures are used in the same year they are forfeited. Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. For the years ended December 31, 2024 and 2023, there was \$8,478 and \$5,887, respectively, in forfeitures of terminated non-vested account balances allocated to remaining participants.

Payment of Benefits

Upon death, disability, or retirement, a participant will receive a lump sum amount equal to the value of the participant's vested interest in his or her account as defined in the Plan document.

Distributions for other separations from service commence in the 5th Plan year following the separation from service and are made in five annual installments. The amount to be distributed is based upon the immediately preceding valuation date. Distributions are made in cash, or if a participant elects, in the form of Company common stock plus cash for any fractional share of common stock. As of December 31, 2024 and 2023, vested benefits for terminated participants totaled \$3,587,479 and \$2,793,743, respectively.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Each qualified participant (age 55 and 10 years of Plan participation) may elect within 90 days after the close of each Plan year during the Qualified Election Period to direct the Plan in writing as to the investment diversification of 25% of the total number of shares of stock acquired by or contributed to the Plan that have ever been allocated to such participant's account. If the participant elects to direct the Trustee as to the investment diversification of his or her account, such direction shall be effective no later than 180 days after the close of the Plan year. The Plan shall either: (1) distribute to the participant the portion of the participant's account covered by the election, or (2) offer the participant at least three investment options and invest the portion of the participant's account covered by the election in such investment options according to the participant's instructions.

Administration of Plan Assets

The Plan's assets, which currently consist of cash, receivables, and Environmental Services of Wyoming, Inc. common shares are held by the Trustee of the Plan.

Employer contributions are held and managed by the Trustee, which invests cash received, interest and dividend income and makes distributions to the participants.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their account. Upon termination of the Plan, the ESOP committee directs the Trustee to pay all liabilities and expenses of the ESOP. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

Note 2 - Significant Accounting Policies and Use of Estimates

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Released gains and losses from security transactions are reported on the average cost method. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year. The Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors/trustees. See Note 4 for discussion of fair value measurements.

The classification of investment earnings reported above and in the statements of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Payment of Benefits

Benefits payments to participants are recorded upon distribution.

Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net asset available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Subsequent Events

The Plan Sponsor has evaluated subsequent events through September 16, 2025, the date which the financial statements were available to be issued.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market deposit account: Valued at carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

Common stock: The fair value of the Company common stock held in the Plan is valued at estimated fair value based upon an independent appraisal. The appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, discount rates, return on assets, return on equity, market comparables and estimated fair value of Company assets and liabilities, including discounts for lack of control and lack of marketability.

Changes in Fair Value of Level 3 Assets

The Plan distributed 0 and 164.1658 shares valued at \$0 and \$90,265 of the Plan's Level 3 assets for the years ended December 31, 2024 and 2023, respectively, with no transfers in or out.

Note 5 - Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated November 1, 2017, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Subsequent to the issuance of the determination letter, the Plan was amended. However, the Company, Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and, therefore believe the Plan is qualified and the related trust continues to be tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6 - Related Party and Party-in-Interest Transactions

Certain Plan investments consist of cash and money market deposit funds managed by First Interstate Bank, the custodian as defined by the Plan. The Plan invests in Company common stock. In addition, the Plan received \$549,607 and \$187,817 in dividends from the Company for the years ended December 31, 2024 and 2023, respectively. As described in Note 2, these stock transactions are related-party and party-in-interest transactions. The Plan has a number of service providers. Such parties are parties-in-interest under ERISA.

As described in Note 2, the Plan paid certain administrative expenses related to Plan operations to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

Note 7 - Risks and Uncertainties

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Market risks include global events which could impact the value of investments, such as a pandemic or international conflict. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
