- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Genesee & Wyoming, Inc. 401(k) Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Genesee & Wyoming Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established as a participant-directed defined contribution plan for certain employees of Genesee & Wyoming Inc. (the Company and Employer), on January 1, 1994. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company sponsors the Plan, and the Benefit Committee administers the Plan. Fidelity Management Trust Company is the trustee of the Plan's assets and provides recordkeeping services.

Eligibility

Under the provisions of the Plan, all employees of the Company on November 1, 1993, except for those employed under collective bargaining agreements and resident of Puerto Rico, became Plan participants. All other employees, except for those employed under collective bargaining agreements that have not separately bargained to be allowed to participate, become eligible to participate in the Plan on the first day of the month following their date of hire. Employees become eligible to receive employer-matching contributions on the first day of the quarter following the completion of one year of service.

Contributions

The Plan allows for participant contributions up to 85% of their total compensation on both a pretax and post-tax (Roth) basis (Compensation Deferral), not to exceed the maximum contribution limit established by the Internal Revenue Code (IRC). Effective May 1, 2022, the Plan has included an automatic enrollment provision. Newly eligible employees who have not affirmatively opted out of enrollment in the Plan are automatically enrolled at a 4% elected pre-tax deferral. The Company contributes to the Plan for non-union employees an amount equal to 100% of the employee's Compensation Deferral, not to exceed 4% of the employee's pretax compensation. The Company contributes amounts to the Plan for collectively bargained employees in accordance with matching formulas specifically agreed to in those collective bargaining agreements.

The Company may contribute an additional amount to the Plan as determined by the Board of Directors, based on the earnings of the Company, although the Company has no obligation to do so. No discretionary contributions were made in 2024 or 2023.

The Plan allows participants who are projected to be age 50 or older by the end of the taxable year and who are making Compensation Deferrals to make a catch-up contribution of up to \$7,500 annually, which is in accordance with IRC limits.

1. DESCRIPTION OF PLAN (Continued)

Participant Accounts

Participants direct the investment of their contributions and the Employer's matching and discretionary contributions into various investment options offered by the Plan. Each participant's account is credited with the participant's contributions, the Company's matching contributions and allocations of (a) the Employer's discretionary contributions and (b) Plan earnings (losses). Allocations are based on participant earnings or account balances, as defined.

Vesting

Participants are immediately 100% vested in their contributions, employer matching contributions and actual earnings and losses thereon.

Benefits Paid to Participants

Upon retirement, death, disability or termination of service, a participant receives a lump-sum distribution equal to his or her vested account balance. In addition, hardship distributions are permitted if certain criteria are met.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years, or up to 10 years for the purchase of a principal residence. The loans are secured by the participant's account and bear interest at the prime rate plus 2% on the date the loan is issued from the Plan.

Administrative Expenses

Certain administrative expenses of the Plan are paid by a recordkeeping fee deducted from participant accounts. Distribution and loan fees are charged directly to the participants for the transactions and are paid out of the proceeds of the distribution or loan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is recorded on the accrual basis. The net appreciation (depreciation) in fair value of investments consists of both realized and unrealized gains or losses on the Plan's investments bought, sold, and held during the year.

Fair Value Measurements - Definition and Hierarchy

Generally accepted accounting principles defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurements - Definition and Hierarchy (Continued)

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

A description of where the Plan's investments fall within the hierarchy is provided in Note 4.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Benefit Payments

Benefit payments are recorded when paid.

Risks and Uncertainties

Investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with investment securities and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in values in the near term would materially affect participants' account balances and the amount reported in the accompanying financial statements.

Estimates

The preparation of financial statements in accordance with generally accepted accounting principles requires management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Reclassifications

Certain amounts in the prior year financial statements have been reclassified to conform to the current year presentation. These reclassifications had no effect on net assets available for benefits or changes in net assets available for benefits.

3. CERTIFIED INFORMATION

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

Following is a description of the valuation methodology used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: valued at fair value based on quoted market prices.

Money market funds: valued at fair value based on quoted market prices. The fund will invest at least 99.5% of its total assets in cash, U.S. government securities, and repurchase agreements that are collateralized fully. Fixed income securities, including short-term securities, are generally valued at evaluated prices obtained from third-party pricing, which approximates fair value.

Collective trust fund: valued at the NAV of units of the bank collective trusts. The NAV, as provided by the trustee of the funds, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the trustee of the funds reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner, which is not probable of occurring at December 31, 2024.

Investments Measured Using NAV per Share Practical Expedient

The following table summarizes investments for which fair value is measured using NAV per share practical expedient as of December 31, 2024 and 2023. Participants are prohibited from directing investments into a competing fund without first investing in a non-competing fund for at least ninety days.

5. TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving this determination letter. However, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

6. PLAN TERMINATION

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of such complete discontinuance of contributions or termination of the Plan, the value of the participants' accounts will be distributed to such participants or their beneficiaries from net assets available for benefits.

7. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments consist of units in investment funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company manages these investments and, therefore, these transactions qualify as party-in-interest as defined by ERISA. Additionally, certain plan assets consist of notes receivable from participants, which qualify as party-in-interest transactions.
