Opinion

We have audited the financial statements of ***Western Land Services, Inc. Employee Stock Ownership Plan*** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the "financial statements").

Notes to Financial Statements

1. DESCRIPTION OF THE PLAN

The following description of the *Western Land Services, Inc. Employee Stock Ownership Plan* (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Western Land Services, Inc. (the "Company") established the Plan effective January 1, 2017. The Plan operates as a leveraged employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended ("Code"). The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is administered by the Company. The trust department of an independent third-party brokerage company is the Plan's custodian.

During 2017, the Plan purchased 980 shares of Company common stock using the proceeds of a loan from the Company (see Notes 4 and 6) and holds the shares in a trust established under the Plan. The borrowing is expected to be repaid in annual installments through 2046 by cash contributions from the Company to the trust fund.

Borrowings are collateralized by unallocated shares held by the Plan. As the Plan makes each payment of principal, an appropriate percentage of shares are allocated to eligible employees' accounts in accordance with applicable regulations under the Code. The Company has no interest or rights in such shares once they are allocated to participants' accounts under the ESOP. Accordingly, the financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to:

- a) The accounts of employees with vested rights in allocated shares (allocated); and
- b) Shares not yet allocated to employees (unallocated).

Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Eligibility

The Plan is a defined contribution plan which covers all non-union employees of the Company who are age 18 or older, have been credited with 1,000 or more hours of employment, and have completed a year of employment, defined as a 12 consecutive month period beginning on employee's hire date. Participants who do not have at least 1,000 hours of service during such Plan year or are not employed on the last working day of the Plan year are generally not eligible for an allocation of the Company's stock for such year.

Notes to Financial Statements

Contributions

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on the term loan provided by the Company. Participants are not permitted to make contributions to the Plan.

Participant Accounts and Forfeitures

The Plan is a defined contribution plan under which a separate account is established for each participant. Each participant's account is credited with an allocation of (a) shares of the Company's common stock released by the Trustee from the unallocated account, (b) forfeitures of terminated participants' nonvested accounts, (c) distributions (when made), and (d) Plan earnings, and charged with an allocation of administrative expenses. Only those participants who are eligible employees of the Company as of the last day of the Plan year receive the allocation of stock and forfeitures and there were no forfeited non-vested accounts at December 31, 2024 or 2023. Employer stock and forfeitures are allocated in proportion to each participant's compensation compared with the total eligible compensation of all participants. There were no forfeited shares of terminated participants' nonvested accounts allocated to remaining participants in 2024. Plan investment income is distributed as of the last day of each Plan year and is allocated based on the ratio of each participant's account balance to total participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Vesting in the Company contributions is based on years of continuous service. A participant is 100% vested after three years of credited service, with no vesting in prior years.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant receives the value of the participant's vested interest in his or her account, in five payments, beginning in the year after termination of service. A participant who has a termination of service for any other reason will begin receiving payment of benefits starting in the fourth Plan year beginning after the year in which service was terminated; payments are made in five payments. The amount to be distributed is based upon the immediately preceding valuation date. Distributions are made in cash.

Voting Rights

Each participant is entitled to direct the Trustee to exercise voting rights attributable to the shares of the stock allocated to his or her account on issues involving mergers or consolidations, recapitalization, reclassification, liquidation, dissolution or sale of substantially all assets of the Company, or any other similar transaction that may be specified in regulations. If the participant fails to direct the Trustee on any issue, the shares will be voted by the Trustee. The Trustee is required, however, to vote any unallocated shares on the behalf of the collective best interest of Plan participants and beneficiaries.

Put Option

Under federal income tax regulations, Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash for the value of their shares.

Diversification

Diversification is offered to participants who attained the age of 55 and have completed at least 10 years of participation in the Plan so that they may have the opportunity to move part of the value of their investment in the Company's stock into investments which are more diversified. In each of the first five years, a participant may diversify up to 25% of the number shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution.

Administration of Plan Assets

The Plan's assets, which consist principally of the Company's common stock, certificates of deposit and a money market fund, are held by the Trustee of the Plan.

Company contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants. The Trustee also administers the payment of interest and principal on the loan, which are reimbursed to the Trustee through contributions as determined by the Company.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses including Trustee fees are paid directly by the Company.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. The fair value of Western Land Services, Inc. common stock is one such significant estimate. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest is recorded on the date received. The net change in fair value of investments includes the Plan's aggregate gains and losses on investments bought and sold as well as held during the year.

Benefits Paid to Participants

Benefit payments to participants are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by the Company, as provided by the Plan document. Certain administrative expenses, including an allocation of salaries related to Plan administration, and audit and legal costs, are paid by the Company and qualify as party-in-interest transactions which are exempt from prohibited transaction rules. Expenses that are paid directly by the Company are excluded from these financial statements. Fees for trustee, custodial, and record keeping services are also paid by the Company. Interest expense is paid by the Plan. Participants are charged directly for certain distribution types.

Subsequent Events

In preparing these financial statements, Plan management has evaluated, for potential recognition or disclosure, significant events or transactions that occurred during the period subsequent to the most recent statement of net assets available for benefits presented herein, through the date these financial statements were available to be issued.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of fair value hierarchy under Accounting Standards Codification 820 are described as follows:

Level 1: Input to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Company common stock: The fair value of the Company's common stock held by the Plan is valued at estimated fair value based upon an independent appraisal. This appraisal is based upon a combination of several different approaches for valuation of the common stock, specifically, income based and market based approaches. The appraiser considered historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities.

The valuation process involves Plan management's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the reviewed financial statements of the Company. The appraiser prepares a preliminary report which Plan management reviews in detail, discusses and approves. The estimated fair value of common stock of the Company as of December 31, 2024 and 2023 was \$14,840 and \$18,722 per share, respectively.

Certificates of deposit: Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer (Note 5).

Money market fund: Shares held in a money market fund are comprised of debt securities with individual maturities of 12 months or less and an average maturity of 33 days or less. The composition of securities is structured to maintain a value of \$1 per share.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of investments could result in a different fair value measurement at the reporting date.

In estimating fair value of the investment in Level 3, Plan management utilizes third-party pricing sources. In substantiating the reasonableness of the pricing date by third-parties, Plan management evaluates a variety of factors including review of methods and assumptions used by external sources, recently executed transactions, existing contracts, economic conditions, industry and market developments, and overall credit ratings.

5. CERTIFICATES OF DEPOSIT

Certificates of deposit at December 31, 2024 consists of amounts on deposit at banks or savings associations, with interest rates ranging from 4.25-5.10%, and a maturity of fourteen months or less. These deposits aggregate \$3,773,331, of which a portion is in excess of federally insured limits at December 31, 2024. Management does not believe the Plan is exposed to any significant interest rate or other financial risk as a result of these deposits.

6. LOANS PAYABLE

During 2017, the Plan entered into a \$4,750,000 loan agreement with the Company. The proceeds of the loan were used to purchase 980 shares of the Company's common stock. Unallocated shares serve as collateral for repayment of the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current years payments divided by the total of this years payments, plus all future years' principal and interest payments. This resulted in 33.23 shares being released and allocated in 2024. The agreement provides for the loan to be repaid in annual installments of \$234,266 through 2046, including interest charged at 2.75%. During 2018, the Company made an additional advanced loan payment in the amount of \$100,000. No such additional payment was made in 2024.

7. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in Company common stock, receives distributions from the Company, has indebtedness with the Company and pays interest expense to the Company. As described in Note 2, the Company pays substantially all Plan expenses. The Plan has a number of service providers. Such providers are parties in interest under ERISA. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

8. TAX STATUS

The Plan and related trust obtained its determination letter on March 12, 2018, in which the Internal Revenue Service stated that the Plan and trust, as designed, were in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan Administrator and the Plan's legal counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. While the Plan may be subject to routine audits by taxing jurisdictions, there are currently no audits for any tax periods in progress.

9. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan agreement and the IRC. Upon termination of the Plan, the Plan's Administrative Committee shall direct the Trustees to pay all liabilities and expenses of the trust fund.

10. RISKS AND ECONOMIC UNCERTAINTIES

The Plan invests in the Company's common stock, certificates of deposit and a money market fund, which are exposed to various risks, such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with certain investment securities, including heightened market risk associated with the investment in common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes in net assets available for benefits.
