We have performed audits of the accompanying financial statements of Mariani Packing Company, Inc. Profit Sharing 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). **NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Mariani Packing Company, Inc. Profit Sharing 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**A. General**

The Plan is a defined contribution plan established May 1, 1988 by Mariani Packing Company, Inc. (the "Company"), to provide benefits to eligible employees. The plan administrator believes the Plan is designed and operated in compliance with applicable requirements of the Internal Revenue Code (the "Code") and provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

**B. Administration and Expenses**

Principal Trust Company ("Principal") serves as trustee and Principal Financial Group provides record keeping and administrative services. Certain investment related expenses are charged directly by the funds and are thereby factored into each fund as a reduction of investment return. Certain investment management and participant elective transaction fees are charged directly to participant accounts. Other costs of administering the Plan may be paid from the Plan or by the Company at the discretion of the Company.

**C. Eligibility**

All regular employees of the Company who are age 20½ or older are eligible to participate in the Plan on completion of one month of service. Employees may enter the Plan on the first day of any month after becoming eligible. Participants may begin salary deferrals on Plan entry and are eligible to receive Company matching contributions upon completion of six months of service.

**D. Contributions**

Participants may elect to have the Company contribute their eligible pre-tax compensation to the Plan up to the amount allowable under Code regulations. Participants who elect to have the Company contribute a portion of their compensation to the Plan agree to accept an equivalent reduction in taxable compensation. Newly eligible employees who do not make an affirmative election to defer compensation to the Plan, including an election not to defer, are auto-enrolled at a pre-tax contribution rate of 5% of eligible compensation.

Participants age 50 or older may elect to make additional catch-up contributions as allowed under Code regulations. Participants are also allowed to make rollover contributions of amounts received from other tax-qualified retirement plans. Such contributions are deposited in the appropriate investment funds in accordance with participant investment directions and the Plan's provisions.

The Company matches 25% of the first 5% of eligible compensation deferred by participants.

**NOTE 1 - DESCRIPTION OF THE PLAN (Continued)**

**E. Participant Accounts**

Plan investments consist of a menu of mutual funds, pooled separate accounts, common/collective trusts and an insurance company general account investment. Participants direct the investment of their accounts. Each participant's account is credited with the participant's contributions, rollovers, employer matching contributions and an allocation of Plan earnings or losses and administrative expenses. The contributions of participants who decline to make an investment election are invested in the Principal LifeTime Fund appropriate for the individual's age and projected date of retirement.

**F. Vesting and Forfeitures**

Participants are immediately 100% vested in their entire account balance. As a result, no forfeitures arise under the Plan.

**G. Payment of Benefits**

Normal retirement age under the Plan is age 65. Upon termination of service, death, disability, retirement or attainment of age 59½, a participant or beneficiary may maintain his or her account in the Plan or choose to receive benefits in a lump sum or installments. Hardship withdrawals are permitted under limited circumstances, as defined in the Plan and approved by the plan administrator. Benefits are recorded when paid.

**H. Notes Receivable from Participants**

The Plan allows participants to borrow not less than \$1,000 up to the lesser of \$50,000 or 50% of their account balance. A loan is secured by the participant's account balance, bears a fixed rate of interest commensurate with interest rates charged by lending institutions, and must be repaid to the Plan within a five-year period, unless the loan is used for the purchase of a principal residence, in which case the loan term may be extended. Principal and interest are paid ratably through payroll deductions. The plan administrator approves the specific terms and conditions of each loan. Notes receivable from participants at December 31, 2024 carry interest rates ranging from 4.25% to 9.50% with various maturities through October 2034. Notes receivable are measured at their unpaid principal balance plus accrued interest. Delinquent notes are recorded as a distribution based on the terms of the Plan document.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**A. Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**B. Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect reported amounts and disclosures. Actual results may differ from those estimates.

**C. Investment Valuation and Income Recognition**

Investments are stated at fair value, except for the fully benefit responsive investment contract which is valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals. Purchases and sales of investments are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Mutual fund capital gain distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

**D. Risks and Uncertainties**

Plan investments are exposed to various investment risks such as interest rate, market and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in value of investments will occur in the near term and such changes could materially affect participant accounts and amounts reported in the financial statements.

**NOTE 3 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. The accounts of the participants affected by a partial or complete termination of the Plan are nonforfeitable and will be determined as of the termination date.

**NOTE 4 - PARTY-IN-INTEREST TRANSACTIONS**

Certain investments offered under the Plan are issued or managed by affiliates of the trustee. Purchases and sales of these investments and payment of expenses to Plan service providers from Plan assets are considered party-in-interest transactions under ERISA. Such transactions are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

**NOTE 5 - INCOME TAX STATUS**

The Company adopted a prototype plan that has received a favorable opinion letter from the Internal Revenue Service. The plan administrator believes the Plan is operated in accordance with and qualifies under applicable requirements of the Code and related state statutes and the trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken a tax position that more likely than not would not be sustained upon examination by a tax authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule including investments held at December 31, 2024 and 2023, and net appreciation, interest and dividends for the year ended December 31, 2024 was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Principal Trust Company, the trustee.

**NOTE 7 - FAIR VALUE MEASUREMENTS**

Accounting guidance establishes a hierarchy that prioritizes valuation inputs into three levels based on the extent to which inputs used in measuring fair value are observable in the market. Under the fair value hierarchy Level 1 inputs are quoted prices for identical securities in an active market. Level 2 inputs are quoted prices for similar instruments and model-based valuation techniques for which all significant assumptions are observable in the market or can be corroborated by observable market data. Level 3 inputs are generally unobservable and typically reflect management’s estimates of assumptions that market participants would use in pricing the asset or liability.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. Although the plan administrator believes this valuation method is appropriate and consistent with other market participants, the use of a different methodology or assumption to determine fair value could result in a different fair value measurement at the reporting date. The following tables summarize Plan investments at December 31 based on the inputs used to value them:

**NOTE 9 - INVESTMENT CONTRACT**

The Plan maintains a fully benefit responsive group annuity contract with Principal through the Fixed Income Guaranteed Option (“Guaranteed Interest Account”). Contributions to the Guaranteed Interest Account are maintained in a Principal general account and credited for interest and charged for participant withdrawals and administrative expenses. Principal is contractually obligated to repay principal and a specified rate of interest that is guaranteed to the Plan. The Guaranteed Interest Account meets fully benefit-responsive investment contract criteria and is reported at contract value. Contract value is deemed to be fair value of the account under current accounting guidance because this is the amount received by participants when they initiate permitted transactions under the terms of the Plan.

The Plan’s ability to receive amounts due is dependent on Principal’s ability to meet its financial obligations. There are no reserves against contract value for credit loss. Certain events might limit the ability of the Plan to transact at contract value including premature termination of Plan investments in the Guaranteed Interest Account. The plan administrator does not believe that any events limiting the Plan’s ability to transact at contract value are probable of occurring.

**NOTE 10 - SUBSEQUENT EVENTS**

Management has evaluated subsequent events through September 17, 2025, the date on which the financial statements were available to be issued. There are no subsequent events that require recognition or additional disclosure in the Plan’s financial statements.
