Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Golden Arches Safe Harbor 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section that:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal controls relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Golden Arches Safe Harbor 401(k) Plan’s ability to continue as a going concern for one year after the date of the financial statements are available to be issued.

1. DESCRIPTION OF PLAN

The following description of the Golden Arches Safe Harbor 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is commonly called a 401(k) plan. The Plan is a defined contribution plan established January 1, 2018, by T & K LLC (the "Company"). The Plan is a multiemployer qualified plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The participating employers are Donjo, LLC, T&K, LLC, NextGen, 4u4, and IMMER.

Eligibility

The Plan covers all non-union employees of the Company who have completed one (1) year of service, have worked 1,000 hours, and are age twenty-one (21) or older.

Contributions

Employees are permitted to make salary deferral contributions to the Plan under a 401(k) arrangement. The Plan provides for employer safe harbor matching contributions equal to 100% of deferrals that do not exceed the 3% of eligible compensation plus 50% of the amount of the participants elective deferrals that exceed 3%, but do not exceed 5% of the participant's eligible compensation. Participants are immediately vested in employer contributions designated as safe harbor matching contributions.

After an employee completes the eligibility requirement, they are entitled to receive an allocation of the employer safe harbor matching contribution. The Plan does not impose an hour service requirement and employees are not required to be employed on the last day of the Plan year to receive an allocation of the employer safe harbor matching contribution. The Plan includes a profit-sharing discretionary contribution based on business units or location.

The Plan permits participant non-deductible, Roth contributions. The Plan also accepts qualified rollover contributions.

Participant Accounts

The participant's accounts are set up in self-directed, individual accounts administered by American Funds. Participant's individual accounts are valued on a daily basis. Contributions and Plan earnings or losses are credited (charged) to the participants as soon as the amounts are received by the investment funds.

The benefit to which a participant is entitled is limited to the vested amount in the participant's account.

Vesting

Participants are immediately vested in their contributions and employer safe-harbor matching contributions, plus actual earnings. Employer profit-sharing contributions vest according to the following schedule:

Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination, a participant may elect to receive a lump-sum amount equal to the value of his or her vested benefit. The Plan does not allow for hardship distributions to participants. Payment of benefits is recorded when paid.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Forfeited Accounts

On December 31, 2024 and 2023, there were no forfeitures related to non-vested accounts. Forfeited accounts will be used to pay Plan expenses, or they will be used to reduce future employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's policy is to have its financial statements prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial Statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

As of the date of this report, subsequent to the plan year-end of December 31, 2024, two operating entities formerly owned by the Plan Sponsor were transferred to a related party. In connection with this transfer, a formal plan amendment was executed to reflect that the new entities continue as covered under the Plan's existing participating employer structure. These changes had no effect on the Plan's structure or financial condition as of year-end.

Additionally, management identified that employee deferral and employer matching contributions totaling \$54,000 were made during the 2024 plan year on behalf of a participant who did not have eligible compensation as defined by the Plan document. In accordance with IRS and Department of Labor correction procedures, these ineligible contributions, along with attributable earnings, were distributed from the Plan to the affected participant in 2025. The corrective distributions will be reflected in the Plan's 2025 financial statements and Form 5500. Management has evaluated the impact of this matter and has implemented additional controls to prevent similar errors in the future.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">• quoted prices for similar assets or liabilities in active markets,• quoted prices for identical or similar assets or liabilities in active markets,• inputs other than quoted prices that are observable for the asset or liability;• inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. TAX STATUS

The IRS has determined and informed the Company by letter that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax Counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related Trust is tax-exempt.

GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes that it is no longer subject to income tax examinations prior to December 31, 2021.

The Plan remitted a participant's contribution late and a loss of earnings was using the Department of Labor's Voluntary Fiduciary Correction Program. The Plan Sponsor intends to take any necessary actions to bring the plan back into compliance with applicable tax codes.

5. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan utilizes a third-party administrator. Advising, recordkeeping and broker fees were paid by the Plan in accordance with the Plan document. Capital Bank and Trust Company is the parent company of American Funds. The Plan's investments were held by Capital Bank and Trust Company, which was the Custodian as defined by the Plan; therefore, these transactions, as well as forfeiture balances, qualify as exempt party-in-interest transactions.

Certain Plan investments are managed by American Funds. American Funds is the Trustee and record-keeper for the Plan and, therefore, these are transactions that qualify as party-in-interest transactions.

7. CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024, and net appreciation in fair value of investments for the year then ended, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Capital Bank & Trust Company, for the year ended December 31, 2024.

8. RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H OF FORM 5500
