Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Fire Sprinkler Systems, Inc. (the Company) 401(k) Profit Sharing Plan and Trust, (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Notes to Financial Statements

1. General Description of the Plan

The following description of Fire Sprinkler Systems, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Fire Sprinkler Systems, Inc. (the Company) established the Plan effective January 1, 2019, and permitted the commencement of elective deferrals on September 3, 2019. On May 20, 2022, the Plan was amended to add FSS Alarms, Inc. as a participating employer.

The Plan was a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act ("ERISA") of 1974, as amended. The Plan is a special type of retirement plan commonly referred to as a 401(k) plan which refers to the specific section of the Internal Revenue Code that allows employees to make pre-tax contributions to a retirement plan. Under the Plan, participants may choose to have a specific percentage or dollar amount withheld from the participant's salary and have such amount deposited directly into a 401(k) account on their behalf. This pre-tax contribution is referred to as "Salary Deferral". The Plan covers all employees of the employer who have obtained 1,000 hours of service, have one year of eligibility service and are age twenty-one or older. The entry date is immediate after meeting eligibility. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees.

Contributions

The Plan has a 92% of compensation elective deferral limitation. Each year, eligible participants may contribute an amount they elect as pretax annual compensation. The participant may increase or decrease on a prospective basis, his/her salary reduction agreement percent as of each entry date. Participants may also rollover eligible amounts from other qualified plans to the plan except for rollovers of designated Roth contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate at 3% of eligible compensation, increase 1% each year up to 10%. Contributions are automatically invested in a designated balanced fund until changed by the participant. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a money market fund. The Plan Sponsor/Company, Fire Sprinkler Systems Inc. may make non-elective employer contributions using a discretionary formula each plan year on behalf of "eligible" participant. The non-integrated allocation formula is the ratio that each "eligible" participant's compensation bears to the total compensation paid to all "eligible" participants for the Plan year. Total contributions are also subject to certain IRS imposed limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, (b) Plan earnings, and (c) charged with an allocation of administrative expenses (if not paid by Plan or by the Plan Sponsor) or investment-related fees incurred as a result of participants investment decisions.

Participant Accounts (Continued)

Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferrals plus actual earnings thereon. Vesting in the Company's contribution portion plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 or up to a maximum, equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates, which are commensurate with local prevailing rates at a commercial U.S. bank and are determined at the time the loan is made, currently at 4.50%. Loan transactions are treated as a transfer to (from) the investment funds from (to) a participant's loan receivable. Loan terms cannot exceed 5 years, unless the loan qualifies as a residential mortgage, in which case a loan term may qualify for a period of up to 20 years. Principal and interest payments are made through payroll deductions, not less than quarterly. Loans that are considered uncollectible are treated as deemed distributions and therefore there would be no allowance for uncollectible loans.

Payments of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum amount, or in annual installments over a period elected by the participant. Normal retirement age was 59.5 and all participant accounts are available for in-service distributions upon attainment of such age. A participant who becomes disabled and satisfies the requirements for Social Security disability benefits was eligible for accelerated distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution or in installments.

Forfeited Accounts

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. These forfeited amounts are used to reduce the Company's discretionary profit-sharing contributions. The Plan had \$1,198 and \$210 of forfeited balances available for use for 2024 and 2023, respectively. Forfeiture used in 2024 to offset fees \$210.

Hardship Withdrawals

The Plan allows for hardship distributions in accordance with IRS regulations. A participant may withdraw any part of their vested account in the event of undue financial hardship.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested.

2. Summary of Significant Accounting Policies

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of net assets, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. The significant accounting policies of the Plan are as follows:

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are evaluated on a recurring basis and reported at fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sale of securities are recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance would be reduced, and a benefit payment would be recorded. At December 31, 2024 and 2023 the outstanding notes receivable from participants was \$129,986 and \$28,693, respectively.

Payment of Benefits

Benefits were recorded when paid.

Administration Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

3. Tax Status

The prototype Plan obtained a determination letter on April 10, 2014, in which the Internal Revenue Service stated that the prototype Plan was qualified under section 401(a) of the Internal Revenue code (the Code). Subsequent to the issuance of the determination letter, the Plan was amended. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The Plan administrator believes that the Plan was designed and was currently being operated in compliance with the applicable requirements of the Code, and therefore believes that the Plan was qualified, and the related trust was tax exempt.

4. Information Certified by Trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information supplied to the Plan Administrator and certified as complete and accurate by Mid Atlantic Trust Company (the Trustee of the Plan).

5. Fair Value Measurements

Fair value measurements provide a framework for measuring fair value under generally accepted accounting principles (GAAP), which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 – measurements) and the lowest priority to unobservable inputs (Level 3 – measurements). The three levels of the fair value hierarchy are as follows: Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Funds

Money Market Funds are financial instruments that invest in stable short-term securities (such as Treasury bills, bank CDs, commercial paper, repurchase agreements, or variable rate demand notes). Money Market Funds keep their net asset value (NAV) constant at \$1.00 per share for fair market value. Their yields change based on the earnings they derive from investments.

Brokerage Accounts/Mutual Funds

Brokerage accounts consist of mutual funds and are valued at the daily closing price as reported by the fund. Mutual Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission.

These funds are required to publish their daily net asset value (NAV) and to transact at that price. The Mutual Funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

6. Related Party Transactions

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. The Company transacts with Paychex, Inc. for its payroll services, including automatic withdrawal of funds from the Company's bank account for employee contributions for deposit to the Plan's trust account. Paychex Retirement Services, a related company to Paychex, Inc. performs the recordkeeping function for the Plan. The Plan issues notes to participants which are secured by the balances in participants' accounts. These transactions qualify as a party-in-interest transactions for which a statutory exception exemption exists. Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments because they are paid through revenue sharing rather than direct payments. Administrative fees charged by Paychex Retirement Services and Mid Atlantic Trust Company for the year ended December 31, 2024 were \$22,785.

7. Risks and Uncertainties

Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of uncertainty related to changes in the value of investment securities, it was at least reasonably possible that changes in the various risk factors, in the near term could materially affect investment balances and the amounts reported in the financial statements. Additionally, many Mutual Funds invest in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than similar types of securities of comparable U.S. companies.
